**Preliminary Objections**

- 1- The appellant has no locus standi /no cause of actions to file the instant appeal against the respondents.
- 2- The present appeal is liable to be dismissed for non joineder/miss joineder of necessary parties.
- 3- The instant appeal is against the prevailing law, rules, and policies.
- 4- The instant appeal is not maintainable in the present form.
- 5- That the instant appeal is time-barred.

➤ **FACTUAL OBJETIONS**

- 1- That Para No 1 pertains to the service record of the appellant hence needs no comments.
- 2- That Para No 2 is related to the present posting of the appellant hence needs no comments.
- 3- That Para No 3 is correct to the extent of untrained appointment as DM & Training of DM.
- 4- That respondent No 4 prepared a seniority list of the DM cadre of Distt; SWAT on basis of Date of training (DM) instead of Dated of 1<sup>st</sup> Appointment. Copy of seniority list attached as Annexure A.
- 5- That the names of the appellants are included in the seniority list & working papers. Seniority list is attached as Annexure A.
- 6- That the appellant preferred department appeal on 20-01-2013. It was not responded because it was contradictory to the policy of Govt of Khyber Pakhtunkhwa Dated 31-08-2012.

According to the Para No 1 & 3 of Policy/Notifications Dated 31-08-2012 and 21/1/2013 the seniority cannot be considered from the Date of 1<sup>st</sup> appointment in case of untrained teachers. The seniority is considered from the Date of passing of prescribed Qualification in case of Untrained Appointments. Copy of policy/Notification is attached as Annexure B.


- 7- That the Notification Dated 30-03-2009 is related to the Annual Increments to the Untrained Teachers for the Untrained Period. There is no direction about the seniority for Untrained Period in the said Notification. Copy of Notification is attached as Annexure C.
- 8- That Para No 8 has already been clarified in Para No 7 Of the factual Objections.
- 9- That according to Para No 7 of the Notification Dated 13-11-2012 the prescribed qualification for DM is Bachelor Degree from a recognized University with one year Drawing Master (DM) course certificate. It implies that one year training is must for (DM) Post. Therefore the seniority cannot be counted from the untrained appointment as already clarified in the para No 6 of the factual objection. copy of Notification is attached as Annexure D.
- 10- According to para No 1 & 3 of the Notifications Dated 31-08-2012 and 21/1/2013 Seniority is counted after passing the prescribed professional qualification relevant to the post. copy of Notification is attached as Annexure B.
- 11- That the appellant is not aggrieved from the seniority list based on date of training as already clarified in the factual objections.


➤ **Grounds**


- A- That the seniority list is legal & based on the policy.
- B- That the seniority of the appellant cannot counted from the Date of Untrained Appointment as clarified in the Factual Objections.
- C- That Para No C is related to the duty & service of the appellant hence needs no comments.
- D- That the seniority list is legal & based on rules/policy. It is not favorable to some teachers. It is not Politically Motivated.

That some other grounds may also be argued with the Prior Permission of this Honorable Tribunal. That the respondents also seek permission to raise additional grounds and proofs at the time of arguments before the honorable service tribunal.

In view of the above facts and circumstances, this Honorable Tribunal may very graciously be pleased to dismiss the present appeal with cost in favor of Respondents.

I am directed to refer to your letter No. 11005 dated 23-8-2012 on the subject mentioned above and to inform you as under:-


1. The seniority cannot be considered from the date of appointment as untrained teacher. The seniority is considered from the date of regular appointment post or from the date of passing the prescribed professional qualification in case of untrained appointment (copy of the Rules attached).
2. The name of the teacher transferred from one district cadre post to other Distt: cadre post on his own request will be placed at the bottom of the seniority list i.e according to the date of taking over charge after the date of issue of his inter Distt: transfer order.
3. The name of the untrained teacher cannot be enlisted in the seniority list unless he passes the prescribed professional qualification.
4. The seniority of the teacher who was transferred to his own District due to devolution of Divisional Directorate will not be disturbed.
5. The new upgraded posts i.e BPS-14, BPS-15 & BPS-16 will be filled by promotion etc as & when the new Service Rules are notified by the Govt: of Khyber Pakhtunkhwa. The notification for constitution of DPC will be issued soon after the new Service Rules.
6. The ACRs/PERs are not required in fixation of pay due to upgradation of scales of PST/Qari teachers (M&F) in BPS 12 as well as upgradation of scale of CT/DM/PET/AT/TA teachers (M & F) in BPS-15. The ACRs will be required for their promotion in next scale against the newly upgraded posts in BPS-14, BPS-15 & BPS-16.
7. The new service rules/ amendment are under process.
8. Before the Service Recruitment Rules 2011, the teachers having FA & F.Sc (in 3<sup>rd</sup> division) already appointed according to the prescribed rules at that time, will be considered for seniority, but their promotion against the newly upgraded posts will be considered if allow the new Service Recruitment Rules which is under process.

"Seniority"

1. For proper administration of a service, cadre or [post], the appointing authority shall cause a seniority list of the members for the time being of such service, cadre or [post] to be prepared, but nothing herein contained shall be construed to confer any vested right to a particular seniority in such service, cadre or [post] as the case may be.
2. Subject to the provisions of sub-section (1), the seniority of a civil servant shall be reckoned in relation to other civil servants belonging to the same service or [cadre] whether serving the same department or office or not, as may be prescribed.
3. Seniority on initial appointment to a service, [cadre] or post shall be determined as may be prescribed.
4. Seniority in a post, service or cadre to which a civil servant is promoted shall take effect from the date of regular appointment to that post; Provided that civil servants who are selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter-se seniority as in the lower post.
5. The seniority lists prepared under sub-section (1), shall be revised and notified in the official Gazette at least once in a calendar year, preferably in the month of January.

I am further directed to further clarify that:

1. The seniority cannot be considered from the date of appointment as untrained. The seniority will be from the date of regular appointment to a post or from the date of passing the prescribed Professional qualifications in case of untrained appointment to a post under the provision of Section 8(4), Chapter-II of THE NWFP (NOW KHYBER PAKHTUNKHWA) CIVIL SERVANTS ACT, 1973 (N.W.F.P. Act No. XVIII of 1973)
2. The Seniority of the teacher who was appointed before the abolishment of Divisional Directorates and transferred to his own domicile after abolishment of Divisional Directorates, will not be disturbed and he may be placed with his counterparts on his due place in the Seniority list.
3. Similarly the Seniority of the teacher, who was appointed before the bifurcation of a district and transferred to his own domicile district after bifurcation, will not be



**Respectfully Sheweth:**

*Brief facts of the case given rise for filing the instant service appeal are as  
under.*

*That the appellant was appointed as drawing master on 05/12/1989 and  
since then the appellant is performing his duties as D.M till now. (Copy  
of the appointment order is attached as annexure A).*

2. *That the appellant is presently serving as drawing master in Govt.  
Middle School ~~Kokarai~~ Sangota*

10/6/13

3. That the appellant was initially appointed as untrained drawing master and then the appellant completed his training on 09/01/1995.
4. That a seniority list of drawing master (male) District Swat was issued from the office of the respondent, in which seniority of the drawing masters is counted from the date of appointment, was prepared by the respondent, but the same was totally ignored and attested copies of the same was not given to the appellant, respondent may also be directed to give attested photocopy of the same to the appellant, in which name of the appellant is present at serial No. // 0. (Copy of seniority list is attached as annexure B).
5. That strangely second seniority list was issued from the office of the respondent, in which name of the appellant is vanished, which is unlawful. The second seniority list is a working paper for developmental committees from the promotion of D.Ms (male) BPS-15 to senior D.Ms BPS-16. (Copy of the second seniority list is attached as annexure C).
6. That feeling aggrieved from the said order, the appellant preferred a departmental appeal to respondent No. 4 for considering the appellant for the promotion and seniority should be counted from date of appointment instead of date of completion of training. (Copy of departmental appeal is attached as annexure D).
7. That the Govt. of Khyber Pakhtunkhwa Elementary and Secondary Education Officer issued a notification No. SO(B&A)/1-18/E&SE/2008 for the grant of incentive of higher pay scale / grade, on the basis of time scale to the different cadres of teachers in elementary and secondary education department Khyber Pakhtunkhwa, in which all the existing posts of D.Ms have been upgraded to BPS-15 for the present incumbents to the post as well as future appointees. Meaning thereby that all the DMs have got equal status privilege through this upgradation order, which is a real theme of justice. (Copy of notification is attached as annexure E).
8. That the Govt. of K.P.K finance Department (Regulation wing) through notification SOFD (PRC) 05/03/2002 Peshawar dated 30/03/2009 directed the Secretary Govt. of K.P.K elementary and secondary



education department for the "Grant of annual increments / running pay to untrained teachers in the light of Supreme Court judgment". And further it is directed to allow the benefit of annual increments to the untrained teachers from the date of regular appointment. Hence the seniority should necessarily be counted from the date of appointment. (Copy is attached as annexure F).


9. That the Govt. of K.P.K. elementary and secondary education department, Peshawar dated the November 13, 2012, issued a notification No. SO(PFH-5)SSRC/Meeting 2012. The Rules are crystal clear in serial No. 7, senior drawing master BPS-16. In which there is no rule regarding the base for seniority. There is also no rule that date of training should be given preference over the date of appointment. (Copy is attached as annexure G).
10. That in the appointment order, there is no para regarding the rule of seniority, which is to be counted for the date of completing training instead of date of appointment.
11. That being aggrieved from the seniority list based on date of training, the appellant filed the instant appeal on the following grounds inter alia.


**GROUND:-**

- a. That the impugned seniority list based on date of training is illegal, against the law and void ab-initio.
- b. That seniority of the appellant should be counted from the date of regular appointment, because the law, rules and regulations are crystal clear regarding this.
- c. That the appellant is continuously performing his duties from the date of his appointment till now.
- d. That the impugned seniority list is illegal, favourable to some teachers, based on political influence.
- e. That some other grounds may also be argued with the prior permission of this Hon'ble Court.

It is, therefore, humbly prayed that on acceptance of this service appeal, the impugned order attested on 22/01/2013 passed by the respondent No. 4 may kindly be set aside and the respondent may be directed to work upon the seniority of the appellants from the date of their appointment, issued by the District Education Officer male Swat at Gul Kada, comprising 205 DMs, instead of counted from date of training.

of their appointment, issued by the District Education  
Officer male Swat at Gul Kada, comprising 192 DMs,  
instead of seniority list counted from date of training.

Respectfully Sheweth:

1. That the appellant was appointed as drawing master on 05/12/1989 and since then the appellant is performing his duties as D.M till now. (Copy of the appointment order is attached).
2. That the appellant is presently serving as drawing master in Govt. Middle School Sangota.
3. That the appellant was initially appointed as untrained drawing master and then the appellant completed his training on 09/01/1995.
4. That a seniority list of drawing master (male) District Swat was issued from the office of the respondent, in which seniority of the drawing masters is counted from the date of appointment, was prepared by the respondent, but the same was totally ignored and attested copies of the same was not given to the appellant, respondent may also be directed to give attested photocopy of the same to the appellant, in which name of the appellant is present at serial No. . (Copy of seniority list is attached).

5. That strangely second seniority list was issued from the office of the respondent, in which name of the appellant is vanished, which is unlawful. The second seniority list is a working paper for developmental committees from the promotion of D.Ms (male) BPS-15 to senior D.Ms BPS-16. (Copy of the second seniority list is attached).
6. That the Govt. of Khyber Pakhtunkhwa Elementary and Secondary Education Officer issued a notification No. SO(B&A)/1-18/E&SE/2008 for the grant of incentive of higher pay scale / grade, on the basis of time scale to the different cadres of teachers in elementary and secondary education department Khyber Pakhtunkhwa, in which all the existing posts of D.Ms have been upgraded to BPS-15 for the present incumbents to the post as well as future appointees. Meaning thereby that all the DMs have got equal status privilege through this upgradation order, which is a real theme of justice. (Copy of order is attached).
7. That the Govt. of K.P.K finance Department (Regulation wing) through notification SOFD (PRC) 05/03/2002 Peshawar dated 30/03/2009 directed the Secretary Govt. of K.P.K elementary and secondary education department for the "Grant of annual increments / running pay to untrained teachers in the light of Supreme Court judgment". And further it is directed to allow the benefit of annual increments to the untrained teachers from the date of regular appointment. Hence the seniority should necessarily be counted from the date of appointment. (Copy is attached).
8. That the Govt. of K.P.K. elementary and secondary education department, Peshawar dated the November 13, 2012, issued a notification No. SO(PFH-5)SSRC <sup>meeting 2012 Teacher</sup>. The Rules are crystal clear in serial No. 7, senior drawing master BPS-16. In which there is no rule regarding the base for seniority. There is also no rule that date of training should be given preference over the date of appointment. (Copy is attached).
9. That in the appointment order, there is no para regarding the rule of seniority, which is to be counted for the date of completing training instead of date of appointment.
10. That being aggrieved from the seniority list based on date of training, the appellant approaches your honour on the following grounds inter alia.

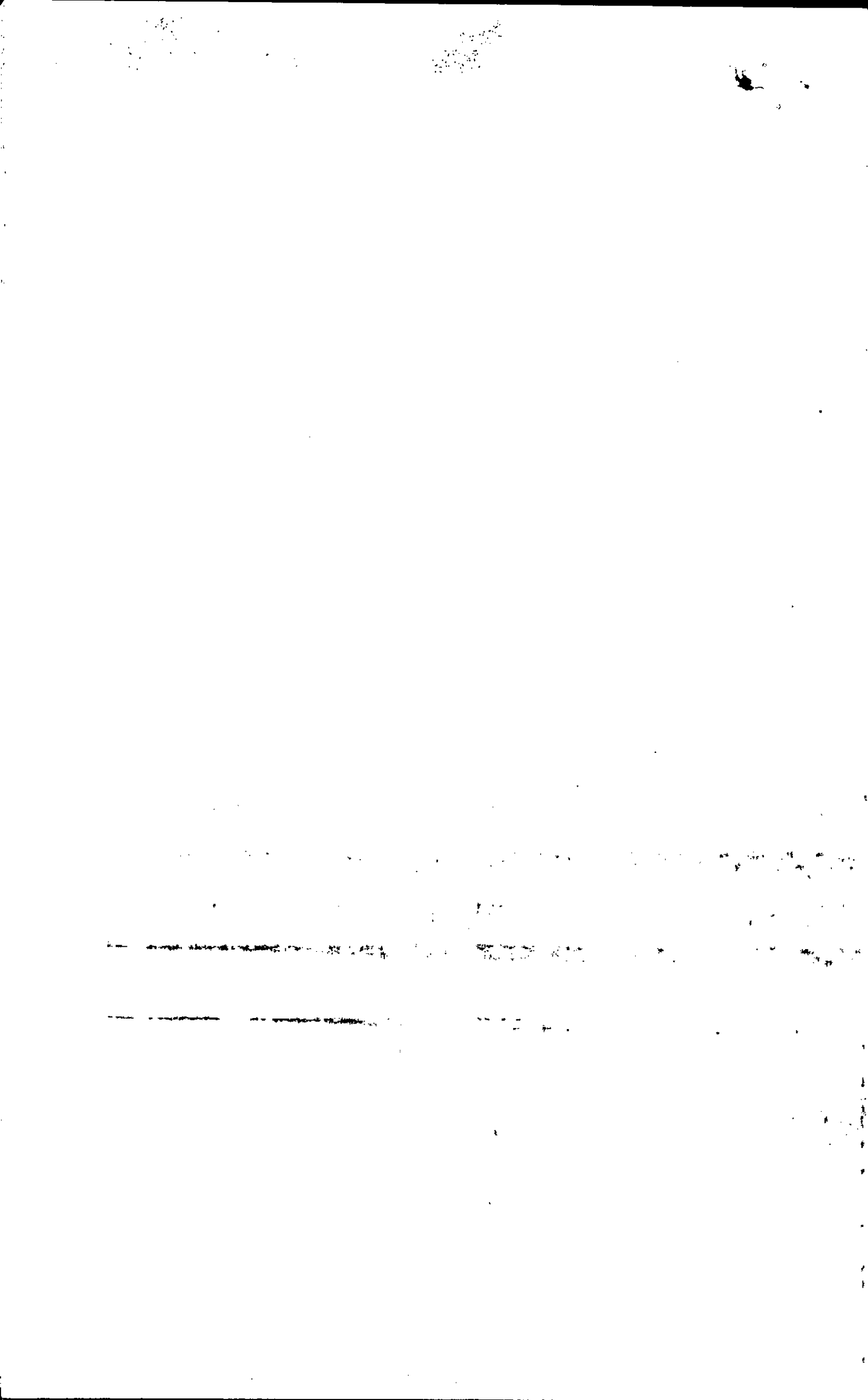

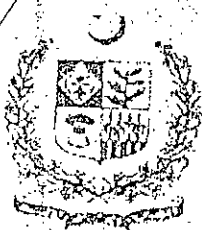


3. That the above mentioned correction / amendment will not change nature of the service appeal of the appellant.
