That the applicant's Execution Petition No: 44/2012 has been pending before the Honourable Tribunal since 2012. As the administrative Member of the Tribunal Mr Sultan Mehmood has been issuing notices to the Respondents, therefore, they are reluctant to implement the orders of the Tribunal. The Respondent instead of complying the orders, have been bringing again and again the same reply to delay the implementation.

That on 10.11.2011 the Apex court dismissed as withdrawn the CPLA of the Govt. of Khyber Pakhtoonkhawa against the orders of this Honourable Tribunal in case of applicant.(annx-A)

One Liaqat Ali Tahir, Superintendent, was made a cat's paw of the Respondents to file a petition before the Supreme Court of Pakistan to create hurdles in the promotion of the applicant to B.17 But the Honourable Apex Court dismissed the said application of Liaqat Ali Tahir on 31-12-2012 (copy annexed as B).

That on 24.04.2013 the Honourable Tribunal had warned the Respondents that in case of their failure in the implementation of the orders, their salaries would be attached (copy annexed as C).

That on 02.05.2013, the Additional Secretary Industries- II, moved a Note to the Secretary Industries KPK, wherein the actual position regarding anti dation of promotion of the applicant had been highlighted and request had been made for antedating of promotion w.e.f 01.07.1996. A draft for corrigendum was also annexed with the said Note. (annexed as D).

Sorry to say that the target date given by the Tribunal has already elapsed but the Respondents are not ready to implement the orders of the Tribunal in letters and spirit.

It is humbly prayed that the case of the applicant may kindly be heard by your Honour and the Honourable Judicial Member of the Tribunal so that the orders could be implemented in letters and spirit and the Respondents may also be punished for violating the orders of the Honourable Tribunal.

N.B: The next date of hearing is fixed as 24.03.2014.

KHLJI ARIF HUSSAIN, J.— The petitioners impugn the judgment dated 25.04.2011 passed by Khyber Pakhtunkhwa Service Tribunal, Peshawar by filing the listed petition under Article 212(3) of the Constitution of the Islamic Republic of Pakistan, 1973. 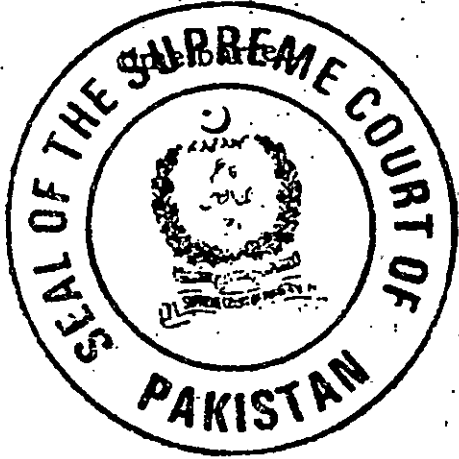
4. It appears that earlier the petitioners filed petition before Branch Registry of this Court at Peshawar on 06.09.2011 which was

The petitioners instead of removing the office objections in time filed the listed petition at Principal seat of this Court, ^{on 12/12/2012} without disclosing this fact.

5. The petition, as per office note, is barred by 171 days. No valid reason has been given in the application for condonation of delay to justify such condonation. The application is, therefore, dismissed and consequently the petition is also dismissed being
