1. This appeal is fixed for office objection as appellant has not attested the annexure, appeal had not properly marked with annexure marks and contact number and email address of the counsel was not mentioned. Counsel has mentioned his contact number and email address on appeal and also properly marked annexure, therefore, office is removed.

2. Learned counsel for the appellant was appointed as PST on contract basis vide order dated 24.05.2004. Later on service of the appellant was regularized on the basis of notification dated 13.07.2020. He further argued that since 2004 appellant regularly performing his duties without any brake till now and she is entitled for counting her contractual service period for the purpose of pay and pensionary benefits under Rule 2.3. Appellant filed departmental appeal on 28.09.2022 which was not responded within statutory period of ninety days. Instant service was filed on 31.01.2023 under Section 4 of Khyber Pakhtunkhwa Service Tribunal Act, 1974. Points raised need consideration, therefore, appeal is admitted for regular hearing subject to all legal objections. Appellant is directed to deposit security fee within 10 days. Thereafter, notices be issued to respondents for submission of written reply/comments. Respondents be summoned through TCS the expenses of which be deposited by the appellant within 3 days. Adjourned. To come up for written reply/comments on 22.11.2023 before S.B at Camp Court, D.I.Khan. P.P given to the appellant.
