"You have disrespected not only a female student namely Misbah Syed student of Ist year MBBS but also resorted to physical assault on the basis of wearing Hijab and also used words against Prophet (P.B.U.H).

After enquiry appellant was found guilty and vide orders dated 23.07.2014 penalty in the shape of compulsory retirement from service was imposed against the appellant with immediate effect.

4. Learned counsel for the appellant argued that no opportunity to cross examine the witnesses during enquiry was extended to the appellant. He further argued that despite lapses in enquiry the appellant would not contest the appeal if stigma attributed to the appellant through impugned order is done away with. He also referred to the affidavit submitted by the appellant sworn by him in the following words:-

APPEAL UNDER SECTION 4 OF THE KPK SERVICE TRIBUNAL ACT 1974 READ WITH RULE 19 OF THE E&D RULES 2011 AGAINST THE ORDER DATED. 23.07.2014 RECEIVED BY APPELLANT ON 5.08.2014 WHEREBY THE APPELLANT HAS BEEN COMPULSORY RETIRED FROM SERVICE AND AGAINST NOT TAKING ACTION ON THE REVIEW PETITION WITHIN STATUTORY PERIOD FIXED BY LAW.

PRAYER:

That on acceptance of this appeal the impugned order may be set-aside and the appellant may be re-instated with all back and consequential benefits. OR the compulsory retirement may be converted into a simple retirement without any stigma. Any other remedy which this august Tribunal deems fit that may also be awarded in favour of appellant.

R.SHEWETH.

- 1- That the petitioner is a true Muslim and believes in the God Almighty and his last Prophet Muhammad (PBUH). The appellant has more than 29 years service at his credit with good record through out of his career. Copy of fitwa is attached as Annexure A
 - 2- That a clash was taken between the students of the KMC and the appellant and that was raised by the students to the peak. Therefore a fact finding inquiry was conducted in the which the blames leveled against the



appellant were declared baseless and wrong. Copy of the report is attached as Annexure – B.

- 3- That despite that the appellant was charge sheeted for allegation mentioned in the charge sheet. How ever the appellant filed reply to the charge sheet and denied all the allegations categorically with proofs. Copy of the charge sheet and reply are attached as Annexure C & D.
- 4- That then an inquiry was conducted at the back of appellant and the inquiry committee recorded the selected statements of few students out of 240 witnesses and that too in absence of appellant which is the violation of true justice. However, on the basis of inquiry report, the appellant was served with the show cause notice which was also replied by the appellant in time and again rebutted all the allegations with proofs and objections on the inquiry committee's findings. Copy of show cause notice and reply are attached as Annexure E & F.
- 5- That on 23.7.2014 the penalty of compulsory retirement was imposed on appellant. The appellant received that order on 5.8.2014. The appellant filed appeal/review petition on 7.8.2014 which was forwarded to the concerned quarter on 22.08.2014. The appellant waited for the statutory period but the appeal of the appellant has not been responded till the expiry of statutory period fixed by law. Copy of the order and appeal are attached as Annexure G & H.
- 6- That now the appellant comes to this august Tribunal on the following grounds amongst the others.

GROUNDS:

- A- That the impugned order is against the law, facts, material on record and norms of justice, therefore not tenable and liable to be set-aside.
- B- That the appellant has not been dealt I accordance with the law and norms of justice and condemned unheard and undefended.
- C- That the inquiry committee has not recorded the stamen of all students who were present at the time of incidence and recorded the statements of those picked students only who were the associate of disobedient girl student and even that too in absence of appellant and the appellant was not allowed to cross examine them. Thus the very essence of the rules are violated.
- D- That some political students wanted to cash the occasion and they succeeded, otherwise it was declared in the fact finding inquiry that the



students gave statements in exaggerations. All that proves that the appellant has not been dealt fairly.

- E- That even the inquiry committee cross the limits of their powers by recommending a penalty which legally, under the law an inquiry committee cannot recommend punishments.
- F- That the impugned penalty order will affect the appellant in sense of endangering his life, kids and whole family and the penalty will stigmatize the appellant for no fault o his part and will degrade the appellant and his family in the society.
- G- That the appellant has been penalized for the act which not done by appellant and the inquiry committee too ignored the language, attitude and behavior of the girl student who did all in the class room in presence of 240 students.
- H- That the appellant has not been treated fairly, according to the settle norms of justice.
- I- That the inquiry committee has not proved the appellant guilty of any misconduct and the appellant has been penalized for no fault on his part.
- J- That the appellant was not provided with the full inquiry report to make him enable to defend himself in the reply to show cause notice.
- K- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.



ENQUIRY REPORT

Dear Sir,

An enquiry committee constituted to look into the incident that took place in 1st Year MBBS class in Khyber Medical College Peshawar held its meeting on 14th December, 2013. The committee listened to 1st Year MBBS student Ms. Misbah Syed Canadian-Pak national and recorded her statement. The committee also recorded statement of Ms. Khushbah, 1st Year MBBS and class representative of 1st Year MBBS Mr. Asad Ullah. The committee also recorded the statement of Prof. Dr. Rahim Bangash and cross questioned him (copy of the statement is attached).

Prof. Dr. Rahim Bangash also recorded his statement tendering an apology if he has hurt the sentiments of anyone. He further said that as Muslim he believes in the Khatm-e-Nabowat and honour of the prophet (P.B.U.H) (copy of the statement is attached) and consider those liable forcapital punishment who would commit Touheen-e-Rasalat.

The committee is of the opinion that the views expressed by the professor in the class room were mere a slip of tongue unintentional, unintended. He therefore has not committed any blasphemy in the honour of the Prophet (P.B.U.H).

However, the situation in the classroom was mishandled. The professor was not supposed to express opinion regarding religion in a professional class. The professor expressed that he was extremely sorry and said that he would not repeat this act in future.

According to the professor which he explained in front of the committee that he is not against hijab in general however his personal opinion differs. On the other hand, the female students concern presented the situation with some exaggeration which was then misused by some elements.

Being a civil servant, his case is forwarded and recommended to the Health Department Khyber

Pakhtunkhwa for further necessary action.

Reply to the charge sheet and statement of allegation

Reference allegations mentioned in the charge sheet, following are submitted:-

The allegation that I have disrespected a female student and resorted to physical assault on the basis of wearing Hijab is not true.

The second allegation that I used word against (Allah forbid) Prophet (P.B.U.H) is not only untrue but also very painful.

To further explain my position I have to give few details of the incident:-

- (a) I am teaching at Khyber Medical College, the subject of Anatomy for the last 28 years. During this long period of time hundreds of girls students wearing Hijab remained my students and to none of them I said a single word about their Hijab. I considered it their personal matter of faith and I never commented on their attire.
- On the day of incident I was taking an introductory lecture of Neuro Anatomy on the topic of "Receptors of Nervous System in Human Body". It was a long topic and took about two hours to complete. Towards the end of the lecture I asked the class that who would be the new class representatives (CRs). I asked this question for the reason that faculty have to frequently interact with the CRs. A boy declared himself as unopposed male CR, while on the female side Miss Misbah Syed declared herself as a female CR but another girl also stood up to be a CR candidate. I asked for voting by show of hands and Miss Misbah Syed was elected as CR by obtaining majority votes. I continued the discussion on receptors of nervous system in human body and expressed my opinion that. in medical profession, all doctors including lady doctors have to examine male and female patients which could involve detail body examination. The demand of the profession is to know the identity of the doctor during examination. Further, feeling the pulse and palpation of the whole body from hair to genital tract could only be performed with bare hands without gloves. Miss Misbah Syed at this point said that she was following the dress cod of Umahat-ul-Momeneen (RAT Anham) and was observing full Pardah as they used to observe. I commented that no one can compare himself / herself

with Sahabah and Umahat-ul-Momeneen as they were very sacred people. Morcover, Umahat-ul-Momeneen were the sacred house wives of Prophet (P.B.U.H) and would stay all the time in their homes. While the profession of a lady doctor demands her presence in the hospital and interactions with both male and female patients and colleagues. I also presented comparison of various facilities available to mankind now a days which were not available at the time of Prophet (P.B.U.H). In fact, I was talking on the medical ethics related to my topic of lecture i.e. Receptors of Nervous System in Human Body but unfortunately Miss Misbah Syed who was wearing gloves, veil and Abaya took it personally due to the fact that she was attending first class of her medical career and was probably not used to such type of academic discussion. Afterward I again explained to the class what I meant by my comments regarding veil and the medical profession and also that I had nothing against one's personal believe and attire.

- (c) Instead of further arguing the case in the light of medical ethics, Miss Misbah Syed rushed to the Dais and tried to snatch the microphone attached to my blazer / collar. I voluntarily handed it over to her. Afterward, she started provoking speech for which she was not allowed and it comes under the breach of code of conduct for the students. I tried to stop her but she did not. At this point I turned her out of the class because no student, could be allowed to deliver a provoking speech and I was duty bound to stop her.
- Although inquiry committee was constituted within two hours of the incident but Misse Misbah Syed, instead of following the due course of rules and discipline, opted to take the issue to the streets and media and fully played into the hands of political maña causing disrepute to the college and medical community.
- (e) The committee comprising of senior professors as well as senior religious scholars thoroughly probed the matter and held detailed proceedings. List of the committee members is attached as Anex 'A'. Report of the committee has already been submitted.

Based on the facts explained above, it is humbly submitted that:-

(a) Miss Misbah Syed was not disrespected and not subjected to physical assault on the basis of wearing Hijab, as alleged, rather she resorted to misbehave during course of academic discussion related to the topic of the day, by coming to dais, trying to snatch microphone and delivering a provoking speech. By the events which followed it became evident that the issue was blown up by the political mafia present within the student community, only and only for their political motives. Resultantly, I faced agony; it caused disrepute to the institution and doctor community. It also created embarrassment for Miss Misbah Syed who unknowingly

played into the hands of union mafia. The fact has been admitted by her parents in a statement Annex 'B' which states, Quote "We do not have any personal grudges against each other about the incident which was developed due to misunderstanding between Professor Dr. Muhammad Rahim Bangash and newly admitted medical student Miss Misbah Syed on the issue of Hijab, occurred at the end of the lecture dated 12th December 2013. The two parties agreed in the best interest of public / institution and the general law and order situation prevailing in the province / country now a days, and not to further aggravate the put the life and property of public danger", Dear sir, the statement is sufficient to prove me not guilty of the charges and it also indicate that me and my family suffered a lot due to the incident for no fault of mine. We were threatened and terrified by the miscreants taking advantage of the volatile situation. Lives of me and my family are still at danger. Further, the complainant party itself is asking for amicable settlement, therefore, prolongation of the issue would not be judicious.

Regarding allegations of using words against the Prophet (P.B.U.H) I only wish to state that being a Muslim I can never think of using such words. My statement in this regard was referred to Musti who has given a written Fatwa in this regard (Anex 'C').

Last but not the least, it needs to be highlighted that Academic discussion in Colleges, Universities and Professional Institutions, throughout the world, is treated as privileged discourse and cannot be made the basis of any legal action. Similarly, unless misconduct is proved, E&D rules also would not envisage disciplinary action on the basis of academic discussion especially in the class of professional college.

It is, therefore, most humbly prayed that the charges leveled against me may be dropped being baseless, untrue and in contravention to the privilege discourse safeguarded from the legal action.

I also wish to be heard in person to further clarify my position.

The committee in their own wisdom ignored many principles of conduct of inquiry much less the inalienable right of my presence during any evidence recorded against me. As regard the unfortunate event itself, it is admitted that at that particular moment I was delivering a lecturer occupying my lawful place called the stage from where ordinarily the lecture is to be delivered. It is admitted that the student namely Misbahd Syed tried to come on to the stage and she did. The framers of the charge ignored the fact that she was the person who started the event by trying to go to a space not meant for she wanted to use the speaker and the rostrum to further her agenda. Nobody felt





Respected Sir,

I am in receipt of Notification No. SOH-I/1-321/2013 dated 23rd July 2014, received on 5th August 2014, whereby major penalty of compulsory retirement from service have been imposed on me.

The following few submissions are respectfully made for kind consideration.

The proposed punishment is the result of the following original charge:-

"You have disrespected not only a female student namely Misbah Syed student of 1st year MBBS but also resorted to physical assault on the basis of wearing Hijab and also used words against Prophet (P B U H)".

An inquiry committee consisting of Mr. Muhammad Humayun Khan Secretary Transport and Pro: Dr. Zafar Iqbal was constituted. The committee visited the Class Room on 21st January, 2014 and obtained written statements of eight witnesses out of two hundred and fourty students who were the witnesses. Even three of those eight selected witnesses negate the allegation leveled against me and still the inquiry committee concluded that I am guilty and recommended the above punishment to the Authority.

Sir,

I am astonished to note with respect that either the so called committee members had never conducted inquiry in their illustrious carriers or they deliberately turned a blind eye to the rules governing their action.

In reply to show cause notice, I requested your good-self for personal hearing. The opportunity for personal hearing was not provided rather, after a long wait; Chief Secretary KP was nominated for personal hearing. Although, so called personal hearing with Chief Secretary, KP was conducted but that was only a formality and without even listening to my view point decision / rejection was made. The competent authority is expected to take all the necessary precautions before deciding to end my 29 years long service and put myself and my family in danger.

In the light of the above it can be safely concluded that the above inquiry is a nullity of law and has been arbitrarily conducted with a preplanned agenda and does not meet the minimum requirement of legal norms. Further, a proceeding after show cause notice has been conducted only as formality with prejudice mind.

Further, major penalty of compulsory retirement is not commensurate with the allegations which do not correspond to the fraud or financial mismanagement. Additionally, an academic discussion was blown-up by the media and interest groups of faculty and students, which not only harmed the prestigious institution but also <u>put the lives of me and my family in severe danger</u>. It is important to note that the <u>matter arising from in-class argument was reconciled</u> with the female student concerned (Annexure- A) but the enquiry committee ignored that.

On the question of committing blasphemy, I was cleared by eminent religious scholars (Annexure -B).

IT IS REPEATEDLY SAID AND PROJECTED IN THE PRINT MEDIA THAT MY CUMPOLSARY RETIREMENT IS IN MY INTEREST AND TO SAVE MY LIFE. Contrary to what is projected, in this pretext, my compulsory retirement will be taken as a proof for the sin that I did not commit and will endanger myself and my family lives.

The notion that my compulsory retirement would be in my interest and in the interest of the institution is totally wrong. My compulsory retirement would not only be a miscarriage of justice but would provide ample reason to the extreme element of the society to endanger my life and the lives of my family. It will become a stigma for me and my children. Further, it will bring bad name to Khyber Medical College



across the world. This might adversely affect training/jobs of tens and thousands of our graduates worldwide.

<u>Lastly</u>, <u>Prophet Mohammad</u> (<u>BPUH</u>) once said that nature of any act is determined by the intention with which it is executed. It was never my intention to insult the female students concerned and can never think of committing blasphemy.

At least my service record spanning over 29 long years together with my reputation, as a committed teacher should have been taken into account while imposing this harsh penalty, as no one in his right mind would put his career at stake and reputation for a pity dispute, provoked rather unveiled for an unnecessary discussion by a fresh first year student unaware of the culture for mutual respect between teacher and student in our society. A trivial matter was blown out of proportion by certain elements entertaining professional jealousy who otherwise could not match professional standing of the petitioner, therefore cashed on the event to fulfill their sinister desire. The fact that students of first year asking for special lectures by a professor, teaching senior students of 2nd year will bear testimony to the professional excellence of the petitioner on one hand, and reveal the real desire of those interested in character assassination and tormenting image of the petitioner on the other hand.

- Sir, as chief executive of the province I expect you to give due consideration to the following.
- 1.My 29 years long service as a teacher to the students of Khyber medical college and the society.
- 2. Adverse decision against me would put myself and the life of my family in danger for the sin I did not commit.
- 3. Adverse decision against me would be a stigma for me and my family and will make our living difficult in the current circumstances, again for the sin I did not commit.


It is, therefore, humbly prayed that notification regarding compulsory retirement may be withdrawn and I may be reinstated on service.

Letter in question was received on 08-01-2014. Dr. Muhammad Rahim Bangash, Professor of Anatomy Khyber Medical College, Peshawar was asked vide letter dated 09-01-2014 for submission of written reply within seven days failing which it shall be presumed that he had no defense to put in & in that case ex-parte decision shall be taken (Annexure-B). The Health Department nominated Dr. Muhammad Zahid, Assistant Professor, Department of Anatomy, Khyber Medical College Peshawar as departmental representative to assist the committee and provide relevant record (Annexure-C). Dr. Muhammad Rahim Bangash, Professor of Anatomy Khyber Medical College, Peshawar has been charged as under:-

"He has disrespected not only a female student namely Misbah Syed student of 1st year MBBS but also resorted to physical assault on the basis of wearing Hijab and also used words against Prophet (PBUH)."

Dr. Muhammad Rähim Bangash joined Health Department as Medical Officer (BPS-17) Khyber Teaching Hospital Peshawar on 01-10-1985. He was promoted as Senior Medical Officer (BPS- 18) and also served as Senior Registrar (Surgical) in the same hospital. During June, 1996 he was appointed as Assistant Professor (Anatomy),

Khyber Medical College Peshawar. Subsequently he was promoted to the post Associate Professor in 2010 and as Professor on regular basis in October, 2013. He is on probation for a period of one year, extendable for further one year. He is MBBS & FCPS (Surgery). According to date of birth of Dr. Muhammad Rahim Bangash he will attain the age of Superannuation on 14-08-2017.

Dr. Muhammad Rahim Bangash, Professor of Anatomy Khyber Medical College, Peshawar submitted his written reply on 16-01-2014 which at Annexure "D". He stated that he is teaching the subject of Anatomy at KMC for the last twenty eight (28) years during this period hundreds of girls students wearing Hijab remained his students. None of them raised any question. He always considers it their personal faith. On the day of incident he was taking an introductory lecture of Neuro Anatomy on the topic of "Receptors of Nervous System in Human Body". Lecture took about two hours to complete. At the end new class representatives were chosen. A boy declared himself as unopposed Male Class Representatives while Miss Misbah Syed and another female were candidates for female GR. Miss Misbah Syed was elected as GR by show of hand. Discussion on receptors of Nervous System continued and he expressed his opinion that in medical profession, all doctors including Lady Doctors have to examine male and female patients which involves detailed body examination.

The demand of the profession is to know the identity of the doctor during examination. Further, feeling the pulse and palpitation of whole body from hair to genital track could only be performed with bare hand without gloves. Miss Misbah Syed at this point said that she was following the dress code of Ummahatul Momineen and was observing full Prada as used to observe by wives of Prophet. He commented that no one can compare himself/herself with Sahaba and Umahatul Momineen as they were very sacred people. Moreover Umahatul Momineen were sacred house wives of Holy Prophet and would stay all the time in their homes. The profession of a lady doctor demands her presence in the hospital and interaction with male and female patients and doctors. He also presented comparison of various facilities available to mankind now-adays which were not available at the time of Holy Prophet. He was talking on the medical ethics related to his lecture. Unfortunately Miss Misbah Syed who was wearing gloves, veil and abaya took it personally due to the fact that she was attending first class of her medical career and probably not used to such type of academic discussion. He again explained to the class that his comments regarding veil and medical profession and he had nothing against one personal believe. Instead of further arguing the case in the light of medical ethics Miss Misbah Syed rushed to dice and tried to snatch the microphone attached to his collar. He voluntarily handed over to her. She started provoking speech for which she was not allowed as it comes under the breach

Miss Misbah Syed in her statement admitted that not have any personal grudges against each other about the incident which developed due to misunderstanding between Professor Dr. Muhammad Rahim Bangash and newly admitted medical student Miss Misbah on 12-12-2013. Both the parties agreed not to further aggravate the issue. Dr. Bangash added that being muslin he can never think of using the words against the Holly Prophet. He requested that academic discussions in colleges and universities throughout the world is treated as privilege and cannot be made the basis for any legal action. He requested that charges leveled against him are baseless, untrue and in contravention to the privilege. He requested that may be exonerated.

One page report of the Committee constituted by the Principal, Khyber Medical College is at Annexure-P. The Committee was of the opinion that views expressed by the Dr. Bangash hurt the sentiments of students. Situation in the class was mishandled. He was not supposed to express opinion regarding religion in the professional class. Dr. Bangash expressed that he was extremely sorry and would not repeat in future. He added that he is not against Hijab but his personal views are different. Preliminary report of the Committee is without specific recommendations therefore they may be conveyed displeasure.

COVERAGE OF INCIDENT

Matter was immediately reported to the news channels. Representatives of various TV channels tried to contact the Principal for obtaining his views. He avoided to respond. Incident was highlighted in the Daily Aaj Peshawar, Daily Mashriq Peshawar, and The News Islamabad with headlines (Annexure-Q).

After few days Miss Misbah Syed addressed a press conference at Press Club Peshawar. The matter was again highlighted in various news papers (Annexure-R). She demanded constitution of an impartial commission for investigating the case. She also demanded that strict action may be taken against Dr. Muhammad Rahim Bangash. Matter was also agitated during Jumma Sermons.

The issue was also debated in the Provincial Assembly on 08-01-2014. A number of MPAs took part in the discussion. Minister for Health informed the Provincial Assembly that Dr. Muhammad Rahim Bangash has been suspended. A two member enquiry committee has been constituted. Recommendations of the committee will be honoured by the Government. His entry in the college has been banned (Annexure-S).

Audio and video recording was collected from the Principal, Khyber Medical College Peshawar. A copy of the audio recording is attached. Comparison of written statement and audio recording shows that both have similar text.

Minister for Health informed the Provincial Assembly that Dr. Muhammad Rahim Bangash has been suspended. A two member enquiry committee has been constituted. Recommendations of the committee will be honoured by the Government. His entry in the college has been banned (Annexure-S).

Audio and video recording was collected from the Principal, Khyber Medical College Peshawar. A copy of the audio recording is attached. Comparison of written statement and audio recording shows that both have similar text.

Observations:

Miss Misbah Syed is a Canadian national but she observes pardah. She was wearing hijab, abaya and gloves. She wanted to become Girls Representative. She was elected by the girls students by show of hands. Dr. Muhammad Rahim Bangash after her election advised her to change her

She argued that she follows Ummahat ul Momineen. Dr. Bangash started debate that no one can feompare himself/herself with Sahaba and Ummahat ul Momineen. The discussion took sudden turn. Dr. Bangash stated that there are a number of things which we are being done now but were not available at the time of Prophet. He particularly referred to the Toilet and Flush and stated that he is using the same and the Prophet had not. He also mentioned that Holy Prophet had thirteen wives but he cannot have thirteen wives. Words used by the Dr. Bangash were not only resisted by Miss Misbah Syed but were also objected by other students as well. Dr. Bangash tried to stop her from delivering provoking speech. She took one round and was not returning mike. Dr. Bangash became furious and took the mike by force. In the presence of the students he suddenly slammed her with his fist on face, pushed her towards the class door and kicked out of the class. He was constantly saying "get lost". Matter was reported to the Principal, Khyber Medical College Peshawar. Students of the college came out of their class rooms. It was expected that there might be strong reaction from the students. Entry of Dr. Muhammad Rahim Bangash in the college has been banned.

RECOMMENDATIONS

a) Under circumstances explained above retention of Prof. Dr. Rahim Bangash in the service is neither in his own interest nor in the interest of Khyber Medical College. It is therefore recommended that major penalty of compulsory retirement from service may be imposed upon him.

INCIDENCE ON 12TH DECEMBER. 2013 IN CLASS OF PROF. DR. RAHIM BANGASH

On the day of incidence, I was sitting in P.A office of the Principal KMC when Dr. Shamim from the Department of Physiology came running to the Principal Office. She told me that Dr. Rahim Bangash has thrashed a 1st Year MBBS girl student and that the girl is not well and is lying in the office of Dr. Anjum Humayun. I rushed to the office of Dr. Anjum Humayun and found that the girl was very upset and crying bitterly. I tried to console her and got her to the Principal office KMC. While she was narrating the incident, the Principal KMC was informed that the students have boycotted the classes and are agitating and are trying to go out of the college towards the main Jamrud road. I alongwith other faculty members accompanied with the Principal KMC. We convinced the students to come to the Anatomy Dissection Hall KMC and listen to the Principal. The Principal addressed the students who were demanding immediate dismissal of the professor concerned and lodging an FIR under the blasphemy act.

The Principal KMC assured the students that they should calm down and the college administration will take appropriate action as per rules. After this assurance, the students dispersed. I along-with other faculty accompanied the Principal KMC to his office. He asked me to call Dr. Rahim Bangash. I sent a peon to call Dr. Rahim but was informed that he has left his car in front yard of the college and has left the college through back door. His cell phone was off. The Principal asked Prof. Dr. Jamshed Ali; the Vice Principal (admin) to go to the Forest Guest House where Dr. Rahim was residing

and bring him in his car and make sure that while bringing him the students are out of the college and no body sees him for his safety as the students were in emotional state.

Prof. DR. Rahim Bangash was brought to the college by Prof. Dr. Jamshed Ali and his initial statement was heard.

That night, the students of Peshawar University, Agriculture University; Engineering University, Islamia College University and Khyber Medical College blocked the main jamrud road and were demanding immediate dismissal of the professor. Dr. Muhammad Zahid, Assistant Provost KMC hostels was dispatched to defuse the situation. He assured them that the government will take the notice and appropriate action will be taken after this the student were dispersed.

Again on the 19th December, 2013 on the occasion of KMC Convocation, the students agitated and presented a complaint to the Governor for the delay in action against the professor concerned. The students presented another complaint to Mr. Asad Qaiser, Speaker Provincial Assembly on his visit to Peshawar University.

- 4. Para No.4 is evasive. Initially Prof. Dr. Liaqat Ali, Prof. Fr Muhammad Humayun, Prof. Dr Jamshed Ali, Prof. Dr. Bushra Iftikhar, Prof. Dr Noor Sahib was included in the committee. Later on when the Principal realized the sensitivity of the situation the committee was expanded by adding names of religious scholars form University of Peshawar and Islamia College University as co-opted members which includes prof. Dr. Miraj ul Islam Zia, Dr Hafiz Abdul Ghafoor, Prof. Dr. Rashid Ahmad, Prof. Dr Islam, Dr. Salim-ur-Rahman, Prof. Dr. Nisar Muhammad and Dr. Muhammad Zahid. The enquiry committee heard the student namely Miss Misbah Syed, her friends, boy class representative and Dr. Raheem Bangash in depth. On 14 December 2013 the larger committee crossed question him. The committee after through discussion and looking from all aspects the following the recommended committee recommendations.

"Prof Dr. Rahim Bangash also recorded his statement tendering an apology if he has hurt the sentiments of any one. He further said that as Muslim he believes in the Khatm-e-Nabowat and honour of the prophet (P.B.U.H) (copy of the statement is attached) and consider those liable for capital punishment who would commit Touheen-e-Rasalat.

The committee is of the opinion that the view expressed by the professor in the class room were mere a slip of tongue unintentional, unintended. He therefore has not committed any blasphemy in the honour of prophet (P.B.U.H).

However the situation in the classroom was mishandled.
The professor was not supposed to express opinion regarding religion in a professional class. The professor expressed that he was extremely sorry and said the would not repeat this act in future.

According to the professor which he explained in form of the committee that he is not against hijab in general however his personal opinion differs. On the other hand the female students concern presented the situation with some exaggeration which was then misused by some elements.

Being a civil servant, his case is forwarded and recommended to the Health Department Khyber Pakhtunkhawa for further necessary action.

- 5. In reply to Para No.5 it is submitted that the enquiry committee after recommendation forwarded the case of appellant to the Health Department for necessary action. The Health Department issued Show Cause Notice to the appellant which was replied. The appellant was charge sheeted and after hearing him the appellant was found guilty and vide Notification No.SOH-I/I-321/2013 the Secretary Health major penalty of "Compulsory Retirement for Services". Rest of the para is not related to answering respondent/Principal KMC.
