





- 3- That the respondent No.2 District Education Officer (Male) Swat issued a notification / order No.9330-9480 PSHT/ Promotion/2014 dated 13/11/2014, in which the appellant promoted as PSHT B-15 and was transferred from Natmaira to Ramoda. (Copy of Notification / order is attached as Annexure "B").
- 4- That as per Government policy a senior most PST shall be promoted and posted in the nearest school in the same UC.
- x 5- That the appellant being a senior most PST at Serial No.40 at Seniority List No.987 and the respondent No.4 as at Serial No.41 at seniority list No.988 which is junior than the appellant, the appellant is therefore, entitled to be promotion and posting at ^{Samsari chadega} Ramoda against the post of respondent at Fazalabad Samsari in the same U.C but the appellant is ignore which is against letter and spirit of policy.




