HEARING.**


**RESPECTFULLY SHEWETH:**

APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED ACTION OF THE RESPONDENTS OF NOT PROMOTING THE APPELLANT FROM THE POST OF SST (BS-16) TO THE POST OF SUBJECT SPECIALIST (BS-17) (URDU) WITH EFFECT FROM 24.05.2022, THE DATE WHEN HIS COLLEAGUES AND JUNIORS WERE PROMOTED FROM THE POST OF SST (BS-16) TO THE POST OF SUBJECT SPECIALIST (BS-17) AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

**PRAYER:**

**THAT ON THE ACCEPTANCE OF THIS APPEAL, THE RESPONDENTS MAY KINDLY BE DIRECTED TO CONSIDER THE APPELLANT FOR PROMOTION TO THE POST OF SUBJECT SPECIALIST (BS-17) (URDU) WITH EFFECT FROM 24.05.2022, THE DATE WHEN HIS COLLEAGUES AND JUNIORS WERE PROMOTED FROM THE POST OF SST (BS-16) TO THE POST OF SUBJECT SPECIALIST (BS-17) WITH ALL BACK BENEFITS. ANY OTHER REMEDY, WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT, MAY ALSO, BE AWARDED IN FAVOUR OF APPELLANT.**

**RESPECTFULLY SHEWTH:**

**FACTS:**

1. That the appellant joined the Education Department in the year 1987 as CT and was promoted to the post of SST (BPS-16) on 31.08.2004. The appellant since his appointed is performing his duty with devotion and honesty, whatsoever assigned to him.
2. That the respondent department issued the final seniority list of the SST (BPS-16) in which the appellant was at Serial No.626, while 59 SSTs who were promoted to the post of Subject Specialist (BS-17) (Urdu) on 24.05.2022 were juniors to the appellant in that seniority list. **(Copy of seniority list is attached as Annexure-A)**
3. That posts of Subject Specialist/ Head Master (BPs-17) were vacant and in this respect the respondent No.3 through letter dated 18.11.2021 directed all District Education Officer, DCTE/PITE/NMD (Male) (E&SE) Department Khyber Pakhtunkhwa to submit application/documents along with ACR for SS/HM Promotion and in response of letter dated 18.11.2021, the respondent No.4 submitted ACR/file of the teachers regarding for promotion from SST to SS/HM to respondent No.3 through letter dated 08.12.2021, in which the name of the appellant was at Sr. No.43 for Urdu and at Sr. No.44 for Pushto. **(Copies of letter dated 18.11.2021 and letter 08.12.2021 are attached as Annexure-B&C)**
4. That Departmental Promotion Committee was held on 28.03.2022 and the consequent upon the recommendations of the DPC, 653 SSTs (BS-16) were promoted to the post of Subject Specialist (BS-17) on regular basis vide notification dated 24.05.2022 in which 64 Subject

Specialist (BS-17) (Urdu) were also included which is evident from their posting/transfer notification dated 15.06.2022 and in these 64 Subject Specialist (BPS-17) (Urdu) 59 were junior to the appellant in the seniority list of SST (BS-16). **(Copies of notification dated 24.05.2022 and notification dated 15.06.2022 are attached as Annexure-D&E)**

5. The appellant then filed complaint for promotion to the post of Subject Specialist (BS-17) to Provincial Ombudsman Khyber Pakhtunkhwa on which notice was issued to respondent No.1, 2 & 3 for report/comments on which respondent No.3 submitted report/comments in which he concealed the material facts and mislead the Provincial Ombudsman by giving false statement in his report/comments that the Peshawar High Court Peshawar has already decided his case in order sheet dated 15.06.2022 title Mr. Bakht Akbar VS Government of KPK in W.P No.3265-P/2021 with the direction that the petitioner may be considered. In case the petitioner is still aggrieved of the decision of the respondents, he may approach proper forum having jurisdiction for redressal of his grievance, but the W.P No.3265-P/2021 is about the up-gradation of the appellant from BS-16 to BS-17 on the basis of notification dated 26.10.2008. Similarly in the report/comments respondent No.3 also gave false statement that now the petitioner approach to the learned Khyber Pakhtunkhwa Service Tribunal Peshawar in Execution Petition vide No. 250/2021 titled Mr. Bakht e Akbar VS Government of KPK, which is still pending before the Honorable Court, but the appellant has never filed Execution Petition No. 250/2021 in this Honorable Tribunal and filed service appeal No.3417/2021 for release of his salary which was also withdraw by the appellant on 06.02.2023 and on the basis of false statement/report submitted by the respondent department, the Provincial Ombudsman gave its finding on 05.04.2023 on the complaint of the appellant that record shows that the complainant has approached the Honorable Peshawar High Court Peshawar in Writ Petition bearing No.3265-P/2021 for redressal of his grievance. Honorable Peshawar High Court was pleased to direct the complainant to approach proper forum having jurisdiction. The complainant has filed appeal before the Honorable Service Tribunal Khyber Pakhtunkhwa for his grievances which is pending adjudication. In view of above this forum has no jurisdiction to entertain the complaint of the complainant. Investigation in the instant complaint is closed under Regulation 17 (m) of eth Khyber Pakhtunkhwa Provincial Ombudsman Office (Regulation, Investigation and disposal of the complaint) Regulations, 2011. **(Copies of notice, report/comments, High Court judgment dated 15.06.2022, memo of service appeal No.3417/2021, order sheet dated 06.02.2023 and ombudsman order dated 05.04.2023 are attached as Annexure-F,G,H,I,J&K)**

6. That the appellant then filed departmental appeal on 30.05.2023 for promotion the post of Subject Specialist (BS-17) (Urdu) which was not responded within the statutory period of ninety days. (Copy of departmental appeal is attached as Annexure-L)
7. That the appellant has no other remedy except to file the instant appeal in this Honorable Tribunal for redressal of his grievance on the following grounds amongst others.

**GROUND:**


- A) That not taking action on the departmental appeal of the appellant and not promoting him to the post of Subject Specialist (BS-17) (Urdu) in notification dated 22.05.2022 along with his colleagues and juniors are against the law, rules promotion policy norms of justice and material on record, therefore not tenable.
- B) That the appellant was at Sr. No. 626 of the seniority list of SST (BS-16), while 59 SSTs who were promoted to the post of Subject Specialist (BS-17) (Urdu) in notification dated 22.05.2022 were juniors to the appellant in that seniority list, which means that the appellant was senior to them and was also eligible for promotion to Subject Specialist (BS-17) (Urdu), but despite that the appellant was not promoted to the post of Subject Specialist (BS-17) (Urdu) along with colleagues and juniors in the notification dated 22.05.2022, which is violation of law, rules and promotion policy.
- C) That posts of Subject Specialist/ Head Master (BPS-17) were vacant in the respondent department and in this respect the respondent No.3 through letter dated 18.11.2021 directed all District Education Officer, DCTE/PITE/NMD (Male) (E&SE) Department Khyber Pakhtunkhwa to submit application/documents along with ACR for SS/HM Promotion and in response of letter dated 18.11.2021, the respondent No.4 submitted ACR/file of the teachers regarding for promotion from SST to SS/HM, to respondent No.3 through letter dated 08.12.2021 in which the name of the appellant was at Sr. No.43 for Urdu and at Sr. No.44 for Pushto, but despite the submission of documents of the appellant for promotion, he was not promoted to the post of Subject Specialist (BS-17) (Urdu) along with colleagues and juniors in the notification dated 22.05.2022 without giving any reason which is against the norms of justice and fair play.
- D) That the appellant has good service record and is also eligible for promotion to the post of Subject Specialist (BS-17) (Urdu), but he was not promoted to the post of Subject Specialist (BS-17) (Urdu) along with his colleagues and juniors and as such the appellant is entitle to




be promoted to the post of Subject Specialist (BS-17) (Urdu) on 22.05.2023 i.e when his colleagues and juniors were promoted to the post of Subject Specialist (BS-17) (Urdu).

- E) That not promoting the appellant to the post of Subject Specialist (BS-17) (Urdu) on 22.05.2023 will cause irreparable loss to the appellant in the shape of pension and other monetary benefits for no fault on his part as the appellant is at the verge of the retirement.
- F) That the appellant seeks permission of this Honorable Tribunal to advance others grounds and proofs at the time of hearing.



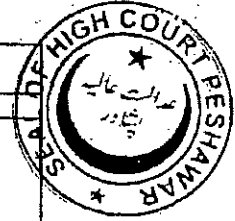

On acceptance of this appeal, the respondents may kindly be directed to release the salary of appellant and respondent No. 1 also be directed not to harass and make hurdles in services of appellant.

Any other relief not specifically prayed but this august court deems proper may also be granted.

**Respectfully Sheweth:**

1. That the appellant was initially appointed as Certified Teacher (CT) in 1987 at Chauga, District Shangla.
2. That the appellant was transferred to the Government Higher Secondary School Dherai, Swat in 2018, thereafter, the appellant assumed charge of his service and since then is regularly performing his duties with zeal and devotion.
3. That, as the respondent No. 1 / principal of the said school was not following the SOPs in current situation of COVID-19, thus, action was taken against him, however, the respondent No. 1 on the back of appellant and other staff members, tried to divert the whole situation in shape of application whereupon the respondent No. 1 has advertently by concealment of facts mentioned that SOPs are been followed in the school and wants all the staff members to put their signature upon the said application, however, the appellant being a person of devotion, did not want to suppressed the facts, thus, didn't bother to sign the application (Copies of applications are attached herewith).
4. That for the reason mentioned above, the respondent No. 1 appears to misbehave with the appellant along with Mr. Roohul Amin (SCT) and Asadullah (CT), which is evident from order No. 334 dated 22-10-2020, and for the purpose of taking revenge from the appellant, started to damage the self-esteem of appellant in the eyes of other staff members.
5. That later on, the respondent No. 1 while illegally exercising his authority and powers, through order No. 332 dated 22-10-2020, directed the appellant to relieve his charge, against which the appellant filed a departmental appeal before the respondent No. 3, which is yet to be decided.
6. That though the above mentioned appeal of appellant has not yet been decided, however, the respondent No. 1 by

further harassing the appellant, personally approached the office of respondent No. 2 and stopped the salary of appellant from the month of October, 2020, for which the respondents are not even authorized to do so.

7. That above said actions and inactions of respondents are liable to be set aside inter alia on the following grounds.

**Grounds:**

- i. That the actions and inactions of respondents are illegal, unlawful and against the service rules and regulations.
- ii. That the respondents Nos. 1 & 2 are not authorized to either relieve the appellant from his charge or stop the salary of appellant, because earlier the services of respondent No. 1 has been placed at the disposal of Directorate vide office order dated 29-12-2017, due to certain inquiries against him and he has further been adjusted at GHSS Totano Bandai, vide office order dated 05-03-2018 (Copies are attached).
- iii. That respondent No. 1 is involved in certain inquiries and illegal affairs, whereupon action has also been taken against him by the higher authorities, which is also evident from a reply through Pakistan Citizen Portal to one of the complainant, wherein it has clearly been mentioned that action has already been taken vide office order No. 5753-57 dated 18-12-2019, however, the respondent No. 1 is still exercising his power and delegation illegally and unlawfully (Copy of the order dated 18-12-2019 may please be ordered to be produced before the court).
- iv. That respondent No. 1 is a headstrong person, who is not even following the orders of his high ups, thus is not entitled to pass any order regarding relieving the charge or stop the salary of appellant.

- v. That the respondent No. 1 has not even followed the SOPs, which has been ordered to be followed by the high ups for deficit the consequences of COVID-19, and were extremely necessary in this critical situation, against which action has been taken against the respondent No. 1, but the respondent No. 1 through some unknown approach, tried to buried all proceedings against him and take adverse action against other staff members, who took stand against him did not followed his forceful directions.
- vi. That the above said behavior of respondent No. 1 is self-explanatory and the respondent No. 1 is liable to be dealt in accordance with the law, because the respondent No. 1 has not only harassed the appellant but life of other staff members have also been made as hell.
- vii. That vide recent judgment of the apex Supreme Court of Pakistan, it has been declared, that the salary of government servant could not be stopped, because it has direct impact upon the family of the government servant.
- viii. That appellant is the only source of income for his family members, however the salary of appellant has illegally been stopped from the month of October, 2020, though the appellant has never committed any misconduct, misbehavior or other illegal acts rather has performed his duties with all efforts and devotion.
- ix. That other ground not specifically mentioned here will be argued during the course of arguments with prior permission.


It is therefore, humbly requested that, on acceptance of this appeal, the respondents may kindly be directed to release the salary of appellant and respondent No. 1 be also directed not to


harass and make hurdles in services of appellant.

Any other relief not specifically prayed but this august court deems proper may also be granted.

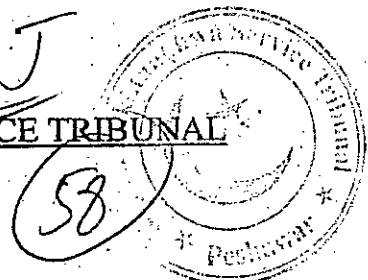

THE COMPLAINT

Mr. Bakht Akbar r/o District Swat instituted the instant complaint stating that he has been associated with the Education Department since 18<sup>th</sup> March, 1987 and performing his duty as SST since September 2004. He further stated that he is at S.No.626 in the 3<sup>rd</sup> final SST seniority list. Total 64 Teachers have been promoted for Urdu Subject. He is entitled to promote as SS Urdu from 15<sup>th</sup> June 2022. He further stated that his case for Urdu SS was sent to Director Elementary & Secondary Education Office by DEO Swat on 8<sup>th</sup> December 2021, but since then he is waiting for appointment order. Hence he approached this Forum for redressal of his grievance.

REPLY OF THE AGENCY

Notices under section 10 (4), of the Khyber Pakhtunkhwa Provincial Ombudsman Act, 2010 were issued to Secretary, Government of Khyber Pakhtunkhwa Elementary & Secondary Education Department Peshawar, Director, Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa, Peshawar and District Education Officer (Male) Swat to addresses the allegations contained in the complaint and submit reply including rebuttal, if any. In response the Section Officer (complaint) Government of Khyber Pakhtunkhwa Elementary & Secondary Education Department, Peshawar and AD (RTI & Ombudsman Directorate of E&SE Khyber Pakhtunkhwa) submitted their replies saying that the case of complainant has approached the Department for redressal of his grievances. But his name is included in the upcoming DPC for consideration. The Directorate of Elementary & Secondary Education Khyber Pakhtunkhwa vide its reply submitted through AD (RTI & Ombudsman Directorate of Elementary & Secondary Education) stated that a letter was issued to all the District Education Officer, DCIF/PITE/NMD (Male) Elementary & Secondary Education Department Khyber Pakhtunkhwa for submission of PERs/ACRs/ documents for promotion from SST BPS 16 TO SS/HM BPS-17 vide letter No 1168-1245 dated 18/11/2021. District Education Officer (Male) Swat has submitted

PERs/ACRs/documents on 31/01/2022. The department has already put up the appeal of the complainant with working papers for promotion to the post of SST BPS-16 to SS BPS-17 to the Secretary Elementary & Secondary Education Department Khyber Pakhtunkhwa, Peshawar on 08/11 2022. Besides the complainant has also filed a Writ Petition before Honorable Peshawar High Court bearing No. 3265-p/2021. The complainant has also approached the Khyber Pakhtunkhwa Service Tribunal, Peshawar in execution petition bearing no 250/221 titled Bakht Akbar versus Government of Khyber Pakhtunkhwa, which is pending final decision.

**REJOINDER**

Reply of the agency was shared with the complainant for feedback/rejoinder. In response, he reiterated his earlier version.

**HEARING**

In order to expedite the matter, the case was fixed for hearing on 22/02/2023. Mr. Abdul Qayum AD (RTI & Directorate of E&SE Khyber Pakhtunkhwa) appeared on behalf of the Agency and informed that complainant approached this department for redressal of grievances with regard to his promotion. That his name is included in the upcoming DPC for consideration. The complainant appeared in person and recorded his statement.

**FINDINGS**

Record shows that complainant has approached the Honorable Peshawar High Court Peshawar in Writ Petition bearing No 3265-p/2021 for the redressal of his grievance. Honorable Peshawar High Court Peshawar was pleased to direct the complainant to approach proper forum, having jurisdiction. The complainant has filed appeal before the Honourable Service Tribunal Khyber Pakhtunkhwa for his grievances, which is pending adjudication. In view of the above this forum has no jurisdiction to entertain the complaint of the complainant. Investigation in the instant complaint is closed under Regulation 17(m) of the Khyber Pakhtunkhwa Provincial ombudsman office (Regulation, investigation and disposal of the complaints) Regulation. 2011
