Respectfully Sheweth;

Brief facts giving rise to the instant Service Appeal are as under

1. That vide order dated 04.01.2011 the appellant was appointed as Theology Teacher (BPS-14) and posted at GGMS Zakarkhel, area Surrani Bannu.
(Copy of appointment order dated 04-01-2011 is enclosed as annexure "A")
2. That thereafter the appellant was posted at GGMS Muhammad Zaman Ialozai area Surrani District Bannu and currently regularly performing her duties to the entire satisfaction of her immediate superiors and no complaint whatsoever was filed against her from any quarter.
3. That the appellant was terminated from her service on 09.05.2017 on the strength of High Court order which was

impugned before Supreme Court of Pakistan. The High court order referred above was set aside by the Apex Court vide order dated 07.03.2018.

(Copies of High Court order dated 09.05.2017 is enclosed as annexure "B" while order of the supreme court dated 07.03.2018 is enclosed as annexure "C")

4. That the appellant was reinstated in service vide order dated 07.10.2019 by the District Education Officer (F) Bannu and accordingly assumed her charge and regularly performing her duties to the entire satisfaction of her immediate superiors.
(Copy of reinstatement order dated 07.10.2019 is enclosed as annexure "D", Copy of charge report dated 07.10.2019 is enclosed as annexure "D-1", service certificate issued by headmistress GGMS Ialozai Suranni Bannu is enclosed as annexure "E" and certificate titled Non-Involvement Certificate in departmental / Anti-Corruption or Judicial cases is enclosed as annexure "F" and confidential reports viz a viz the appellant for the year 2020, 2019, 2018, 2017 are enclosed as annexure "G-1 to G-4").
5. That the Committee consisting of Mr. Akbar Niaz, (Superintendent), Mr. Barkat Ali, (Litigation officer), Miss Shahana Hameed (ASDEO), and Mr. Dilawar Shah (Dealing Assistant) recommended to release to pay of the appellant vide release order dated 14.10.2019.
(Copy of pay release order dated 14.10.2019 is enclosed as annexure "H")
6. That the appellant was drawing monthly salaries from October, 2019 to March 2020, however, her salary was stopped w.e.f 01.04.2020 to September, 2022 without assigning any reason or cause.
7. That the appellant filed Service Appeal No. 3235/2021 before Service Tribunal, Peshawar, which was allowed vide judgment/order dated 05.10.2022 wherein the official respondents were directed to release the current salaries of the appellant.

8. That vide order dated 21.06.2023 the official respondents in the light of order dated 05.10.2022 released the pay of appellant w.e.f. 05.10.2022.

9. That the appellant preferred her Departmental Appeal for release of her salaries w.e.f. 01.04.2020 to 01.09.2022 for a period of 2 years and 5 months with all increments before respondent No. 3 with copy forwarded to Respondent No. 4 but no response has been so far provided to her hence constrained to file the instant Service Appeal for redressal of her grievance on the following amongst other grounds.

(Copy of departmental appeal is enclosed as annexure "K")

Grounds

A. It is settled law that salary of a civil servant cannot be stop in presence / existence of appointment order and strick action will be taken against the concerned officer who has illegally withheld the salary without referring to any explicit provision of law. (2017 PLC (cs) Note 14 Peshawar High Court) (1997 PLC (cs) 666): (2009 PLC (cs) 557): (2006 PLC (cs) 95)

B. That the appellant was regularly performing her duties to entire satisfaction of her immediate superiors w.e.f. 01.04.2020 to 01.09.2022 therefore there was no occasion or cause to stop her salary for the said period which is violative of various provision of Constitution of Pakistan.

(Copy of attendance sheets are enclosed as annexure "L")

C. That earlier the appellant approached through Service Appeal No. 3235/2021 before Service Tribunal, Peshawar, which was allowed vide judgment/order dated 05.10.2022 wherein the official respondents were directed to release the current salaries of the appellant therefore no valid justification exist to illegally withheld her previous salaries w.e.f. 01.04.2020 to 01.09.2020 when she had performed her duties for the aforesaid period.

- D. That a civil servant cannot be expected to maintain a dignified living without being paid her monthly salaries.
- E. That it was held in reported judgment dated (2017 PLC (cs) Note 14 Peshawar High Court) even if appointment order was made against the procedure then appointing authority would be reasonable for committing irregular appointment. It was further held that state was bound to eliminate all forms of exploitation. The impugned action of departmental authority with regard to stoppage of pay of an employee was void ab initio. Department was directed to release the salary of employee forthwith from the date of stoppage of her pay. **Further reliance can be placed on 2012 PLC (cs) 708, 2014 PLC (cs) 330 and 2001 SCMR 1320**
- F. That additional grounds will be raised at the time of arguments with the prior permission of this Hon'ble Tribunal.

Keeping in view what has been stated above it is therefore humbly prayed from this Hon'ble Tribunal to allow this Appeal with direction to the official respondents to forthwith release the salaries of the appellant w.e.f 01.04.2020 to 01.09.2022 for a period of 2 years and 5 months with all increments.

TERMS & CONDITIONS


- 1- Their/his services will be considered regular but without pension or gratuity in term of Section-19 of NWFP, Civil Servant Act, 1973 as amended vide NWFP, Civil Servant (Amendment) Act, 2005. They/he will however be entitled to Contributory Provident Fund in such a manner and at such rates as may be prescribed by the Government.
- 2- Their/his services will be liable to termination on one month's notice from either side, in case of resignation without notice their/her two month's pay/allowance shall be forfeited to Govt.
- 3- They will be governed by the NWFP, Civil Servants act, 1973 all the laws applicable to the Civil Servants & rules made there under.
- 4- The appointee should submit their charge Report to all concerned.
- 5- Their services can be terminated at any time, in case their performance is found unsatisfactory during probationary period. In case of misconduct they will be proceeded against under the NWFP removal from service Special Power Ordinance 2000 and the rules framed from time to time.
- 6- The candidate should join their pos. within 15 days of the issuance of this order.
- 7- The head of the institution concerned should furnished a certificate to the effect that the candidate have joined the post or otherwise, after 15 days of the issuance of this order, failing which, their order will be treated as cancelled.
- 8- Charge should not be handed over if age of the candidate is below 18 year or above 33 years.
- 9- The appointees are directed to perform their duties in their respective school noted against their names for a minimum period of Three years and they will not be transferred from school where appointed
- 10- In case of Fake Certificate and Degree detected later on the undersigned reserve the right of amendment in the appointment order accordingly.
- 11- They are required to produce Health & Fitness Certificate from the Medical Superintendent concerned before taking over charge.
- 12- They would be on probation for a period of Two Years extendable for an other one year.
- 13- Their original certificate/Degree should be verified from the Concerned Board/University/Institution before the release of their pay.
- 14- No TA/DA etc is allowed

2. The aforesaid petitions pertain to two groups of petitioners, i.e. Arabic Teachers and Theology Teachers. So petitioners in W.P.Nos. 16-B/2011, 51-B/2016, 449-B/2016 & 454-B/2016 have prayed for issuance of a writ declaring the appointment of respondents as Arabic Teachers by respondent No.1 as illegal, without lawful authority with further prayer to direct the official respondents to appoint the petitioners against the posts of Arabic Teachers with further prayer to verify the degrees/"Asnaads" of the respondents appointed against the said posts. Similarly, petitioners in W.P.No. 18-B/2011, 78-B/2011, 96-B/2012, 97-B/2012, 580-B/2015, 203-B/2016 & 404-B/2016 have challenged the appointments of respondents as Theology Teachers and through their petitions, they prayed for issuance of a writ directing the respondents to appoint the petitioners against the said posts and also verification

of "Asnaad" of the respondents appointed against the said posts of Theology Teachers.

3. Facts leading to the filing of all these petitions are that respondents advertised certain posts of Arabic Teachers (A.T) and Theology Teachers (T.T) in the national Daily "Ausaaq" dated 24.04.2010 and in response to that petitioners, respondents and so many other considering themselves eligible for the posts of A.T & T.T applied for their appointments. As per the advertisement, all the candidates were directed to appear for interview on certain dates. However, the official respondents violated the terms and conditions given in the advertisement and introduced written test and accordingly, all the candidates were put to written test including the petitioners. All the petitioners, as alleged by them in their petitions, were sanguine of their success but to their surprise, they were declared fail in the written test or were given below passing

marks while other candidates who are holders of the fake degrees and "Asnaad" were declared pass in the written test resultantly were appointed against the said vacant posts.

4. Since the allegations levelled by the petitioners were very serious in nature, therefore, comments of respondents were called which were furnished wherein they totally denied the allegations levelled in the petitions and contended that their "Asnaad" were genuine, valid and all the appointments were made in accordance with rules and the policy in vogue.

5. During several hearings of these petitions, it came to lime light that in view of the serious nature of the allegations levelled by the petitioners qua favouritism and corrupt practices meted out by the official respondents in ignoring the petitioners and

adjusting the respondents against the vacant slot, and to this effect though several queries were made but of no avail, therefore, to meet the situation and resolve the controversy, a Division Bench of this court on 10.9.2015, with the concurrence of learned counsel for the parties, constituted a four members committee headed by the Additional Registrar, Bannu Bench Mr. Nasrullah Khan Gandapur, while Assistant Advocate General, Peshawar High Court, Peshawar Bannu Bench, Mr. Qudratullah Khan Gandapur President High Court Bar Association Bannu Bench, Mr. Zafar Iqbal Khan Advocate and Mr. Ghulam Farid, Inspector Circle Office Anti-Corruption Bannu were its members.

6. The mandate of the committee was to probe into the matter, scrutinize all the degrees/"Asnaad" of the respondents to the effect as to whether the testimonials/documents on the basis of which

appointments were made, were in fact fake or otherwise were genuine and valid and also report as to whether merit position of the candidates in the light of advertisement, policy and rules was correctly assessed.

7. The Committee so constituted for the purpose has submitted its two detail reports one about A.T and other for T.T, wherein it has been stated that to dig out the factum of genuineness or otherwise of the degrees/"Asnaad" allegedly issued by various Islamic religious institutions i.e. Madrisas/Darul-Alooms of the country, the committee took pain by visiting far away station, like Lahore and recorded statements of the responsible incumbents of the said Institutions. The committee in its report concluded that all the "Asnaad" of the respondents were got verified from the Tanzim-ul-Madaris, Ahle-Sunnat Pakistan at Ravi Road, Lahore and according to latter, all the "Asnaad" were found fake.

8. We have heard the arguments of the learned counsel for the parties at considerable length and have also gone through the available material appended with the petitions and also the reports of fact finding enquiry committee constituted by this Court.

9. After going through the available record as well as the findings of the enquiry Committee, we have come to the conclusion that all the selection process was defective, especially in the light of reports filed by the Committee constituted with the consent of the parties that all the selectees/appointees, are equipped with bogus "Asnaad" certificates and were lower in merit despite the fact that opportunity was given to the official respondents but they failed to produce the written papers either before this Court or before the inquiry committee inspite of clear cut direction of the Additional Registrar (who happens to be Chairman of the Committee) to furnish such result

sheets/answer sheets/merit lists, the same could not be provided which act on their part smacks of malafide on the part of official respondents, and as such all the appointments based on said bogus and fake "Asnaad" are nothing but a sheer nullity in the eye of law. The respondents at the helm of affairs have made the entire process of selection mockery which is unbecoming of holder of official position as government servants.

10. It is worthwhile to mention that according to the findings of the enquiry committee, testimonials of the some 09 candidates were found genuine and on merit they deserved to be appointed but were not appointed and the departmental authorities, in a haste, issued their appointment orders without bringing into the notice of this court, therefore their appointment cannot be legitimized when entire process of selection, as discussed above, was found defective against rules & law and has been declared null and void with effect

11. As discussed above whole process of selection has been found a classic example of favouritism, corruption and of corrupt practices by benefiting some blue eyed who did not possess even required qualifications, as fake "Asnsad" does not mean that they were qualified.

12. It is surprising and requires solid and authentic proof that ladies belonging to this jurisdiction got admissions in "Deni Madaris" situated at Punjab, having no any entry or admission record; no record of issuance of Roll Numbers and no record of examination was found by the committee so "Asanaad" was found fake. 13. In view of above all the connected writ petitions are allowed in terms of:

(i) Declaring all the appointments of the respondents as illegal, void and ineffective upon the rights of the petitioners from the date of their appointment order.

- b. To restrain the respondents to effect any illegal / unauthorized recoveries from the appellants.
- c. To issue direction to the respondents for release of the Monthly pay / salary of the appellant and arrear of monthly salary.
- d. Any other relief deems fit in the circumstance of the case.

R/SHEWETH:

FACTS:

1. That it is the second circulation of the appeal in hand as earlier on appellant also filed appeal which was disposed of and later on since the appellant was terminated from her services on 23.06.2017, on the strength of the order of Hon'ble Peshawar High Court Peshawar, therefore the matter was lead to Hon'ble Supreme Court of Pakistan.
2. That Hon'ble Supreme Court of Pakistan was pleased to allow the preferred CPLA vide order dated 07.03.2018, consequently appellant was certainly been reinstated on her services and the duties were about to perform and salaries were about to release to the appellant.
3. That Meanwhile the impugned explanation letter TT/ AT 2010-12/2019 dated Nil was issued on the part of the respondent No. 03 according to which it was allegedly

recommended that appellant was found illegal and unlawful conduct to draw her consistent salaries, by presentation of the incomplete and forged record of herself.

- 4. That it is also notable that appellant impugned the above explanation letter vide preferring writ petition No. 535-B/2020 before Hon'ble Peshawar High Court Peshawar, which was also got disposal vide order / judgment dated 30.09.2020, according to which it was suggested that this plea of the appellant can be sought before the appropriate forum of law as Hon'ble High Court is lacking with the jurisdiction in the matter. *(Copy of the recently passed order / judgment of Hon'ble Peshawar High Court on the preferred writ petition of the petitioner bearing No. 535-B/2020 dated 30.09.2020 is attached as annexure A).*
- 5. That as per disposal order of the Hon'ble Peshawar High Court Peshawar dated 30.09.2020 appellant is hereby preferring this appeal through proper channel to invoke departmental appellate jurisdiction of this worthy Service Tribunal inter alia on the following grounds amongst others;

GROUND:

- A. That firstly being part and parcel of the earlier grounds taken in the above preferred writ petition, by the petitioner, therefore, the same grounds are required to re-consider being basic ingredients and integral part of this appeal too.
- B. That the acts of the respondents are illegal hence of no legal effect.
- C. That, re-instatement order of the appellant is still in field hence explanation letter regarding unauthorized / illegal withdrawal of arrears and back benefit is without authority and vide.
- D. That, after order of re-instatement some valuable rights have been accrued to the appellant which can not be taken back / withdraw without due process of law.
- E. That, non-payment of monthly salary to serving Government employee is the violation of article 2(A), 3,9 and 14 of every functionary of the state to see that provisions of the constitution and particularly those relating to the fundamental rights are vegntly observed and followed, failing which they are liable to be proceeded for disciplinary action. The same view was hold by Lahore High Court in case reported as 1997 PLC (CS) Page 666 and judgment of Peshawar High court Bannu Bench in Writ Petition No. 24-B/2015.

That, article 9 of the constitution of the Islamic Republic of Pakistan 1973, guarantees protection to life and employee not receiving his salary for considerable period of time was not expected to maintain minimum standard of civilized living hence act of respondents of stopping monthly salary of the appellant is in violation of the Article 9 of the constitution.

G. That, some other grounds may be raised during course of arguments.

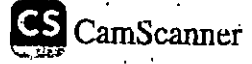

This is in light of verbal directions by the DEO (F) Bannu dated 22-7-2016 in her personal office in regard conduction of an enquiry/inquest report about female T.T. teachers who had filed service appeals in the Honourable Tribunal Khyber Pakhtoonkhwa, Peshawar with regard stoppage of their salaries by the Ex-EDO (E&SE) Bannu on the basis of forged sanads declared forged by the controller of madrisa namely Maulana Naseem Ali Shah Bannu, being feeling aggrieved by the office order in regard their stoppage of salaries, the below named female TT teachers/appellants knocked at the door of service Tribunal KPK Peshawar.

To sum up, the DEO (F) Bannu ensured her personal appearance before the Honourable Tribunal on dated 21-4-2016 in the above titled service appeals and stated at the bar that the issue under discussion is also in the table of Honourable Peshawar High Court Bench Bannu. Since the above titled service appeals have closed connection with those petitions which are sub-judice before Honourable High Court Bannu bench.

That on 17-5-2016 the Honourable Court Bannu bench directed the DEO (Female) Bannu to release the salaries of those teachers/petitioners/respondents who are actively serving the education department. Hence, the directions issued by the court the competent authority directed the below named enquiry officers to see and to probe into the matter as to whether the above named teachers/appellants performed their duties at their posted schools or otherwise.

PROBE BY THE ENQUIRY OFFICERS.

In this connection, the concerned headmistresses were also included in the instant enquiry as active members who pleasantly participated in this process. When confronted with the situation each concerned headmistress stated on oath regarding attendance/ service of each teacher/ appellant. Their detailed FINDINGS are as following.

DETAIL OF FINDINGS

- 1- Shabina: she was posted at GGMS Painsda Khel Wazir, Tulsa Rani CT/ the then In charge Headmistress stated that since she has joined the school in March, 2013, she has not seen Shabina/Appellant in the school. She further stated that Shabina is not known to her by face. The Present Headmistress Fakherun Nisa also stated that since she has joined the school as regular Headmistress, Shabina has not performed her Govt. duty for a single day.
- 2- Bina Khanum: GGMS Bodin Khel. She was posted at GGMS Bodin Khel Bannu and according to In Charge of the School namely Mst. Yasmin, Bina Khanum/ Appellant has remained herself absent from duty without any intimation. The In Charge of the school herself stated that Bina Khanum /appellant is not entitled for the post of TT as well as monthly salaries. Nasreen Taj Headmistress GGHS Kotka Juma Khan Bannu strongly supported the statement/views of the one Mst. yasmin incharge GGMS Bodin Khel.
