PRAYER:

That on acceptance of this appeal the impugned transfer orders dated 15.6.2023 & 27.9.2023 and appellate order dated 28.9.2023 may very kindly be set aside and the respondents may kindly be directed not to transfer the appellant from the post of village Sectary Village Council Kattan Bala, Dir Upper. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH: ON FACTS:

Brief facts giving rise to the present appeal are as under:-

1- That the appellant was appointed as village Secretary Village Council kattan Bala (BPS-07) vide office dated 5.2.2016. That it is pertinent to mention that proper codal formalities have been adopted by the respondents in the selection process of the appellant. That after appointment the appellant started performing his duty quite efficiently and up to the entire satisfaction of his high ups. Copies of

6- That appellant feeling aggrieved prefer Departmental appeal but the same has been regretted by the appellate authority vide impugned appellate order dated 28.9.2023. Hence no other efficacious remedy but to file the instant appeal on the following grounds amongst the others. Copies of the Departmental appeal and rejection are attached as annexure **I & J**.

GROUNDS:

- A- That impugned transfer orders dated 15.6.2023 & 27.9.2023 and subsequent appellate order dated 28.9.2023 issued by the respondents are against the law, facts, normal of natural justice and materials on the record hence not tenable and hable to be set aside.
- B- That appellant has not been treated in accordance with law and rules by the respondent department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

C- That the impugned transfer orders dated 15.6.7023 & 27.9.2023 and appellate order dated 28.9.2023 are also violative of Clause-1, Clause-IV and Clause-XIII of transfer/posting policy of Provincial Government. Copy of the policy is placed as annexure

D- That the impugned transfer orders dated 15.6.2023 & 27.9.2023 and appellate order dated 28.9.2023 has been issued by the respondents

in arbitrary and mala fide manner, therefore, the same is not tenable in the eye of law and liable to be struck down.

E- That, the impugned transfer orders dated 15.6.2023 & 27.9.2023 and appellate order dated 28.9.2023 are not passed in the public interest which is clear violation of judgments passed by this Honourable Tribunal and also the apéx Supreme Court of Pakistan hence impugned orders are void ab initio in its nature.

F- That as per rules and as per condition of the advertisement the post of the appellant is non transferrable being purely neighbor hood/village Council cadre.

G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal may kindly be accepted as prayed for.

Government servants including District Govt, employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.

Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.

To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule – TV thereof is referred. Transfer the holder of a tenure post before the completion of his

tenure or extend the period of his tenure. ... Require an officer to hold charge of more than one post for a period

exceeding two months.

4. I am further directed to request that the above noted policy may be strictly observed /implemented.

All concerned are requested to ensure that tenures of the concerned officers/officials are invariably mentioned in summaries submitted to the Competent Authorities for Posting/Transfer.
