

- 3. We have heard learned counsel for the appellants and learned District Attorney for the respondents.
- 4. Learned counsel for appellant contended that the impugned transfer order was the result of political motivation/pressure which smacked malafide and also the result of discrimination, arbitrary, perverse and without lawful authority; He further argued that the frequent transfer posting orders of the appellant was against the Transfer/Posting Policy of the Provincial Government which was liable to be set aside. At the end he requested that the instant appeal might be accepted.
- 5. As against that learned District Attorney argued that the transfer order 20.07.2022 was issued in public interest, therefore, the appellant had been treated in accordance with law. Furthermore, posting/transfer is a part of service and the appellant was required under Section-10 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 to serve anywhere in the province.

order dated 28.02.2022 but on 25.05.2022 the appellant was again transferred as Senior Research Officer (Plant Pathology BS-18) Agriculture Research Center, Baffa, District Mansehra. Just within two months he was again transferred to Chitral vide impugned notification dated 20.07.2022. The contention of pre-mature transfer was controverted by the respondents in the manner that it was the government administration and jurisdiction to order transfer posting order of the Officer wherever their services were required in the best public interest. It was contended that the appellant had spent most of his service period in Baffa i.e. his home town.

7. The contention of the respondents that it was the prerogative of the government to utilize the services of its servants may be considered but when once the government has notified a posting transfer policy for the civil servants wherein a specific tenure has been fixed then in such an eventuality the government or the authority competent to transfer a civil servant had to have the regard of the term of policy notified by itself. There is no denial of the fact that the appellant after spending more than three years at Chitral, was transferred to Baffa on 08.02.2022, which order was withdrawn on 28.02.2022 and again the appellant was transferred on 25.05.2022. After 25.05.20222, it was just and appropriate that the appellant, who had spent been allowed to complete at least two years at Baffa in view of the two

eyears' tenure provided in the posting/transfer policy. As against that the appellant was transferred just within two months i.e. on 20.07.2022 to Chitral without having regard to the tenure provided in the policy. Therefore,
