PRELIMINARY OBJECTIONS:

- (1) That the appellant, namely, Mr.Kalim Ullah, Naib Qasid (BPS-03) has got no cause of action and locus standi to file the instant service appeal.
- (2) That the appellant has not come to the Hon'ble Tribunal with clean hands.
- (3) That the appeal is barred by law and limitation.
- (4) That the appeal is bad for mis joinder and non-joinder of necessary parties.

PARA-WISE REPLY ON FACTS: -

- 1. Para No.01 of the Service Appeal is correct to the extent that appellant was appointed as Naib Qasid (BPS-03) in District Courts, Lakki Marwat in the year 2015 and also has completed M.A in Islamiyat during in service, as per record.
- 2. Para No.02 of the Service Appeal is correct to the extent that the appellant was placed at serial No.01 in that seniority list of Class-IV which was prepared for the purpose of promotion to the post of Junior Clerk (BPS-11) when Daftari/Record Lifter (BPS-05) is not available/ suitable in the District (copy of the said seniority list is enclosed as annexure "A").
- 3. Para No.03 of the Service Appeal is correct.
- 4. Para No.04 of the Service Appeal is correct to the extent that the vacant posts of Assistant (BPS-16) and Senior Clerk (BPS-14) were filled in the DPC meeting held on 26-11-2022 and the promotions against three vacant posts of Junior Clerk (BPS-11) could not be made due to the lack of requisite requirements of the senior official amongst the Daftari/Record Lifter & other class-IV staff. It is also worth noting that Mr.Tariq Hamayoun, Naib Qasid (BPS-03) also placed the application before the Departmental Promotion committee regarding possessing the requisite qualification for the promotion to the resultant vacant post of Daftari/Record Lifter (BPS-05) i.e Certificate of Middle Standard Examination, if promotion is being made to the post of Junior Clerk (BPS-11) from the post of Daftari/Record Lifter (BPS-05) but in the seniority list he was mentioned as illiterate and this omission was also noted by the Departmental Promotion Committee in its meeting held on 26/11/2022. Thus, the seniority/right of Mr.Tariq Hamayoun, Naib Qasid (BPS-03) upon the mentioning as illiterate in the seniority list and Mr.Rizwan Ullah, Daftari (BPS-05) due to lack of his service length may be effected, therefore, the

promotions of Class-IV staff were deferred and it was concluded that afresh provisional seniority lists would be prepared for the purpose of promotions to the posts of Daftari/Record lifter (BPS-05) and Junior Clerk (BPS-11) and after preparation, the same would be circulated among the concerned i.e Daftari/Record Lifters, Naib Qasid, Chowkidar, Mali and sweeper working in District Judiciary Lakki Marwat with directions to file their objections (if any). In this scenario, the same posts remained vacant and it was found not appropriate to consider the Junior officials for promotions as the said requisite requirements could be fulfilled with the passage of time, therefore, it was decided to postpone the promotions to the vacant posts of Junior Clerk (BPS-11) and the same will be filled up with respect to its ratio of promotion and direct recruitment in the next DPC which will be conducted at appropriate time.

PROMOTIONS TO THE 02 VACANT POSTS OF ASSISTANT (BPS-16)

DETAIL OF VACANT POSTS: 01 post became vacant on the retirement of Mr.Mir Abbas. Ex-Assistant from his service in the Establishment of the District & Sessions Judge, Lakki Marwat and 01 post became vacant in the Establishment of the District & Sessions Judge, Lakki Marwat on the reversion of Mr.Said Ahmad from the post of Assistant (BPS-16) to his original position of Senior Clerk (BPS-14). This post of Senior Clerk (BPS-14) was a newly created post vide the Peshawar High Court. Peshawar letter bearing Endst: BO-II/FD/3-14/SNE/PHC/2022-23 dated 11/10/2022 in the Establishment of SCJ (Admn).

The criteria for the Post of Assistant (BPS-16) under Serial No. 4 of the schedule to the Peshawar High Court, Peshawar (Subordinate Courts Staff) Recruitment Rules, 2003 is:

Nomenclature of post	Method of recruitment
Assistant/ Reader (BPS-16)	 Twenty five percent by initial recruitment; and Seventy five percent by promotion, on the basis of seniority-cum- fitness, from amongst holders of the posts of Senior Clerks at serial # 10 to 12 (all BPS-14) with at least three yeas service as such.

The Committee at the very outset considered the factum of calculation of quota by promotion and through direct recruitment of the vacant posts of Assistant (BPS-16). Total sanctioned strength in both the Establishments i.e. District & Sessions Judge & Senior Civil Judge (Admn), Lakki Marwat is 04, out of which 03 posts are to be filled through promotion and 01 post through direct recruitment/appointment. Total vacant posts of Assistant (BPS-16) at present are 03 while only one post is working under promotion quota and as per the calculation, it would be 03 posts under the promotion quota, so, 02 more posts will be filled through promotion for fulfilling the requisite quota under the promotion category as one post is already in promotion category.

Final Seniority List for the year 2022 of the Senior Clerks (BPS-14) of both the Establishments i.e District & Sessions Judge & Senior Civil Judge (Admn) Lakki Marwat is Annexure-"A"

After examining the service records of prospective officials from amongst holders of the posts of Senior Clerk (BPS-14) for promotion to the vacant posts of Assistant (BPS-16) and common Seniority List prepared for the purpose of promotion to the posts of Assistant (BPS-16), the senior most officials amongst the Senior Clerks (BPS-14) in the said seniority list for the year 2022 for the purpose of promotion to the posts of Assistant (BPS-16) were interviewed one by one and their academic/professional records were also examined and it was revealed that the officials as mentioned at serial No.01 & 02 in the common seniority list prepared for the purpose of promotion to the vacant post of Assistant (BPS-16), namely, Mr. Sami Ullah, Senior Clerk (BPS-14) and Mr. Muhammad Iqbal, Senior Clerk (BPS-14) had been dropped from promotion to the vacant post of Assistant (BPS-16) due to lack of requisite qualification for the post i.e. Bachelor Degree in the previous DPC meeting held on 19-12-2019 and the official namely, Mr. Said Ahmad, Senior Clerk (BPS-14) placed at serial No.03 in the seniority list was promoted to the said vacant post of Assistant (BPS-16) as he possessed Bachelor Degree. Mr. Sami Ullah, Senior Clerk (BPS-14) being aggrieved filed departmental appeal against the proceedings of said DPC vide bearing No.03/2020 before the Hon, ble Peshawar High Court, Peshawar which was dismissed on 13/09/2021 and then he filed Service Appeal bearing No.7508/2021 before the learned Khyber Pakhtunkhwa Service Tribunal, Peshawar for promotion to the post of Assistant (BPS-16) being deserving and eligible cum fit official . The learned Khyber Pakhtunkhwa Service Tribunal, Peshawar disposed of the said Service Appeal on 29-06-2022 with the following observations/decision.

In compliance with the order of the learned Khyber Pakhtunkhwa Service Tribunal, Peshawar passed on 29-06-2022 in the said Service Appeal No.7508/2021 titled "Sami Ullah Vs District & Sessions Judge, Lakki Marwat", Mr. Sami Ullah, Senior Clerk (BPS-14)) is promoted and considered as Assistant (BPS-16) w.c.f. 20-12-2019 with all back benefits.

Therefore, after examining the service records of prospective officials and considering their qualification as per requirement under the rules of Peshawar High Court, Peshawar (Subordinate Court Staff) Recruitment Rules-2003 for the purpose of promotion to

the vacant posts of Assistant (BPS-16), the Committee unanimously recommended the following two officials named below, in order of seniority, for promotion against the 02 vacant posts of Assistant (BPS-16) on the basis of seniority-cum-fitness with immediate effect.

PROMOTIONS TO THE 03 VACANT POSTS OF JUNIOR CLERK (BPS-11)

The criteria for the post of Junior Clerk (BPS-11) under the rules of Peshawar

High Court, Peshawar (Subordinate Court Staff) Recruitment Rules, 2003 is:

Nomenclature of post	Method of recruitment
	I. Not less than 70 percent by initial recruitment; and
Junior Clerk (BPS-11)	II. not more than 30 percent by promotion, from amongst the holders of the posts of Daftari and Record Lifter with Matric and three years' service as such: and in case no suitable candidate from amongst holders of the posts of Daftari and Record Lifter is available, then from amongst holders of the posts of Chowkidar, Naib Qasid, Sweeper, Chowkidar-cum-Mali, Mali and Water Carrier who have passed Secondary School Certificate Examination and have at least five years' service as such.

The Committee at the very outset considered the factum of calculation of quota by promotion and through direct recruitment of the vacant posts of Junior Clerk (BPS-11). Total sanctioned strength in both the Establishments i.e. District & Sessions Judge & Senior Civil Judge (Admn), Lakki Marwat is 41, out of which 12 posts are to be filled through promotion and 29 posts through the direct recruitment/appointment. After promotion to the posts of Senior Clerks (BPS-14), total number of vacant posts of Junior Clerk (BPS-11) becomes15 while the available working posts under the promotion quota is 09 and as per the calculation, it would be 12 posts under the promotion quota, so, 03 more posts will be filled through promotion to fulfill the requisite quota under the promotion category. Final common Seniority list of Daftari/ Record Lifter (BPS-05) for the purpose of promotion to the posts of Junior Clerk (BPS-11) of the Establishment of District & Sessions Judge, Lakki Marwat is Annexure-"C"

Final common Seniority List of other class-IV Staff i.e Naib Qasid, Chowkidar and Sweeper (BPS-03) for the purpose of promotion to the posts of Junior Clerk (BPS-11) when Daftari/ Record Lifter (BPS-05) is not available/ suitable, of both the Establishments i.e District & Sessions Judge and Senior Civil Judge (Admn) Lakki Marwat is Annexure. "D"

After examining the service records of prospective officials from amongst holders of the posts of Daftari/ Record Lifter (BPS-05) and other Class-IV employees for promotion to the posts of Junior Clerk (BPS-11) and after perusal of the common Seniority Lists prepared for the purpose of promotion to the posts of Junior Clerks (BPS-11) (annexures "C" & "D") the senior most officials/ holders of the posts of Daftari & Record Lifter (BPS-05) and other Class-IV staff in the seniority lists as stood on 30-04-2022 for the purpose of promotion to the posts of Junior Clerk (BPS-11), were interviewed one by one and their academic/professional records were also examined, objectively.

Considering the service record and qualifications of officials as per requirement under the Peshawar High Court, Peshawar (Subordinate Court Staff) Recruitment Rules-2003, the committee found that:

- The senior most official amongst the holders of Record lifter/ Daftari (BPS-05) named Mr.Imam Ahmad does not possess the requisite qualification so he lost entitlement for promotion to the required slot of Junior Clerk.
- The next official named Mr. Rizwan Ullah, Daftari (BPS-05) being junior official mentioned at Serial. no. 02 does not possess the requisite requirements i.e. lack of required service length of 03 years as he was promoted to the present post on 25-04-2022.

The committee, therefore, unanimously decided that name of official at Serial no. 01 be dropped where as the official at serial no. 02 is not eligible for promotion at this stage.

Thereafter, merits/ eligibility of officials next in the row amongst holders of the posts of Chowkidar, Naib Qasid & Sweeper etc were discussed. Although they have requisite qualification but the committee decided that their promotion could not be made due to the reason that by doing so the seniority/ right of Mr. Rizwan Ullah. Daftari (BPS-05), who was recently promoted to the present post of Daftari (BPS-05) on 25-04-2022, may be effected unjustifiably. Similarly in the same column of seniority Mr. Akbar Zaman, Sweeper (BPS-03) was found to be having no knowledge of typing. Therefore, the committee concluded that the promotions from the posts of Daftari, Chowkidar, Naib Qasid & Sweeper etc should be deferred and guidance in the matter for removal of anomaly in the seniority of officials should be sought from the Hon'ble Peshawar High Court, Peshawar after which the vacant posts of

Junior Clerk (BPS-11) under promotion quota will be filled in the next DPC to be conducted at proper time.

It is also worth noting that the office placed the application of Tariq Humayun, Naib Qasid (BPS-03), before the Departmental Promotion Committee as he submitted that he had passed Middle Standard Examination, which is the required qualification for promotion to the post of Daftari/Record Lifter, but in the seniority list he was mentioned as illiterate. He, though, had been acknowledging the provisional seniority list when ever it had been circulated.

On examination of common seniority list, it was revealed that the same needs to be prepared subject to proper verification in accordance with Hon'ble Peshawar High Court, Peshawar (Subordinate Courts Staff) Recruitment Rules-2003 notified vide notification No. J-39 dated 26-03-2003 and read with guide lines of Peshawar High Court, Peshawar circulated vide notification no. 2315/49/SDJ/Reg dated 29-04-2019.

The meeting ended with a vote of thanks to and from the Chair.
