SERVICE APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL, 1974 AGAINST THE INACTION OF THE RESPONDENTS BY NOT ALLOWING/GRANTING ANTI DATED PROMOTION TO THE APPELLANT TO THE POST OF SPST BPS-14 WITH EFFECT FROM 02/03/2013 AND SUBSEQUENT PROMOTION TO THE POST OF PSHT BPS-15 WITH EFFECT FROM 01/02/2018 WITH ALL BACK BENEFITS INCLUDING SENIORITY AND AGAINST THE INACTION OF THE RESPONDENTS BY NOT DECIDING THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF 90 DAYS.

Prayer:-

That on acceptance of the instant service appeal, the respondents may kindly be directed to consider the

appellant for anti-dated promotion to the post of SPST BPS-14 with effect from 02/03/2013 and subsequent promotion to the post of PSHT BPS-15 with effect from 01/02/2018 i.e. from the date when junior to the appellant have been promoted to the ibid posts of SPST & PSHT with all back benefits. Any other remedy which this august Tribunal deem fit may also be awarded in favour of the appellant

R/SHEWETH:

ON FACTS:

1. That the appellant was initially appointed against the post of PST BPS-07 now PST BPS-12 in the respondent department vide notification dated 08/10/2005. Copies of appointment order, service book and BA degree are attached as Annexure.....**A**
2. That during service junior to the appellant i.e. private respondents were promoted to the post of SPST BPS-14 vide notification dated 02/03/2013, ignoring the appellant, despite of the fact the appellant is senior to the private respondents. Copy of the promotion notification is attached as annexure.....**B**
3. That feeling aggrieved the appellant preferred departmental appeal to the respondent No 2 and in response the respondent No 2 promoted the appellant to the post of SPST BPS-14 vide notification dated 23/05/2015 with immediate effect. Copy of the notification is attached as annexure.....**C**
4. That subsequently the private respondents were promoted to PSHT vide notification dated 01/02/2018 once again ignoring the appellant from promotion to the post of PSHT. Copy of the notification is attached as annexure.....**D**
5. That feeling aggrieved, the appellant preferred department appeal and in response the appellant was promoted to the post of PSHT BPS-15 with immediate effect vide notification dated 14/09/2019. Copies of departmental appeal and promotion notification are attached as annexure.....**E & F**
6. That as per Rule 17 of the ATP Rules, 1989, the appellant is entitled for regaining her inter Se seniority, but unfortunately the respondents ignored the appellant from her due right. Feeling

aggrieved the appellant preferred departmental appeal, upon which an inquiry was conducted, but no fruitful result was obtained. Copies of department appeal and correspondence/inquiry report are attached as annexure.....G & H

7. That appellant having no efficacious remedy, filed the instant service appeal on the following grounds amongst the others:-

GROUND:

- A- That the action and inaction of the respondents by not allowing/granting Anti Dated Promotion to the appellant to the post of SPST BPS-14 with effect from 02/03/2013 and subsequent promotion to the post of PSHT BPS-15 with effect from 01/02/2018 including seniority and not deciding the departmental appeal of the appellant within the statutory period of 90 days is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondent department has acted arbitrary and malafidely by not considering the appellant for Anti Date Promotion from due date.
- D- That the treatment meted out to the appellant is clearly based on discrimination and malafide and as such the respondents violated the principle of natural justice.
- E- That respondents violated Article 38(e) of the Constitution of Islamic Republic of Pakistan 1973, according to which state is bound to eliminate disparity in the income and earning of individuals including persons in the services of the Federation, thus in light of the above quoted constitutional provision the respondents are duty bound to grant ante dated promotion/notional promotion to the post of promotion to the post of PSHT BPS-15.
- F- That according to Section 9 of the Civil servant Act, 1973 read with Rule 17 of the appointment, promotion and transfer Rules and

Notional promotion policy the appellant is fully entitled for the grant of ante dated promotion.

G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may very graciously be accepted as prayed for, please.



Subject: - DEPARTMENTAL APPEAL AGAINST THE INACTION OF THE DEPARTMENT BY NOT ALLOWING/GRANTING ANTI DATED PROMOTION TO THE APPELLANT TO THE POST OF SPST BPS-14 WITH EFFECT FROM 02/03/2013 AND SUBSEQUENT PROMOTION TO THE POST OF PSHT BPS-15 WITH EFFECT FROM 01/02/2018 WITH ALL BACK BENEFITS INCLUDING SENIORITY.

Respected Sir,

1. That the appellant was initially appointed against the post of PST BPS-07 now PST BPS-12 in the Education Department vide notification dated 08/10/2005.
2. That during service juniors to the appellant were promoted to the post of SPST BPS-14 vide notification dated 02/03/2013, ignoring the appellant, despite of the fact the appellant is senior to them.
3. That feeling aggrieved the appellant preferred departmental appeal to the respondent No 2 and in response the department/concerned authorities promoted the appellant to the post of SPST BPS-14 vide notification dated 23/05/2015 with immediate effect.
4. That subsequently the colleagues of the appellant were promoted to PSHT vide notification dated 01/02/2018 once again ignoring the appellant from promotion to the post of PSHT.
5. That feeling aggrieved, the appellant preferred department appeal and in response, the appellant was promoted to the post of PSHT BPS-15 with immediate effect vide notification dated 14/09/2019.
6. That as per Rule 17 of the ATP Rules, 1989, the appellant is entitled for regaining her inter Se seniority, but unfortunately the department ignored the appellant from her due right. Feeling aggrieved the appellant preferred departmental appeal, upon which an inquiry was conducted, but no fruitful result was obtained.
7. That the action and inaction of the department by not allowing/granting Anti Dated Promotion to the appellant to the post of SPST BPS-14 with effect from 02/03/2013 and subsequent promotion to the post of PSHT BPS-15 with effect from 01/02/2018 including seniority is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.

8. That appellant has not been treated by the Department in accordance with law and rules on the subject noted above and as such the department violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
9. That the department has acted arbitrary and malafidely by not considering the appellant for Anti Date Promotion from due date.
10. That the department also violated Article 38(e) of the Constitution of Islamic Republic of Pakistan 1973, according to which state is bound to eliminate disparity in the income and earning of individuals including persons in the services of the Federation, thus in light of the above quoted constitutional provision the department is duty bound to grant ante dated promotion/notional promotion to the post of promotion to the post of PSHT BPS-15.
11. That according to Section 9 of the Civil servant Act, 1973 read with Rule 17 of the appointment, promotion and transfer Rules and Notional promotion policy the appellant is fully entitled for the grant of ante dated promotion.

It is therefore, most humbly prayed that on acceptance of the departmental appeal, concerned authorities may kindly be directed to consider the appellant for Anti-Dated Promotion to the post of SPST BPS-14 with effect from 02/03/2013 and subsequent promotion to the post of PSHT BPS-15 with effect from 01/02/2018 i.e. from the date when junior to the appellant have been promoted to the ibid posts of SPST & PSHT with all back benefits.
