#### RESPECTFULLY SHEWETHI

### PRELIMINARY OBJECTION

- 1. That the Appellant has irrelevantly impleaded the Respondents No. 3 to 12, because of the matter, the inception of Service Rules and maintaining the Seniorities of the staff of Provincial cadre posts falls within the sepher object of Respondent-1 and Respondent-2 as co-opted member of the SSRC alongwith other officers from the Establishment, Finance and Law Department(s), which the appellant has not impleaded as necessary parties, hence the instant appeal is not entertainable.
- 2. That the appellant has not come to the Court with clean hands.
- 3. That the Appellant has got no cause of action to file the instant Appeal in the present form.
- 4. That the matter in question relates to subordinate legislation which cannot be adjudicated in this court.
- 5. That the instant Service Appeal filed on 24.02.2023 is badly time barred. The appellant as per his statement had filed Writ Petition No. 2872-P of 2022 in Peshawar Court on 18.07.2022 whereas amendment- in Appointment/Recruitment in C&W Department were notified on 26.01.2022, hence the Writ Petition in the Peshawar High Court was filed before the incompetent forum, even this Appeal is badly time barred by law and limitations.

#### ON FACTS

1. Incorrect, As per the papers at Page-17 with the instant Service Appeals, Appellant was given an offer of appointment as Work Supervisor (BPS-06) having DAE in Electrical Technology by the office of Executive Engineer Fata C&W Division FR Kohat/FR Peshawar somewhere in 21.03.2016 as Employer and the appellant joined post on 23.03.2016.

- Correct to the extent that prior to the substitution of rules against the post of Sub Engineers, under ENGINEERING SERVICES at Serial No. 5 as per column-5 of the Notification No. SOE/C&WD/8-12/2009 dated 25.03.2010, the following method of Recruitment were prevailing:
  - a. Seventy-five present (75%) by initial recruitment,
  - b. Five Percent (05%) by Promotion from amongst the Work Superintendent/Work Supervisor/Supervisor/Surveyors with 05-years Service as such having 03-Years DAE in Civil (Technology).
  - c. Five-percent (05%) by Promotion form amongst-Road Inspectors with 07-years Service as such, having 03-years DAE in Civil Technology.
  - d. Five-Percent (05%) by promotion from amongst the Work Superintendent/Work Supervisors and Road Inspector with 07 years service as such, having 03-years DAE in Electrical/Mechanical Technology.
  - Note: For the purpose of Promotion Joint Seniority list of Work Superintendent

    Supervisors and Road Inspector with reference to their regular

    appointment to the post shall be maintained, in case the two dates are

    similar, the official in BS-11 shall rank senior.
  - and by this way, the appellant, being one individual under sub clause(d) having 03-years DAE in Electrical Technology was appointed on Acting Charge basis as Sub Engineer in BPS-12 vide office order dated 30.04.2021 (Annexed-I).
- 3. Incorrect and baseless accumulation, Appellant stance "introduced fresh Tentative Seniority List by Respondent-9" is not worth consideration, Actually that is the Respondent-2 (Chief Engineer (Centre) to draw seniorities of the staff of Provincial cadre either tentative or Regular-ones. After substitution of Sub Rule-5(d) and bringing into one as 5(a) vide Notification No. SOE/C&WD.8-12/2022 dated 26.01.2022 (Annexed-II) all the 3-Sub Clauses i.e b, c & d of the earlier rules have been clubbed, brought to 15% in to including the post of Road Inspector despite carrying less Pay Scale viz BPS 06, and in sequence to the Note there under, the appellant thus stands at Serial No. 38. The Note is reproduced below;

For the purpose of promotion a joint senitoy list of the Work Superintendent, Work Supervisors, Supervisor, Surveyors and Road Inspectors with reference to their regular appointment to the post shall be maintained. The seniority shall be determined from the date of appointment or acquiring the Diploma in Civil, Electrical or Mechanical Technology from a recognized Board of Technical Education whichever is later.

Provided that in case the two dates are similar, the official in BPS-12 shall rank senior;

- 4. As described in para-2, above, the separately quotas 5%, 5%, 5% as under clause-b, c & d, at the then, isolated and independent seniorities were notified and the appellant as per the then 5(d) he was appearing at S.No-1 in that seniority of dated: 17.07.2020 (as Annexure-C at Page-18) and he was therefore was considered for appointment on Acting Charge as Sub Engineer in BPS-12, then such sub clauses i.e. b, c, & d were nor clubbed. After the amendment and clubbing all the sub cadres into one/sub cadre as 5(a) vide Notification No. SOE/C&WD/8-12/2022, dated: 26.01.2022 (already annex-II) the seniority was first notified tentatively thereafter regular vide letter No.52-E/907/CE/C&WD, dated: 25.07.2022 (Annexure-III) on the basis of Note as appended under the rules, notified on 26.01.2022 how he is falling at S.No.38 of the list. So far the question of filing Application for redressal of grievances, the Respondent vide letter dated 16.01.2023 which the appellant annexed at Page-31 with the Appeal, itself prove that the same was responded, hence no weight to say not replied.
- 5. Incorrect. As explained in above paras, the Appellant firstly went before the Peshawar High Court on 18.07.2022 in the Writ Petition No. 2872-P, whereas the application for Redressal of Grievances has been moved on 20.12.2022 through his immediate officer (Executive Engineer Building Division Kohat), which was properly replied on 16.01.2023, the Executive Engineer remarks are there, so he was fully aware of the position, the Appellant best tried to deceive the Court/Tribunal on this account.
- 6. Incorrect statement, the documents as annexed at page-31 with the instant Service Appeal i.e dated 16.01.2023 by itself prove that the Executive Engineer Building Division Kohat (through which office Application was processed) vide letter No. 108/M dated 20.12.2022 was endorsed the response/reply of Respondent-1, where the remarks of Executive Engineer to HC!

"to get it noted from the concerned official"

prove he was having full knowledge and he has annexed the same with the Appeal, the stance, kept the same secret from the Appellant is mis-conceiving and false, only to deceive the Tribunal.

7. Incorrect the earlier rules where 5%, 5%, 5% separate quota was allocated to each sub cadre/class has now been clubbed into 15%, specifying the common kind of qualifications, Civil/Electrical and Mechanical which in past was separate hence the case of Appellant to give him Regular Promotion as Sub Engineer is not covered in the present state of scenario.

8. Mis-conceiving, in this para-8 appellant says that "due to violation of fundamental rights guaranteed under the Constitution of Islamic Republic of Pakistan, 1973

hence filing the instant Writ Petition" is not understood. Surely this para is a copy paste of that para when he filed the Writ Petition before the Peshawar High Court (Writ Petition No. 2872-P of 2022) while the instant Appeal as before this Honourable Tribunal comes within the arbit of Service Appeal and not the Writ Petition. Here to further apprise, that after the substitution/amendments of rules, certain Road Inspectors have been promoted as Sub Engineers vide order No.177-E/178/CEC/C&WD dated 30.11.2022 (Annexed-IV).

#### **ON GROUNDS**

- a) Incorrect. As replied in facts.
- b) Incorrect. On the inception of amendments in the promotion rules, the Respondents are now duty bound to adhere to these rules.
- c) Not tenable, because on the amendments in rule the Petitioner and same others similarly placed persons shall be dealt with accordingly.
- d) The same as per reply (b) and (c) above.
- e) Incorrect, the same as above.
- f) As expressed in para (b) above, the Repondents are duty bound to follow the rules since amended.
- g) Incorrect, the representation made by the Appellant has been replied as stated in para-6, above.
- h) The respondents seek leave to raise additional grounds at the time of arguments.
- The relevant rules stand amended and attained finality as 10-officials of the rank of Road Inspectors (BPS-07) have been promotied to the posts of Sub Engineers (BPS-12) as expressed in para-8, above.

In the wake of above stated facts, the instant Appeal being devoid of merit may please be dismissed with cost against he Appellant. There some 3-others similarly placed Service Appeal No. <u>1513 of 2022</u> No. <u>1514 of 2022</u> and No. <u>1515 of 2022</u> are also pending adjudication before this Tribunal, which may also please be consolidated with this Appeal.

No.SCE/C&WD/8-12/2022: In pursuance of the provision contained in sub-rule (2) of rule 3 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, the Communication & Works Department, in consultation with the Establishment Department and Finance Department, hereby notify that in this Department's Notification No.SOE/C&WD/8-12/2009, dated March 25, 2010, the following further amendments shall be made, namely:


