

- 3. Learned counsel for the appellant argued that the impugned order is against the law and facts. Further argued that there is no charge of corruption against the appellant and it was for the first time the appellant was awarded departmental punishment vide impugned order. Further argued that in view of the allegations leveled against the appellant, the major penalty of removal from service is extremely harsh and excessive.
- 4. As against that learned Additional Advocate General contended that the appellant has shown no interest towards his duties and his attitude was unbecoming of a gentleman and the competent authority was at last constrained to conduct proper departmental action against the appellant and that the inquiry committee also found the appellant guilty of misconduct. Further argued that the appellant in his reply dated 25.11.2016 admitted that he remained late comer. Further argued that impugned order was issued after observing all codal formalities and legal requirements. Further argued that departmental appeal of the appellant against the impugned order was also rejected:
- 5. Arguments heard and file perused.
- 6. There is no dispute that the charge sheet/ statement of allegation was served upon the appellant and he also replied the same. The appellant joined the inquiry and the inquiry committee found the appellant guilty of charges. Show-cause notice was issued upon the appellant which he also responded. Learned counsel for the appellant could not demonstrate that findings of the inquiry committee against

the appellant are arbitrary or based on malafide. However, in view of the circumstances of the case, this Tribunal is of the considered opinion that the arguments of learned counsel for the appellant in relation to the harshness of the awarded punishment of removal from service, carries weight. Consequently, for the purpose of safe administration of justice, the impugned major penalty of removal from service is modified and converted into major penalty of reduction to lower stage in time scale for a period of five years. The intervening period shall be treated as leave without pay. The present appeal is disposed of in the above terms. Parties are left to bear their own costs. File be consigned to the record room.
