PRELIMINARY OBJECTION

- 1. That the appellant had no legal grievances nor wrongfully deprived as he did not come in the ambit of aggrieved person, furthermore, the appellant has no locus standee to file the appeal titled above.
- 2. That the appeal has been filed mere on mala fide intentions, furthermore the replier has been promoted in accordance with law, rules by the competent forum.
- 3. That bear reading of the appeal vividly shows that there is no cause of action accrues out of the contents of the appeal, so the same is not maintainable and be dismissed with cost.

FACTS

- 1. That in response to para no.1, the respondent no.3 was appointed as steno-typist vide appointment order no. 2464-72/dated Batkhela the 30.11.2005 and was reflected at serial No.1 of the office order above and the appellant (Murad Khan) without any objection accepted the terms and conditions of the their appointment order, so at this stage he have no right or entitlement to any back benefits of past in terms of seniority, hence he estopped by his conduct, the appointment order is available on page no.9 of the main appeal.
- 2. That para-2 is incorrect and further stated the seniority list issued by the competent authority upto December 2021 never been impugned by the appellant meaning thereby he accepted the same, so, at this belated stage the appellant cannot question the correctness/authenticity of the seniority lists, hence on this score too the appeal is not maintainable. (Copy of the seniority list are attached, wherein the appellant never raised any objection is attached may be considered integral part of this reply).

- 3. That in response to para no.3 the appellant never assailed the seniority li st before any competent forum which has got finality and the promotion has been made just on the strength of said seniority list, furthermore the respondent no.3 is M.Com degree holder and short hand course diploma while the appellant has deficient qualification, so rightly been dropped.
- 4. That in response to para no.4, the replier/respondent no.3 was promoted to the post of senior scale stenographer BPS-16 as per his entitlement and the same was not challenged before any next higher authority.
- 5. That in response to para no.5 the appellant remained in slumber, constantly signing the seniority list and never questioned the authenticity of the same, furthermore the promotion order dated 12.11.2022 has not challenged before the competent forum.

GROUNDS

A. That the contents as taken in ground A to H are incorrect and the appellant had not challenged

the vires of appointment order and the seniority list issued by the competent authority, so he accepted the terms and conditions of their appointment letter as well the contents of seniority list, so he could not at this later stage deviate from their own acceptance, so principle of estopple applied to his case, furthermore appellant who opted to change cadre not only be placed at bottom and the same cannot be counted toward their promotion.

It is, therefore, humbly prayed on acceptance of this reply, the appeal may kindly be dismissed with huge cost.




