PRAYER: -

<u>BY</u> **ACCEPTANCE OF** THE APPLICATION, THE ORDER/JUDGMENT 27-07-2023 OBTAINED <u>APPELLANT</u> (NOW RESPONDENT) MISREPRESENTATION & CONCEALMENT OF MATERIAL FACTS FROM THIS HONORABLE TRIBUNAL MAY VERY GRIEVOUSLY SET-ASIDE/RE-CALLED IN FAVOR OF THE APPLICANTS UNDER THE **ABOVE** PROVISION OF LAW & IN THE INTEREST OF JUSTICE.

Respectfully Sheweth:-

ON FACTS

- 1. That the Respondent has invoked the constitutional jurisdiction under Article -212 of the constitution of Islamic Republic of Pakistan, 1973 through filing Service Appeals No. 231-234/2022, whereby, the final seniority list of SIPs (BS-18), stood on 02-03-2021, has been impugned by the appellants with the contention that junior colleges/ the private Respondents have been made senior to the appellants & the same has been decided vide order dated 27-07-2023 by this Honorable Tribunal. (Copies of the order dated 27-07-2023 & Seniority list dated 02-03-2021 are Annx-A & B).
- 2. That it is pertinent to mention here that vide Notification bearing Endst No. SOG/S&L/1-69/06/Vol-1/DPE/LIB dated 13-11-2007, the provincial Government up graded the post of Director Physical Education (D.P.Es) now Instructor of Physical Education (IPs) from BS-16 to 17 on regular basis for the then existing incumbents who hold Master Degree in the relevant subject in E&SE Department, however, vide para-2 of the Notification ibid their existing seniority was ordered to be remained intact & the DPEs cadre was declared as dying cadre. In this regard para-02 of the Notification ibid is hereby reproduced as under for perusal & ready reference:
 - (2). "The Librarians & D.P. Es who hold the diploma in the relevant subject will stay in BS-16 till such time, they acquire Master Degree in the respective subject. On acquiring Master Degree in the relevant subject, their posts will be up graded on case-to-case basis from BS-16 to BS-17 (Regular) and promotion (from BS-16 to BS-17) would be given as per laid down procedure and in accordance with the service rules to be framed. However, their existing seniority will remain intact". (Copy of Notification dated 13-11-2007 is Annx-C)
- 3. That in compliance of Notification dated 13-11-2007, 115-Male and 37-Female DPEs, including the appellant were promoted from BS-16 to BS-17 vide Notification No. SO(PE)/2-6/E&SE/DPC/DPEs dated 19-05-2009. However, seniority of all the incumbents/DPEs were remained intact in pursuance of the

Notification dated 13-11-2007. (Copy of Notification dated 19-05-2009 is Annx-D).

- 4. That in compliance of the consolidated judgment dated 04-03-2010 of the Honorable Khyber Pakhtunkhwa Service Tribunal, Peshawar in Service Appeals No. 1667/2009 under case titled Ghulam Nabi VS Govt; & other (12) connected Appeals, the 14-appellants/DPEs were promoted from BPS-16 to 17 on regular basis w.e.f 13-11-2007 instead of 19-05-2009 vide Notification bearing Endst: No. SO(PE) 9-10/DPE/Ghulam Nabi dated 29-04-2014. Moreover, the same benefits have also been extended to other similarly placed 116-DPEs (including the present appellant) who acquired the prescribed qualification on or before 13-11-2007. (Copy of Notification dated 29-04-2014 is Annx-E).
- 5. That it is pertinent to mention here that the promotion Notification bearing Endst: No. SO(PE) 9-10/DPE/Ghulam Nabi dated 29-04-2014dated has been issued by the Department in continuation of the Notification bearing Endst: No. SO(PE)/2-6/E&SE/DPC/DPEs dated 19-05-2009 which was further based on the Notification dated 13-11-2007, wherein, the Seniority of the promoted DPEs was ordered to be remained intact, however, this fact has been concealed & mis-represented by the Respondent before this Honorable Tribunal & has thus got succeeded in obtaining the impugned order dated 27-07-2023 in her favor against the Rules & Criteria in vogue.
- 6. That in case of non-acceptance of the titled application by this Honorable Tribunal in spite of jurisdiction to entertain, it would open a flood gate for all the similarly placed Male & Female IPEs and resultantly would create huge litigation for the Department.
- 7. That the Respondent/appellant is not an aggrieved person within the meaning of Section-4 of Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article-212 of the constitution of 1973, hence, the order dated 27-07-2023, being the result of mis-representation on the part of the Respondent/appellant is liable to be re-called in favor of the applicants/Department in the interest of justice, hence the Respondent Department further submit on the following grounds inter alia:-

ON GROUNDS

A. *That* the appellant/Respondent has been treated as per law & rules in the final seniority list dated 02-03-2021 by the applicant/Respondent Department.

- **B.** *That* the act of the applicants/Respondent Department is within legal sphere and liable to be maintained in favor of the Respondents/Petitioners.
- C. That valuable legal rights are attached with the instants case of the Petitioners.
- **D.** *That* the instant application is within limitation & the Honorable Service Tribunal has failed to consider the facts & circumstances of the case prior to the announcement of the order dated 27-07-2023 of this Honorable Service Tribunal.
- **E.** That the appellant is habitual litigant against the Department for no cause of action accrued to her & this Honorable Service Tribunal did not consider the factual position of the case as mentioned above & has thus passed the impugned order dated 27-07-2021 without criteria against the applicants/Respondent Department which if implemented would amount to huge financial losses to the Government Treasury.
- **F.** That the appellant has been treated as per law by the Respondent Department. The act of Respondent Department is in accordance with the Constitution of the Islamic Republic of Pakistan, 1973 but the claim of the appellant was against the law, rule and policies of the Government.
- **G.** *That* the applicants/ Department has treated the Respondents/applicants appellants according to law, rule and policy. Hence the order dated 27-07-2022 is liable to be re-called.

PRAYER

It is therefore, humbly requested that on the acceptance of this application under Section 12 (2) CPC 1908, the order/judgment dated 27-07-2023 of this Honorable Tribunal in the titled appeal may kindly be set-aside in favor of the Applicants/E&SE Department in the interest of justice please.


