**APPEAL UNDER SECTION 4 OF THE KP
SERVICE TRIBUNAL ACT, 1974
IMPUGNING THEREIN THE ORDER DATED
07.08.2020 IN PURSUANCE OF
SENIORITY LIST ISSUED IN THE YEAR
2019; WHEREIN ENTRIES MADE IN FOAR
APPELLANT ARE DISCOURAGED BY
RECORD; CONTRARY TO THE LAW AND
JURISPRUDENCE**

Respectfully Sheweth,

1. That the Constitution of Islamic Republic of Pakistan aims at protecting civil servants in order to ensure smooth running of affairs of the Government and Institutions so as to benefit the public citizenry.
2. The Constitution of Islamic Republic of Pakistan equally beshields civil servants from being treated otherwise than in accordance with law.

In Sheikh Riaz-ul-Haq's Case¹, it was held that, "Admittedly, civil servants being citizens of Pakistan have fundamental rights including the right to access to justice as envisaged under Article 9 of the Constitution".

3. That the Constitution of Islamic Republic of Pakistan evenly emphasizes on equality for the citizens and by the citizens; aimed at underpinning rule of law.

ON FACTS

4. That the appellant was appointed as Patwari Halqa (BPS-07) in District Haripur, Khyber Pakhtunkhwa. **(Copy of the appointment order dated 18.03.2004 is annexed as Annexure "A").**
5. That the appellant was performing as Patwari Halqa to the best of his abilities, determination and perseverance; to the entire satisfaction of the competent authority from the date of inception with impeccable service record in the respondent Department.
6. That during the interregnum; Final Seniority List of the patwaris; stated to have been issued in the year 2007 in line with that of year 2006; wherein the appellant stood at serial No. 56. **(Copy of the Final Seniority List dated 28.06.2007 is annexed as Annexure "B")**
7. That given the seniority list; one Mr. Ihsanullah Patwari stands at serial No. 55, whereas Mr. Dilfaraz Khan at serial No. 57.
8. That to the utter most disregard; tentative seniority list stated to have been issued by the respondent in the year 2019; wherein the appellant was placed at serial No. 40; Mr. Amjad Shehzad is placed at serial No. 39; Azeem Ullah Khan

at serial No. 41; whereas Mr. Ihsan Ullah and Dil Faraz Khan at serial No. 25 and 27. **(Copy of the Seniority List is annexed as Annexure "C")**

9. That for the sake of brevity and information; the appellant had preferred a departmental appeal dated 23.06.2020, but instead of setting straight the objection raised; the respondent ordered filing of the application. **(Copy of the Departmental Appeal dated 23.06.2020 is annexed as Annexure "D")**

In Suo Moto Case No. 19 of 2016², it was held that,
"Good governance was not a favour to be bestowed on the people; it was their right".

10. That the appellant beseechs for intervention of this Hon'ble Court given the entries made in the Seniority list issued in the year 2019 and thereafter; inter-alia of the following grounds:-

GROUND

- A.** That the entries made in the seniority list insofar appellant; discountenanced by record, is contrary to law, well-settled jurisprudence in field and practice; since the very inception.
- B.** That the entries in the seniority list insofar appellant; are uncalled for, against the law governing the subject matter.
- C.** That the appellant was neither provided the relevant documents nor put on notice for the purposes of objecting over the seniority list at the relevant time.
- D.** That the competent authority has failed to take into consideration the relevant law on the subject matter.
- E.** That the respondent has overlooked the well-settled

principles, while affirming the seniority list; which cannot stand at all.

- F. That carte-blanche exercise of power; abdicates the well-entrenched principle of "structured discretion".
- G. That the purported omission(s) on the part of respondent; itself speaks volumes engraving danger to the notion of good governance, hence requires interference of the Hon'ble Court.

In Qaiser Iqbal's Case³, it was held that, "Rule of Law meant supremacy of law as opposed to arbitrary authority of the Government; said supremacy guaranteed three concepts; first, the absence of arbitrary power; second, equality before law and third the rights of a citizen".

- H. That it is cardinal principle of law and justice that what cannot be done directly cannot be done indirectly.⁴
- I. That public functionary had to reinforce good governance, observe rules strictly and adhere to rule of law in public service; public functionaries were not obliged to follow illegal orders of higher authorities⁵.
- J. That "Expressio Unis Est Exclusio Alterius", commanding that when law requires a thing to be done in particular manner then, it should be done in that manner as anything done in conflict of the command of law shall be unlawful being prohibited.

- K. That "*Ignorantia juris non excusat*", commanding that ignorance of the law excuses not.
- L. That further necessary grounds will be raised during the course of arguments.

PRAYER

It is therefore humbly prayed that on acceptance of this Service Appeal: -

1. The entries made in the seniority list in the year 2019 and thereafter insofar appellant may please be rectified along-with consequential benefits.
2. In alternative; the respondent may please be directed to decide the case of the appellant on merits instead of technical knockout vide order dated 07.08.2020; by taking into consideration the available record.
3. Any such order be passed which this Hon'ble Tribunal deems fit and appropriate as the circumstances may require for determination of the subject at hand.



In lieu of the above; it is therefore humbly prayed and submitted that the application seeking condonation of delay may please be allowed for securing the ends of justice.



As per Part-VI Rule 17 (1)(a) of the Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion & Rules, 1989 (Annexure-A), "the seniority inter se of civil servants (appointed to a service, cadre or post) shall be determined:- (a) in the case of persons appointed by initial recruitment in accordance with the order of merit assigned by the Commissioner [or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection;" The order of merit assigned by the Department Selection Committee was maintained in their appointment order. This merit was kept intact in the seniority list for the year 2012 issued vide this office Notification bearing No. 511-12/HC/DC(H) Dated 14.03.2013 (Annexure-C). Thereafter, the updated seniority list of Patwaris of District Haripur was issued in subsequent years regularly (Annexure-D) and the appellant has never objected to it. Most of the Patwaris mentioned in the Seniority list attached by the appellant with his service appeal either have been retired from service or promoted to the next higher scale. The claim of the appellant is not based on facts and it will adversely affected the precious legal rights of other Patwaris reflected in the current seniority list.

PROBATION AND CONFIRMATION

⁴⁷15. Probation. ----- (1) Persons appointed to posts by initial recruitment, promotion or transfer shall be on probation for a period of one year.

(2) The appointing authority, if considers necessary, may extend the probation period for one year as may be specified at the time of appointment.

⁴⁸(3) On the successful completion of probation period, the appointing authority shall, by specific order terminate the probation of the officer or official concerned within two months after the expiry of probation period prescribed in sub-rule(1):

Provided that if no specific order regarding termination of the probation period of the official or officer concerned is issued within two months, the period of probation shall be deemed to have been extended under sub-rule (2):

Provided further that if no specific order is issued on the expiry of the extended period of probation, the period of probation shall be deemed to have been successfully completed."

16. Confirmation:-After satisfactory completion of the probationary period, a civil servant shall be confirmed; provided that he holds a substantive post, provided further that a civil servant shall not be deemed to have satisfactorily completed his period of probation, if he has failed to pass an examination, test or course or has failed to complete successfully a training prescribed within the meaning of sub-section (3) of Section 6 of the ⁴⁹[Khyber Pakhtunkhwa] Civil Servants Act, 1973.



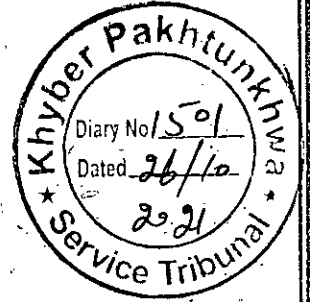

Preliminary Objections:

1. That the appellant has got no cause of action.
2. That the appellant has not come to this Honourable Tribunal with clean hands.
3. That the appeal is bad in its present form.
4. That the appellant is estopped by its own conduct.
5. That the petition is not maintainable for mis-joinder and non-joinder of necessary parties.
6. That the appellant has never preferred any departmental appeal before the competent authority.
7. That the instant service appeal is time barred.

The Para-wise comments in the above petition are submitted as under: -

ON FACTS

6. Incorrect as stated. His name was inserted at serial number 56 erroneously. As per amendment and new instructions of the Board of Revenue, Khyber Pakhtunkhwa 20 posts of Patwaris were advertised in the test inviting the application from Patwar Passed Candidate having domicile of District Haripur. All the Patwar Passed Candidate of that time submitted application. Their written test was conducted and 20 candidates with higher marks were selected and approved for appointment by the DSC. As per Part-VI Rule 17(1)(a) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 (Annexure-A), "the seniority inter se of civil servants (appointed to a service, cadre or post) shall be determined:- (a) in the case of persons appointed by

initial recruitment, in accordance with the order of merit assigned by the Commission [or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection;". The order of merit assigned by the Departmental Selection Committee was maintained in their appointment order issued vide No. 625-52/HC/DOR(H) Dated 18.03.2004 (**Annexure-B**). Since all the candidates were appointed on the same date, therefore, merit assigned by the DSC on the basis of written test was maintained in the appointment order. This merit was kept intact in the seniority list for the year 2012 issued vide this office Notification bearing No. 511-12/HC/DC(H) Dated 14.03.2013 (**Annexure-C**). Thereafter, the updated seniority list of Patwaris of District Haripur was issued in subsequent years regularly and the appellant has never objected to it. Most of the Patwaris mentioned in the Seniority list attached by the appellant with his service appeal either have been retired from service or promoted to the next higher scale. The claim of the appellant is not based on facts and it will adversely affect the precious legal rights of other Patwaris reflected in the current seniority list.

7. Not relating with the answering respondents.
8. Incorrect as stated. The detailed reply has been given in para-06 above.
9. Incorrect, hence denied. The Appellant's application was turned down due to the reason mentioned at overleaf of his objection (**Annexure-D**).
10. No comments.

GROUND: -

A to L. All the grounds from A to L are incorrect, hence denied. Detailed reply has been given in Para-06 above. The seniority list has been prepared in accordance with prevailing law.

Keeping in view the facts and circumstances of the case, the appeal of the appellant being not tenable may graciously be dismissed with cost in limine, please.

PROBATION AND CONFIRMATION

⁴⁷15. **Probation.** ----- (1) Persons appointed to posts by initial recruitment, promotion or transfer shall be on probation for a period of one year.

(2) The appointing authority, if considers necessary, may extend the probation period for one year as may be specified at the time of appointment.

⁴⁸(3) On the successful completion of probation period, the appointing authority shall, by specific order terminate the probation of the officer or official concerned within two months after the expiry of probation period prescribed in sub-rule(1):

Provided that if no specific order regarding termination of the probation period of the official or officer concerned is issued within two months, the period of probation shall be deemed to have been extended under sub-rule (2):

Provided further that if no specific order is issued on the expiry of the extended period of probation, the period of probation shall be deemed to have been successfully completed.”

16. **Confirmation:-**After satisfactory completion of the probationary period, a civil servant shall be confirmed; provided that he holds a substantive post, provided further that a civil servant shall not be deemed to have satisfactorily completed his period of probation, if he has failed to pass an examination, test or course or has failed to complete successfully a training prescribed within the meaning of sub-section (3) of Section 6 of the ⁴⁹[Khyber Pakhtunkhwa] Civil Servants Act, 1973.

PART-VI

SENIORITY

17. **Seniority :-**(1) the seniority inter se of civil servants ⁵⁰(appointed to a service, cadre or post) shall be determined:-

- (a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission ⁵¹[or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and
- (b) in the case of civil servants appointed otherwise, with reference to the date of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post,



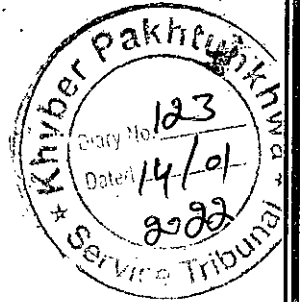
