

**SERVICE APPEAL UNDER SECTION 4 OF
SERVICE TRIBUNAL ACT 1974, FOR
DECLARATION TO THE EFFECT THAT ARREARS
OF GRADED PAY W.E.F 26-01-1986 TO THE DATE
OF RETIREMENT I.E. 23-06-2013, SELECTION
GRADE WHICH WAS DUE IN MAY 2001 AND
PROFORMA PROMOTION AS HEADMASTER
W.E.F 27/03/2010 HAS NOT BEEN GRANTED IN**

FAVOUR OF THE APPELLANT SO FAR WHICH IS DISCRIMINATORY AGAINST THE LAW AND RESPONDENTS ARE BOUND TO ALLOW THE BENEFITS MENTIONED ABOVE.

PRAYER; ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, RESPONDENTS MAY GRACIOUSLY TO BE DIRECTED TO MAKE PAYMENTS OF ARREARS OF GRADED PAY W.E.F 26/01/1986 TO THE DATE OF RETIREMENT I.E. 23/06/2013, WITH FURTHER DIRECTION TO THE RESPONDENTS TO GRANT SELECTION GRADE IN BPS-17 W.E.F MAY 2001 AND PROFORMA PROMOTION AS HEADMASTER FROM 27/03/2010 MAY ALSO BE GRANTED. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEM APPROPRIATE IN THE CIRCUMSTANCES MAY ALSO BE GRANTED TO THE APPELLANT.

Respectfully Sheweth;-

That Facts forming the background of instant service appeal are arrayed as under;-

1. That the appellatant was appointed in education department on PST on 13-10-1974 and was retired

from service on 23/06/2013. Copies of appointment order as well as retirement order of appellant are attached as Annexure "A" & "B".

2. That the appellant served the department with complete devotion and dedication and left no stone unturned in the smooth functioning of the department.
3. That the appellant was given charge of post of S.S.T on 26/01/1986 to 23/12/1987, thereafter, the appellant was regularly promoted S.S.T on 26/01/1986. In this regard, copy of office order dated 31/12/2018 is attached as Annexure "C".
4. That the appellant as per order dated 31/12/2018 granted graded pay w.e.f 26/01/1986 to 22/12/1987 as per office order dated 31/12/2018. But arrears of graded pay w.e.f 23/12/1987 to the date of retirement of appellant has not been granted.
5. That as per law, thirty three percent employees were eligible for selection grade to next higher grade. Therefore, selection grade of appellant was due w.e.f May 2001 but the same has not been

granted to the appellant. In this regard, juniors to the appellant were granted selection grade on April 2001. Hence, the appellant has been discriminated, which is not maintainable at law. Copy of employees juniors to the appellant who had been granted selection grade is attached as Annexure "D".

6. That it is further submitted that the promotion to the post of headmaster, was due to the appellant w.e.f 27/03/2010. Respondents' department promoted juniors, headmasters vide promotion order dated 27/03/2010. Copy of promotion order of headmasters who are juniors of the appellant are attached as Annexure "E".

7. That the appellant filed appeal to the competent appellate authority which was rejected on 07/01/2022 which was received by appellant on 03/02/2022. Copy of appeal as well as rejection order dated 07/01/2022 is attached as Annexure "F".

8. That the appellant filed service appeal No. 1110/2022 before the Honourable Tribunal. Copy

of service appeal No. 1110/2022 is attached as Annexure "G".

9. That office of the tribunal raised objection on the appeal and the appellant was directed to submit the appeal duly rectified within a period of 15 days but the appellant submitted appeal No. 1110/2022 after lapse of 120 days. Therefore, the appeal of the appellant was disposed off by the Honourable Tribunal vide order dated 19/07/2022. Copy of the order dated 19/07/2022 of the appellant is attached as Annexure "H".

Hence the instant appeal filed inter-alia on the following grounds:-

GROUND:

- a) That the appellant has been discriminated by respondents' department and the benefits which were admissible to appellant has not been granted to him so far. The respondents' department is supposed to grant the arrears of graded pay w.e.f 26/01/1986 to 23/06/2013. Similarly, selection grade as

well as proforma promotion to post of headmaster was also not granted to the appellant.

- b) That, when law prescribe a thing which is to be done in a particular manner that must be done in that manner and not otherwise. Hence, respondent departments' was supposed to follow Rules Regulations and whatever was due and admissible to the appellant was to be granted on his turn.
- c) That respondents' department has led the appellant to the place which is utterly unknown to the principle of natural justice, good governance and fair play.
- d) That the matter relates to the terms and conditions of service, therefore, this Honourable tribunal has jurisdiction to entertain the instant service appeal under Article 212 of the Constitution. Besides, the matter in issue in the instant appeal relates to the financial matter. Therefore, the appeal is not time barred.

e) That other points shall be urged at the time of arguments.


PRAYER:

On acceptance of the instant service appeal, respondents' may graciously to be directed to make payments of arrears of graded pay w.e.f 26/01/1986 to the date of retirement of the appellant i.e. 23/06/2013, with further direction to the respondents' to grant selection grade in BPS-17 w.e.f May 2001 and proforma promotion as headmaster from 27/03/2010 may also be granted. Any other relief which this Honourable Tribunal deem appropriate may also be granted to the appellant.
