(Copy of seniority list is attached as annexure A).
5. That feeling aggrieved from the said order, the appellant preferred a departmental appeal to respondent No. 4 for considering the appellant for the promotion and seniority should be considered as per rules. (Copy of departmental appeal is attached as annexure B).
6. That the Govt. of K.P.K. education department Rules are crystal clear, in which there is no rule that the senior be ignore. (Copy is attached as annexure C).
7. That being aggrieved from the impugned order, the appellant filed the instant appeal on the following grounds inter alia. (Copy of impugned order is attached as annexure D).

GROUND:-

- a. That the impugned seniority list is illegal, against the law and void ab-initio.

- d. That the impugned seniority list is illegal, favourable, based on political influence.

PRELIMINARY OBJECTIONS:

- 1- That the appellant has no locus standi/no cause of action to file the instant appeal against the respondents.
- 2- That the appellant has not come field his Departmental Appeal to Appellate Authority within the statutory period.
- 3- That the appellant has concealed the material facts from this Honorable Tribunal, Hence liable to be dismissed.
- 4- That the appellant has filed the instant appeal just to pressurize the respondents.
- 6- That the present appeal is liable to be dismissed for Non-joinder/ Misjoinder of necessary parties.
- 7- That the appellant has filed the instant appeal on malafide motives.

- 8- That the instant appeal is against the prevailing law, rules, and policies.
- 9- That the appellant is estopped by his own conduct to file the instant appeal.
- 10- That the instant appeal is not maintainable in the present form.
- 11- **That the instant service appeal is time- barred.**

Factual Objections:

1- That para no 1 is related to the service record of the appellant. Hence needs no comments.

2- That the Para No 2 is correct to the extent that the appellant is PST

At GPS Qambar Swat.

3- That para no 3 is related to the Professional Qualification of the appellant. Hence needs no comments.

4- That the Para No 4 as drafted is denied. In Seniority list, the Appellant seniority No is 1334 **but the appellant was Matric at that time** because the appellant did not submit his verified intermediate certificate & DMC during the DPC, that the Appellant promotion was deferred because the appellant file was incomplete due to non-availability of verified intermediate certificate during the DPC & promotion order dated 26/02/2013.

(Seniority List and Promotion order are is appended as Annex "A and B")

That the Para No is incorrect and denied the Respondent have not ignored the rules & they have considered the Seniority –cum-Fitness rules during promotion. **The appellant did not fulfill the criteria for promotion, therefore the case has been deferred as**

"Clarified in para no 4."

5-That the appellant is not aggrieved because the promotion order dated 26/02/2013 is based on Rules. Hence, it is legal, lawful & justified. That the appellant preferred departmental appeal on 1/2/2014 against the order dated 26/02/2012 which was time barred. Therefore the same was not responded by the respondents.

6-That the appellant is not aggrieved because the promotion order dated 26/02/2013 is based on Rules. Hence, it is legal lawful & Justified.

7-That the respondents have not violated the rules rather acted upon the rules. All the facts have already been clarified in Para No 4&5.


E-That the respondents may also seek permission to raise additional grounds and proofs at the time of arguments.



REJOINDER ON BEHALF OF PETITIONER / *Appellant*

Respectfully Sheweth:

ON PRELIMINARY OBJECTIONS:

1. The petitioner / *Appellant* has got locus standi as well as cause of action to file the above mentioned service appeal.
2. Mis conceived and misleading objections have been raised for the sake of more objections only. The

objections are nothing but callus attempt to side track the main issue whereby petitioner ^{/Appellant} despite most eligible and desirable candidate was intentionally ignored for the promotion from BPS 12 to BPS 14. The unfair, discriminatory and mala fide conduct is even established from the record by the respondents with their comments where in the intentionally concealed some material facts from the concentration of this Hon'ble Court.

3. That the appellant has no other relief / remedy against the respondents to get his legal rights from the respondents.

ON FACTS:

1. That paras No.1 to 3 admitted by the respondents.
2. That para No.4 of the comments is incorrect, hence denied because in the time of submitting DPC the appellant-fulfil all the required documents and

academic documents. The appellant submitted his verified intermediate certificate and DMC during the DPC. In this regard on dated 10/08/2012 entering in the service of the appellant and verified letter also issued from the concerned authorities.

3. That para No.5 of the comments is incorrect, hence denied. Appellant fulfilling all the requirement and respondents have intentionally ignored the rules, regulation, law and Sharia. If respondents promote the appellant in time or on 26/02/2013 then the appellant had been on BPS-15. Therefore respondents are doing irregularity intentionally and promote the appellant on June 2015 and transfer the appellant for away area which is against law, fact and Sharia. Although vacant post is lying in the same school. The appellant is most senior but respondents are ignoring all the facts.
4. That para No.6 of the comments is incorrect, hence denied while appellant accepted BPS -14 as a protest.
5. That para No.7 of the comments is incorrect, hence denied while the detail answer is given in above paras.

GRUNDS:

- A. That Para No. A of the comments on ground are incorrect, the respondent did not follow the rules, regulation and seniority for the promotion.
- B. That Para No. B of the comments on grounds are incorrect, in the time of submitting DPC the appellant fulfil all the required documents and academic documents. The appellant submitted his verified intermediate certificate and DMC during the DPC.
- C. That Para No. C of the comments on ground is admitted.
- D. That Para No. D of the comments on ground is incorrect while detail answer is given above paras.
- E. That Para No. E of the comments on ground is incorrect while detail answer is given above paras.
- F. That Para No. F of the comments on grounds is incorrect; the impugned order dated 26/02/2012 is against law, fact and shareia and violated the fundamental rights of the appellant, hence liable to be dismissed.

It is, therefore, most humbly prayed that on acceptance of this rejoinder this Hon'ble court may graciously be accept the instant service appeal as prayed for.
