PRAYER:

That on acceptance of this appeal the respondents may kindly be directed to allow/grant pro forma promotion to appellant to the rank of HC from the date of officiating promotion i.e. 08/08/1998 and be further allowed pro forma promotion to the rank of ASI from due date and may further be granted pro forma promotion to the next rank of SI from due date.

R/SHEWETH: ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- 1- That appellant was the employee of the respondent Department and had served the respondent department as Assistant Sub Inspector for quite considerable period efficiently and up to the entire satisfaction of his superiors.
- 2- That appellant was initially recruited in respondents department as constable vide order dated 1/6/1977 and was later promoted to the post of officiating head constable vide order dated 08/08/2020 and was confirmed as HC vide order dated 18/05/2010 w.e.f 6/5/2010. Copies of service book and confirmation order are attached as annexure.

- **3-** That it is pertinent to mention that lastly the appellant was promoted to the post of ASI vide order dated 31/3/2016.

- **6-** That appellant feeling aggrieved preferred Departmental appeal before the appellate authority for pro-forma promotion but no reply has been received so far. Copy of the Departmental appeal is attached as annexure.....
- 7- That appellant feeling aggrieved and having no other remedy but to file the instant service appeal on the following grounds amongst the others.

GROUNDS:

- A- That the inaction of the respondents by not granting pro forma promotion to the appellant to the post of HC and ASI from the due date, and further not promoting the appellant to the post of officiating SI despite availability of vacancies is against law, facts and norms of natural justice.
- B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondents malafidly did not promote the appellant to the post of officiating SI and when the appellant retired from service juniors were promoted to the post of officiating SI.
- D- That the respondents discriminated the appellant on the subject by not promoting the appellant to the post of officiating SI despite the fact that vacancies were available.
- E- That the respondents acted in arbitrary and malafide intentions by not promoting the appellant from due date to the post of HC and ASI and finally when he was not promoted to the post of officiating SI and juniors were promoted when he retired from service.

- F- That the respondents violated Article 38(e) of the Constitution of Pakistan, 1973 by not promoting the appellant to the rank of HC and ASI from the due date and finally when he was not promoted to the post of officiating sub inspector despite availability of vacancies.
- G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

PRELIMINARY OBJECTIONS: -

- a) The appeal is not based on facts.
- b) That the appeal is not maintainable in the present form.
- c) The appeal is bad for non-joiner and miss- Joinder of necessary parities.
- d) That the appellant is estoped by his own conduct to file the appeal.
- e) That the appellant has not come to the service Tribunal with clean hands.
- f) That the appal is barred by law in limitation.

FACTS:-

- 1. Correct to the extent that the appellant was employee of Respondent Department, but during employment, his performance was not up to marks. (List of bed entries annexed as Annexure A")
- Correct to the extent that the appellant was recruited as constable in 01.06.1977 and appellant was
 promoted as officiating Head Constable on 08.08.1998 and confirmed as Head Constable on
 18.05.2010 (copy attached as Annexure B-C)
- 3. Correct to the extent that the appellant was promoted into the rank Officiating Assistant Sub-Inspector on 31.03.2016 and confirmed as ASI on 09.04.2018(copy attached as Annexure D-E)
- 4. Pertains to the service record of the appellant.
- 5. Incorrect the appellant was eligible for promotion to the rank of Sub-Inspector, because the appellant did not complete mandatory period required for promotion to the next rank as per Police Act, 2017. (copy attached as Annexure F)
- 6. Incorrect, appellant submitted no such application for pro-forma promotion to department.
- 7. The appellant has no cause of action and wrongly filed appeal after his retirement through unsound grounds.

GROUNDS.

- A. Incorrect, the plea of the appellant is misleading and mis conceived. Promotion to the next rank is made subject to availability of vacancies and seniority cum-fitness by the Departmental Promotion Committee under rules/law.
- **B.** Incorrect, the appellant has been treated in accordance with law and rules. No right of the appellant has been violated by the respondent department.
- C. Incorrect, as explained in the above Para his mandatory period was not completed and no officials have been promoted against the law/rules.

- **D.** Incorrect, the appellant has not been discriminated in any way, only those officials were promoted to the next ranks who fulfilled the requisite criteria for the promotion as per law/rules.

- G. The respondent may be allowed to raise other grounds at the time of hearing.

In view of the above, it is humbly prayed that the appeal being barred by law and devoid of Merit may kindly be dismissed with costs.



No.755/Legal.-In exercise of the powers conferred by section 140 of the Khyber Pakhtunkhwa Police Act, 2017 (Khyber Pakhtunkhwa Act No. II of 2017), the Provincial Police Officer, with the approval of Government, is pleased to direct that in the Police Rules, 1934, the following further amendments shall be made, namely:

AMENDMENTS

- 1. In rule 12.1, after sub-rule (4), the following new sub-rules shall be added, namely:
 - "(5) No official of police establishment shall be allowed to change the cadre in which he was initially appointed.
 - (6) The official appointed on contract shall not perform duty in any other Unit except in the Unit for which his services are hired. The period of contract shall be for one year and may be renewed upon satisfactory performance report.".
- 2. For rule 12.4, the following shall be substituted, namely:
 - "12.4. Recruitment in Traffic Warden Service.—(1)Direct recruitment in the Traffic Warden Service shall be in rank of Constable and Assistant Sub-Inspector in the same manner as provided for initial recruitment of Constable and Assistant Sub-Inspector in the general cadre.
 - (2) On appointment, the Constable and Assistant Sub-Inspector in addition to the basic recruit and probation courses, shall undergo mandatory Elite Course and Specialized Traffic Training Courses as determined by Provincial Police Officer.
 - (3) The ratio of Fast Track Promotion in the Traffic Warden Service, in the ranks of Assistant Sub-Inspector, Sub-Inspector and Inspector, shall be same as provided for Assistant Sub-Inspectors, Sub-Inspectors and Inspectors under the Khyber Pakhtunkhwa Police Act, 2017.
 - (4) The Constable and Assistant Sub-Inspector shall be promoted on seats allocated for them in their respective districts and regions. The promotion within the Traffic Wardens shall be upto the rank of Inspector subject to completion of requisite promotional and capacity building courses as determined by Provincial Police Officer.
 - (5) An Inspector of Police Warden Service shall be eligible for promotion as Deputy Superintendent of Police against general posts of Deputy Superintendents of Police, if he successfully completes the requisite courses including Advance Course provided under these rules and also qualifies specialized courses of minimum two (02) weeks each in the Police School of Intelligence, Police School of Investigation, Police School of Tactics and Police School of Public Disorder and Riot Management besides (04) weeks general policing orientation course and (08) weeks field attachment with Sub-Divisional Police Officer office and Police Stations. Deputy Superintendent of Police so promoted shall be eligible to be posted anywhere on any assignment.

- (a) the Provincial Police Officer, may give relaxation in height and chest to minimum extent of 2 inches and 11/2 inches, respectively; and
 - (b) running shall be as follows:
 - i. Male candidates 1 Km in seven minutes
 - ii. Female candidates 1 Km in eight minutes
- (ii) the syllabus for examination for initial recruitment of Constable Canine shall be provided to the approved testing agency with the approval of Provincial Police Officer;
- (iii) the procedure for the selection of Assistant Sub-Inspector Canine and Constables Canine, except as provided under this Appendix shall be same as provided for the selection of Assistant Sub-Inspector and Constables in the general cadre;
- (iv) the Canine courses required for promotion under this Appendix, shall be approved by the Provincial Police Officerand
- (v) the promotion under this Appendix shall be made by a Departmental Promotion Committee which shall consist of such numbers of members as the Provincial Police Officer may determine.


