



### ORDER.

This order will dispose of the departmental appeal preferred by Inspector Matak Taj who was awarded the major punishment of "Time scale for two years" under PR-1975 by SSP/Inv: Peshawar vide OB No. 171, dated 27.11,2020.

- 2- Short facts leading to the instant appeal are that the appellant while posted at investigation wing proceeded against departmentally on the charges that he being investigation officer, kept pending various case files without any cogent reason.
- 3- He was issued proper Charge Sheet and Summary of Allegations by SSP/Investigation. DSP/Inv: Canit: Peshawar was appointed as enquiry officer to scrutinize the conduct of the accused official. The enquiry officer after conducting proper enquiry submitted his findings and recommended the official for major punishment. The competent authority in light of the findings of the enquiry officer issued him Final Show Cause Notice, to which he replied but the same was found unsatisfactory, hence was awarded the above major punishment.
- He was heard in person in O.R and the relevant record along with his explanation perused. A fresh report regarding current pendency on the part of appellant was also obtained from SSP-Inv: Peshawar. According to the report of SSP-Inv: Peshawar five eases are still pending with him from 2015. During personal hearing the appellant also failed to submit any plausible explanation in his defence. Therefore, his appeal for setting aside the punishment awarded to him by SSP-Inv: Peshawar vide OB No. 171, dated 27.10.2020 is hereby rejected/filed, being also time barred.

### PRELIMINARY OBJECTIONS:-

- 1. That the appeal is badly barred by law & limitation.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- 3. That the appellant has not come to Hon'ble Tribunal with clean hands.
- 4. That the appellant has no cause of action and locus standi to file instant appeal.
- 5. That the appellant is estopped by his own conduct to file the instant appeal.
- 6. That the appellant has concealed the material facts from Hon'ble Tribunal.
- 7. That the appeal is not maintainable being devoid of any merit.

### **REPLY ON FACTS:-**

- 1. Para pertains to record.
- 2. Incorrect. In fact the appellant was issued charge sheet with statement of allegations and initiated departmental enquiry against him as he kept pending various under investigation cases without any cogent reason. The enquiry officer after conducting enquiry proceedings under KP Police Rules 1975 (amended 2014) recommended him Major punishment hence issued final show cause notice to which he replied and was awarded major punishment of time scale for two years. (Copy of charge sheet, statement of allegations, enquiry report, Final Show Cause Notice are annexure as A,B,C,D).
- 3. Incorrect. After completion of the enquiry proceedings, he was issued final show cause notice to which he replied but his explanation was found unsatisfactory hence the allegations stand proved.
- 4. Incorrect. The competent authority before imposing the punishment had completed all codal formalities and sufficient opportunity of defence was provided to him however he failed to defend, hence was awarded Major punishment of time scale for the period of two years.
- 5. Incorrect. The appellant filed departmental appeal against the penalty to the appellate authority but failed to defend himself with plausible/justifiable grounds, hence his appeal was rejected on merit however the appeal was also time barred as per law of limitation.

6. That appeal of the appellant being devoid of merit and limitation may be dismissed on the following grounds.

### **REPLY ON GROUNDS:**

- A. Incorrect. The appellant was treated as per law/rules and no violation of the Constitution of Pakistan 1973 has been done by the respondent department.
- B. Incorrect. The appellant availed the opportunity of defense and was also called person to explain his innocence but failed.
- C. Incorrect. Proper departmental enquiry as per prevailing Rules ibid was conducted against him however failed to rebut the charges as he was found guilty committing misconduct within the meaning of Rules ibid.
- D. Incorrect. The allegations were proved against the appellant hence was reprimanded as per law/rules.
- E. Incorrect. After fulfilling of all codal formalities, he was awarded Major punishment of time scale for a period of two years by the competent authority.
- F. Incorrect. Proper departmental enquiry was conducted wherein the allegations leveled against him got proved against him.
- G. Incorrect. The punishment awarded by the competent authority is as per KP Police Rules 1975 (amended 2014).
- H. That respondent may also be allowed to advance any additional ground at the time of hearing of the appeal.

### PRAYER.

It is therefore most humbly prayed that in light of above facts and submissions, the appeal of the appellant being devoid of merit and legal footing, may kindly be dismissed with costs please.

Keeping in view of the facts/circumstances, I came to the conclusion that the delinquent official is not taking any interest to pursue the process of the enquiry and did not make his defense, therefore I am of the opinion that if approved, after full filling of legal formalities, he may be awarded major punishment.

### **FINAL SHOW CAUSE NOTICE**

### (UNDER RULES 5(3) KHYBER PAKHTUNKHWA, POLICE RULES, 1975)

1. That you SI Malik Taj the then I.O PS Pishtakhara have rendered yourself liable to be proceeded under Rule 5(3) of the Khyber Pakhtunkhwa, Police Rules for following misconduct:-
