Para is incorrect that the aforementioned school was not functional and Mr. Rasheed Muhammad was transferred with a task to make it functional and enroll students but he failed badly. Whereas in the new academic session 2023-24, only two new students were enrolled in four months, and their enrollment drives lacked passion and hence was not successful, Whereas Deputy District Education officer (Male) Mansehra made "surprise" visit to GPS Mandihar Mansehra on 29-04-2023 at 8:00 AM, he found that the school was closed and thus he called Mr. Syed Anwar Shah SDEO (M) Mansehra and ASDEO concerned therein. Whereas Deputy DEO checked the Attendance Register and marked the concerned teacher absent and took the Attendance Register in his custody. After being called, Rasheed Muhammad PSHT GPS Mundihar arrived at 8:30 AM, and the appellant tried to snatch the Attendance Register from Dy: DEO and also used abusive language. As far as school attendance was concerned, students were found absent and only four students were enrolled according to the school records. In Log Book, he was directed to appear personally the next day and was show caused but he did not appear. He was transferred to GPS Bela Sacha (Hangrai) vide Notification No 3914-19 on 29-04-2023, but he did not obey the Order and filed an appeal to the Director E&SE Department Peshawar which is still pending before Respondent No.02.whereas after transfer order of the appellant Mr, Attiq ur rehman was adjusted at GPS Mandihar with a task to make it functional and enroll students, Whereafter the student enrollment increase day by day with the collaboration of community as per report of SDEO Circle enrollment was 22 and present student were 17 on 18-05-2023. Whereas the allegation of willful absence from duty, misbehavior the abused/immoral language used against the Deputy DEO (Male) Mansehra, the competent authority nominated the inquiry committee on 14-06-2023, the inquiry committee submitted report on 09-09-2023 with the recommendation that "the concerned teacher is penalized under E&D Rule 2011 under 4 sub-Rule 1(a) "Forfeiture of two annual increments" An Affidavit from accused may be obtained for non-involvement in such Misbehavior/Misconduct/ill-disciplined activities, a Final warning of Removal from service may be issued and the transfer order issued is legal as per Rule"





Moreover, he confessed that he had misbehaved with the Deputy DEO (M) Mansehra but unintentionally as he did not know the Dy: DEO (M) Mansehra personally so he thought someone else had come to school in disguise. While the concerned teacher in response to undersigned questionnaire through ASDEO (M) Haneef Khan Circle Mansehra on 01-09-2023 refused the aforementioned allegations. He also said that he did not disobey the Transfer Order but he filed an appeal to the Director E &SED. (Annexure D) Statement of the Dy: DEO (M) Mansehra Dy: DEO (M) Mansehra in his statement said that when he had visited GPS Mundihar on 29-04-2023, the concerned teacher Muhammad Rasheed was not present in the school and he arrived at 9 AM. Furthermore, he tried to snatch the Attendance Register from Dy: DEO and also used abusive language. As far as school attendance was concerned, students were found absent and only four students were

- tv- After being called, Rasheed Muhammad PSHT GPS Mundliker surrived at 8,30 AM
- v- He then tried to snatch the Attendance Register and had a land talk and misbehaved with Deputy District Education Officer (M) Manzehra.
- vi- On 02-05-2023, ASDEO (M) paid a visit to GPS Mund'har and he mentioned on the Log Book that not a single student was consilled from September 2022 to April 2023. While in documents only 09 students were enrolled.
- vii-The aforementioned school was not functional and Mr. Ras band Muhammad was transferred with a task to make it functional and enroll students but he failed badly

On the basis of above facts findings and perusal of the available recommended that:

- 1 The concerned teacher is penalized under E & D Rule, 2011 to 4 sub-Rule 1(a) "Forfeiture of two annual increments".
- 2. An Affidavit from accused may be obtained for a partial in such Misbehavior/Misconduct/ill-disciples desired
- 3. A Final warning of Removal from service may be hard
- 4. The concerned teacher is transferred from GPS Months.

Facts/ Findings	 i- Dy: DEO (M) Mansehra Mr. Mahroof Khan paid a surprise visit to GPS Mundihar on 29-04-2023 at 8:00 AM. (Annexure F) ii- He found the school closed and thus he called Mr. Syed Anwar Shah SDEO (M) Mansehra and ASDEO concerned. (Annexure G) iii- Deputy District Education Officer checked the Attendance Register and marked the concerned teacher absent and took the Attendance Register in his custody. iv- After being called, Rasheed Muhammad PSHT GPS Mundihar arrived at 8:30 AM. v- He then tried to snatch the Attendance Register and had a hard talk and misbehaved with Deputy District Education Officer (M) Mansehra. vi- On 02-05-2023, ASDEO (M) paid a visit to GPS Mundihar and he mentioned on the Log Book that not a single student was enrolled from September 2022 to April 2023. While in documents only 09 students were enrolled. vii- The aforementioned school was not functional and Mr. Rasheed Muhammad was transferred with a task to make it functional and enroll students but he failed badly. viii- In the new academic session 2023-24, only two new students were enrolled in four months, and their Enrolment drives lacked passion and hence, have not been successful. ix- The concerned teacher was transferred to GPS Bela Sacha (Hangrai) vide Notification No 3914-19 on 29-04-2023. x- He did not compliance with the Transfer Order and filed an appeal to the Director E&SE Department Peshawar.
	xi- The concerned teacher has not even cooperated with the Inquiry Committee. he was given the questionnaire on 17-07-2023 and he provided the answer to questionnaire on September 01, 2023.
Recommendations	On the basis of above facts findings and perusal of the available record, the Inquiry Committee recommended that: 1. The concerned teacher is penalized under E & D Rule, 2011 under 4 sub-Rule 1(a) "Forfeiture of two annual increments". 2. An Affidavit from accused may be obtained for non-involvement in such Misbehavior/Misconduct/ill-disciplined activities. 3. A Final warning of Removal from service may be issued. 4. The concerned teacher is transferred from GPS Mandihar to GPS Bela Sachan is legal and as per rule.
