

**APPEAL UNDER SECTION 4 OF N.W.F.P/K.P.K SERVICES TRIBUNAL ACT 1974 AGAINST THE IMPUGNED ORDER OF TRANSFER OF APPELLANT BEARING ENDMT NO. 11662-67/PROMOTION PSHT(F) ADJ/ DATED 26/3/2013, WHEREBY THE APPELLANT ON PROMOTION WAS TRANSFERRED FROM G.G.P.S AFGHAN COLONY NO.3 PESHAWAR TO G.G.P.S. DIN BAHAR COLONY, PESHAWAR IN DISREGARD AND VIOLATION OF THE TRANSFER AND POSTING POLICY OF RESPONDENT / GOVT AND ON APPEAL, THE APPELLANT AUTHORITY FAILED TO REDRESS THE GRIEVANCE OF APPELLANT WITHIN THE STATUTORY PERIOD.**

**PRAYER IN APPEAL.**

On acceptance of this appeal, the impugned order bearing ENDMT NO. 11662-67/Promotion PSHT(F) Adj/ dated 26/3/2013 may kindly be set aside to the extent of transfer/posting of appellant, and the appellant may please be posted in GGPS, Afghan Colony No3, Peshawar by transferring respondent No.5 from said school.

**Respectfully Sheweth**

1. That appellant was appointed as PTC teacher in the year ..... in respondent /Govt: School and was lastly posted in GGPS No.3, Afghan Colony, Peshawar, in BPS No. 12.
2. That similarly the respondent No. 5 was also lastly posted in GGPS No.3, Afghan Colony, Peshawar.
3. That as per seniority list published by the respondent/department, the appellant rank senior to respondent No.5 and her name is appearing at serial No 465 while the name of respondent No.5 is appearing at serial No 669.
4. That vide notification bearing ENDMT NO. 11662-67/Promotion PSHT(F) Adj/ dated: 26/3/2013, the respondent No.2 ordered the promotion, the appellant was also promoted to BPS No.15, similarly vide the said order of numerous school teachers including the respondent No.5, and upon promotion, transfer and posting orders was also made. ( Copy of notification dated 26/3/2013 is annexed "A" herein impugned)
5. That by virtue of notification/order dated 26/3/2013, the appellant was also transferred from GGPS No. 3 Afghan Colony, Peshawar to GGPS Din Bahar Peshawar in disregard and violation of Govt: policy regarding transfer / posting in case of promotion.
6. That as per Respondent/ Govt: Policy No. 1/A-88/KC/S. list: dated Peshawar 18/01/2013, on promotion from PST No. B-12 to senior post of B-14 or B-15, the senior PST may be retained and posted in the same School while junior will be transferred ( Copy of Govt: policy is annexed as "B" ).
7. That in order to frustrate the transfer/posting policy, the respondent No.5 has been shown transferred from GGPS Din Bahar Colony, Peshawar to GGPS, Afghan Colony No.3, on promotion, while true fact are that both appellant and respondent No 5 were lastly posted in GGPS, Afghan Colony No. 3, Peshawar and respondent No 5 not at all remain posted in GGPS Din Bahar Colony, Peshawar, thus the policy has been violated by ignoring the appellant. ( Copy of extract from attendance Register for the month of December, 2013 Jan, 2013 to March 2013 is annexed as "C" showing posting of respondent No 5 in GGPS No 3 Peshawar)

8. That feeling aggrieved of the same, the appellant filed a departmental representation / appeal on 9/4/2013 but the same was not redressed by the departmental authorities within the statutory period ( Copy of grounds of departmental appeal is annexed as "D").
9. That being highly aggrieved of the impugned order bearing ENDMT NO. 11662-67/Promotion PSHT(F) Adj/ dated 26/3/2013 to the extent of transfer/posting, the appellant is constrained to institute the instant appeal on the following grounds inter alia,

**GROUND:** -

- a. That the order impugned bearing ENDMT NO. 11662-67/Promotion PSHT(F) Adj/ dated 26/3/2013 to the extent of transfer / posting of appellant is illegal, Corum non JUDGE, unlawful and in disregard of relevant provision of law and respondent/ Govt: policy, hence untenable and liable to be set aside.
- b. That as per Policy applicable to the matter, the appellant has a right to her retention in the same school on promotion being senior PST while the respondent being junior PST should have been transferred / posted in the other school, but the same has not been followed and violated by respondent / department.
- c. That departmental authority in colorable exercise of their powers and in order to frustrate the policy, and to facilitate the blue eyed, shown the posting of respondent No.5 to GGPS, Afghan Colony No.3, Peshawar while actually she has been retained in the same school i.e. GGPS , Afghan Colony No.3, Peshawar in violating policy.
- d. That conduct of respondent No 2 is against natural justice and is nullity in the eyes of law.
- e. That respondent no. 2 is bound to have followed the policy in letter and spirit, and by violation of policy, the appellant has been discriminated.
- f. That any other ground would be adduced by appellant during arguments during the hearing of instant appeal with the permission of the Hon' able Tribunal.

It is, therefore, requested that, on acceptance of this appeal, the impugned notification bearing ENDMT NO. 11662-67/Promotion PSHT(F) Adj/ dated: 26/3/2013 may kindly be set aside to the extent of transfer/posting of the appellant, and she may please be posted in GGPS Afghan Colony No 3, Peshawar by transferring respondent No.5 from said school.

The Respondents submit as under:-

**Preliminary Objections:-**

1. That the appellant has got no cause of action.
2. That the appellant has concealed material facts from this Hon, able Tribunal.
3. That the appellant has not come to this Hon, able Tribunal with clean hands.
4. That the appellant is not entitled for the relief he has claimed.
5. That the present appeal is based on malafide intensions.
6. That the present appeal is not maintainable in its present form.
7. That the order dated 26/03/2013 is legally competent and is liable to be maintained.
8. That the present appeal is badly time barred.
9. That the instant appeal is against the service rules and relevant policy.
10. That the present appeal is bad for mis-joinder and non-joinder of the necessary parties.

**On Facts:**

1. That para-1 is correct, hence no comments.
2. That para-2 is needs no comments, being relates to the service record of the appellant.

However it is further submitted the said post is of District cadre post on the analogy of one BPS-15 Head Teacher for one primary school having no question of transferring postings against the noted scale on Union Council base.

6. That para-6 is also incorrect and denied, the appellant has rightly been posted against BPS-15 at GGPS Din Bahar Colony Peshawar in the light of relevant policy, facts and circumstances of the case and in the interest of the public service.
  7. That para-7 is incorrect and denied, detailed reply has been given in the above mentioned para, hence no further comments.
  8. That para-8 is correct to the extent that her departmental appeal has been rejected by the competent authority vide order dated 09/04/2013 in the light of the facts and circumstances as mentioned above.
  9. That para-9 is incorrect and denied, the order dated 26/03/2013 is legally competent and as per policy.

**Grounds:**

- A. That para-A is incorrect and denied, the order dated 26/03/2013 is lawful and according to the Govt: policy.
- B. That para-B is also incorrect and denied, the appellant has rightly been transferred and posted at GGPS Din Bahar Colony Peshawar in the light of the relevant policy by the competent authority.
- C. That para-C is also incorrect and denied, the appellant has rightly been transfer and posted at the said school in the light of the Govt: policy.
- D. That para-D is incorrect and denied the respondent No 2 has acted in the instant case according to the relevant rules and policy, hence the order dated 26/03/2013 is liable to be maintained.
- E. That para-E is incorrect, the respondent-2 has acted and followed the relevant policy in the instant case.
- F. That para-F is legal, however the respondents No 1-4 seek leave of this Hon ,able Tribunal to advance additional grounds/ record and case law at the time of arguments,

It is therefore submitted that on the acceptance of this reply the appeal of the appellant may kindly be dismissed in favor of the respondents.

Appellant with counsel present. Preliminary arguments heard. Counsel for the appellant contended that the appellant has not been treated in accordance with law/rules. The appellant has wrongly been showing at GGHS Din Bahar Colony, Peshawar whereas at the time of promotion she was performing duty at GGPS No.3 Afghan Colony. According to note-5 of the "Guide Line for posting of PST(BPS-12) on promotion" as circulated vide Notification dated 18.01.2013, Senior most PSHT BPS-15 etc (according to the seniority list) may be retained in the school of their posting. The appellant is at S.No.665 is senior from Mst. Razaqat Begum (respondent NO.5) who is at S.No.669.

The learned Government Pleader was on the opinion that there is not departmental appeal. That under Section-10 of the Civil Servant Act, 1973 every Civil Servant shall be liable to serve any where in the interest of province, and that no one can claim posting against a specific post as provided under Proviso ( b)(i) under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act,1974. Since the issue relates to promotion, it was for the appellant to obey the order and actualize her promotion before filing the instant appeal.

Points raised at the Bar need consideration. The appeal is admitted to regular hearing subject to all legal objections. The appellant is directed to deposit the security amount and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply on 03.02.2014.



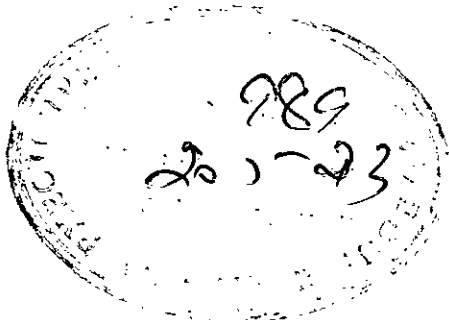
