

THE SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUNED ORDER OF RESPONDENT NO. 03 WHEREBY THE APPELLANT HAS BEEN DEPRIVED FROM HIS DUE SENIORITY OF HEAD CONSTABLE WITHOUT ANY VALID REASONS AND LAWS, THE DEPARTMENT APPEAL OF THE APPELLANT VIDE LETTER DATED 2905/LEGAL DATED 27.07.2023 AND NOT TREAED THE APPELLANT BY THE RESPONDENTS NO. 1, 2,& 3 IN ACCORDANCE WITH THE LAW AND ILLEGALLY DEPRIVED THE APPELLANT FROM HIS SENIORITY POSITION AND SUBSEQUENT PROMOTION.

PRAYER:

On acceptance of the instant service appeal, this Honorable Tribunal may graciously be pleased to:-

- i. Declare the impugned minutes of departmental promotion committee vide Endst: 258-59/EC held on 17.01.2021 and subsequently seniority list, whereby appellant has been made junior and deprived of his due seniority of head constable by respondent No. 3, and the impugned promotion order of respondent No. 3 as illegal, discriminatory, without lawful authority and against the natural justice / law & rules. Copy of minutes of Departmental Promotion Committee as annexure-A.
- ii. Direct the respondents to restore the original seniority position of the appellant assigned to him by the PTC Hangu as per rules 13.9 of Police Rules-1934 and promote him with effect from the promotion order ibid alongwith all back benefits.
- iii. Any other relief as deemed appropriate under the circumstances of the case may also graciously be allowed to the appellant.

Respectfully Sheweth,

The facts given rise to the present service appeal are as under:-

Facts:-

1. That the appellant appointed in Police department in the year-2002 and transferred /posted in district Hangu in the year-2011 vide RPO Kohat order Endst No. 5652-53/EC, dated 29.06.2011. Copy as Annexure-B
2. That in the year-2015, the appellant qualified B-1 examination through Educational Testing & Evaluation Agency (ETEA) from District Hangu and the respondent No. 3 sent him to Lower School to PTC Hangu. The Commandant, PTC Hangu, Gazzet Notification vide No. 579/S/RESULT, dated 04.04.2016 successfully completed the Lower School Course and stood at Serial 155/merit order No. 96 of the notification ibid. copy of B-1 Etea result as annexure-C
3. That the Respondent No. 3 placed the name of appellant on the list of 'C-1' constable of the district Hangu after completion of lower school course. Copy of Notification PTC Hangu as annexure-D.
4. That respondent No. 3, constituted a Departmental Promotion Committee vide order Endst: No. 259-59/EC, dated 17.01.2021 wherein LHCs were promoted to the next rank of Head Constable while the appellant was not promoted on the basis of standing order No. 02/2016 having no right of lien in the district Hangu and transferred back to District Karak for the purpose of promotion after serving 11 years service in District Hangu vide RPO order No. 7256/EC, dated 27.06.2023. Copy of transfer order as annexure E.
5. That the appellant aggrieved of the order of the respondent No. 3, preferred a departmental appeal to the respondent 2 who referred the case to respondent No. 4 for comments in light of the representation filed by appellant. Copy of departmental appeal as annexure-F
6. That respondent-4 meticulously perused the case of appellant and wrote a detailed letter vide No.1264/EC, dated 20.03.2023 to RPO Kohat (R-2). Last para of the letter is reproduced below:- copy as annexure-G

"As far as the seniority induction of LHC Rehmat Ullah No. 340/01 is concerned, neither district Hangu is Central Unit nor District Karak. So the above quoted standing No. 02/2016 do not apply to his case. Therefore, the case of LHC Rehmat Ullah No. 340/01 is recommended for induction of his Lower School Course seniority in district Hangu, please.

7. That appellant was made a roll stone from one office to another for seeking justice but none of the respondent dealt the appellant in accordance with law and finally a letter vide No. 2905/Legal, dated 27.07.2023 was issued by the

respondent No. 1 that the seniority of the appellant should be fixed with the batch mates of lower school course, Karak. Copy as annexure-H

- 8. That in compliance with the order of respondent No. 1, the appellant seniority was fixed in District Karak rather than in District Hangu in sheer violation of the rules & laws.
- 9. That the order of the respondent No. 1 was communicated to the appellant in a very belated stage.
- 10. That the appellant aggrieved from the impugned order of the respondents No. 1 & 3 and having no alternate remedy except this Honorable court for speedy disposal /redressal of grievances through present service appeal on the following grounds:-

GROUND:-

- A. That the impugned order of the respondents No. 1&3 is against to the cannon of laws as well as against the natural justice.
- B. That the appellant was rightly admitted by the respondent No. 3 for B-1 examination from district Hangu and successfully qualified the B-1 examination from the said district and subsequently to Lower School Course from the said district. But the respondent No. 3, in sheer violation of the rules and wrong interpretation of the law/standing order No. 02/2016, deprived the appellant from promotion of Head Constable and promoted junior Police officials to the appellant.
- C. That it is a settled law/rules that once a Police officials passed B-1 and Lower School Course from any district of the region shall be promoted in the rank of Head Constable in that district on the basis of C-1 list maintained by the district concerned.
- D. That letter of DPO Karak (R-4) is very cleared reproduced in para-6 of the fact above in which seniority of the appellant shall be fixed in district Hangu not in district Karak as the appellant appeared for B-1 examination from district Hangu and also successfully completed his lower school course from the same district.
- E. That the appellant had passed his B-1 examination in 2015 upon which he was detailed to lower school course to PTC Hangu while the standing order No. 02/2016 has prospective effects and cannot be extended to the case of appellant retrospectively. There is plethora of judgment of apex court that law / rules passed would have prospective effects. The said standing order does not apply to the seniority case of appellant as the appellant passed his B-1 examination in the year-2015 while the standing promulgated in 2016 liable to be set aside in the appellant case.

- F. That the appellant spent 11 years in district Hangu and no objection was placed by the respondents that the appellant is not entitled to B-1/lower school course from district Hangu but dully accepted and placed the appellant on C-1 list by the respondent No. 3. Copy of C-1/LHCs as annexure-I.
- G. That the standing No. 02/2016 pertains to Central Units while the appellant performed duties and done promotional courses from settled District Hangu not a central units hence the case of appellant doest hit/ not fall within the domain of standing order No. 02/2016. Copy of standing order No. 02/2016 as annexure- J
- H. That there is no such lien word exists in 13.8 of Police Rules 1934 and it is worth-mentioning here that still a lot of Police officials recruited in district Hangu on domicile of district Karak and onward promoted from the same district Hangu but the appellant has been deprived on the wrong interpretation of law & rules.
- I. That the appellant promotion/seniority fixation with district Karak would cause the appellant irreparable losses in future promotion and could not be promoted to the rank of head constable for long period in future. Therefore, the impugned order of respondents No. 1 & 3 is against the service laws and natural justice to be declared as illegal, unconstitutional and void ab initio.
- J. That the appellant has a constitutional right to be dealt in accordance with law as envisaged in article 4,9,10 & 25 of the constitution 1973.

In view of position explained above, it is humbly prayed that the instant service appeal may be allowed as prayed for above.

Kindly refer to your office letter No. 1883/JEC dated 10.02.2023 on the subject noted above.

It is submitted that LHC Rehmat Ullah No. 340 was enlisted in Karak on 12.02.2002. He passed his A-1 examination on 25.04.2009 from district Karak. Meanwhile, he was transferred on complaint basis to district Hangu vide the WRFO Kohat order Endst: No. 5652-53/JEC dated 29.08.2011 wherein he passed his B-1 examination on 15.03.2015 and he was selected for Lower School Course from district Hangu term ending 31.11.2015. Moreover, a Departmental Promotion Committee was constituted at District Hangu vide the DPO Office Hangu order Endst: No. 258-59/JEC dated 17.01.2021 wherein senior most LHCs were promoted to next rank of Head Constables whereas LHC Rehmat Ullah No. 340/61 was not promoted due to the Standing Order No. 14/2014 & 02/2016 (copy annexed).

Furthermore, LHC Rehmat Ullah No. 340/SSU/CPEC/61/Hangu was called to the office on 14.03.2023 and heard in person. The applicant LHC Rehmat Ullah No. 340/SSU/CPEC/61/Hangu stated that the aforementioned Standing Orders i.e. 14/2014 and 02/2016 does not applied to his case of promotion/seniority.

Moreover, as per Standing Order No. 14/2014 relates to upper age limit for A-1 and B-1 Exams and selection criteria for the Lower Course while S/O No. 02/2016 clause 04 states that:-

"Recruitment, Promotions in Central Units:- "Recruitment and promotion in the ranks from Constable to Sub-Inspector will be carried out and be regulated in concerned district and regions only. Central Units will neither recruit nor promote any officer unless it is specially provided and allowed. All personnel serving in the central units will be on deputation from concerned districts and Regions and their Sen will be in their parent district/Region. If in the past any recruitment has been carried out directly in the central units and Sen of such recruits has not been fixed so far, it will be fixed in district of domicile of the concerned recruit. Furthermore, for retirement purpose personnel will be posted back in their parent district."

As far as the seniority induction of LHC Rehmat Ullah 340/61 is concerned, neither district Hangu is central unit, nor district Karak. So the above quoted Standing Orders do not apply to his case. Therefore, the case of LHC Rehmat Ullah No. 340/61 is recommended for induction of his Lower School Course seniority in district Hangu, please.

STANDING ORDER NO. 02/2016
Quotas of Districts in Central Units

This Standing Order is issued under Article 10(3) of Police Order 2002 and in pursuance of the Police Policy Board decision taken in its 20th meeting held on 15th December 2015.

2. **Aim:** - This Standing Order aims at fixing the contributory quota of District and Regions in the executive strength of the Central Units.
3. **Existing Sanctioned Strength in Rank as determining Factor:** - (1) The executive strength from Constable to Sub-Inspector of all Central Units including Frontier Reserve Police, Elite force, Central Police Office, Special Branch, Traffic Khyber Pakhtunkhwa, CPO Investigation, Central Police Office, PQR and Training Schools and College will be provided by the Police Districts/Regions of the Province in accordance with the ratio of their existing sanctioned strength in overall sanctioned strength for each rank as detailed in attached Annexures.
(2) CTD Strength will be determined as per their requirement and deployment plan which has already been approved and issued vide CPO letter No. 322S-80/E-II dated 31.01.2014.
4. **Recruitment, Promotions in Central Units:** - Recruitment and promotion in the ranks from constable to Sub-Inspector will be carried out and be regulate in concerned Districts and Regions, only. Central Units will neither recruit nor promote any officer unless it is specifically provided and allowed. All personnel serving in the central Units will be on deputation from concerned Districts and Regions and their lien will be in their parent District/Region. If in the past any recruitment has been carried out directly in the central units and lien of such recruits has not been fixed so far, it will be fixed in District of domicile of the concerned recruit. Furthermore for retirement purposes personnel will be posted back in their parent Districts.
5. **Tenure:** - The period in the central unit will be considered on deputation in the meaning of Police Rules and shall not exceed 03 years.
6. **Application:** - This Standing Order will come into force with immediate effect and transition to this scheme of things will not be at once but be in phased manner subject to occurrence of vacancies in central units and capacity of the contributing Districts to contribute as per quota in due course of time.
7. **Power to remove difficulties:** - If any difficulty arises in giving effect to this order, the Provincial Police Officer may by notification make such provisions as deemed appropriate.
8. **Amendment:** - All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.



Please refer to your office Memo No. 4084/EC, dated 05.04.2023 on the subject cited above.

The Official Rehmat Ullah No. 340 appeared in A-I examination from his parent district Karak and later on qualified B-I exam illegally from district Hangu when he was transferred there on complaint while his lien was in district Karak. Similarly, he qualified Lower College Course on the strength of district Hangu which is totally illegal and against the rules. His lien if had transferred to District Hangu would be against the spirit of Standing Order No. 02/2016 wherein it has been mentioned that lien of each Police Official/ Constable will be in his parent district.

However, justice and fair play requires that he may be repatriated to his parent district Karak and his seniority may be settled along with his A-I colleagues besides initiation of disciplinary action against the dealing hands of District Hangu, please.
