APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACTS, 1974, AGAINST THE ORDER DATED 17.11.2017, WHEREBY THE APPOINTMENT ORDER OF THE APPELLANT WAS WITHDRAWN AND AGAINST THE REJECTION ORDE DATED 03.04.2018 WITHOUT SHOWING ANY COGENT REASON.

PRAYER:

THAT ON ACCEPTANCE OF THIS APPEAL, THE ORDER DATED 17.11.2017 AND 03.04.2018 MAY PLEASE BE SETASIDE AND THE APPELLANT MAY BE REINSTATED INTO SERVICE WITH ALL BACK AND CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

RESPECTFULLY SUBMITTED:

FACTS:

1. That the appellant was appointed as SST (Bio Chem) BPS-16 against the vacant post vide order dated 25.04.2017 and posted in GHS Hadora Bandi. The appellant properly submitted his chrg report/Arrival report on 03.05.2017. **(Copy of appointment order is attached as Annexure-A)**
2. That the appellant faced severe domestic problem and also got serious ill due to which the appellant absented from duty. The appellant also informed the athourity about the situation. **(Copy of medical certificate is attached as Annexure-B).**
3. That thereafter, the authority issued absence notice to the appellant the appellant properly replied to the absence notice and clear all the situations but the respondent not consider the reply of the appellant and appointment order was withdrawn vide order dated 17.11.2017 in fanciful manner without following proper procedure which is mandatory in law, against which appellant filed departmental appeal which was rejected by the incompetent authority wihout showing any cogent reason vid order dated 03.04.2018. **Copy of absence notice, reply, impugned order, departmental appeal and rejection is attached as Annexure-C, D, E,F & G).**
4. Hence the appellant constrained to file the instant service appeal on the following grounds amongst others.

GROUND:

- A. That the impugned order dated 17.11.2017 and 03.4.2018 are against the law, facts, norms of justice, and material on record, therefore not tenable and liable to be set aside.
- B. That the rejection order was not passed by the competent authority which is against the law and rules, and corrum non judice and voin in the eye of law.
- C. That the whole proceeding conducted by the respondent department is against the law and rules.
- D. That the proceeding was initiating against the appellant by District Education Officer, which is incompetent to initiate proceeding against the appellant. The competent authority for the appellant is Director

Educatuion, so the whole proceeding is void abinitio and nullity in the of law.

- E. That no regular enquiry has been conducted nor the enquiry office is rebutted the plea of illness of the appellant because as medical prescription have not been cross examined from the concerned Doctor, and in case of any doubt the authority was required to refer the matter to Medical Board for their opinion. therefore, without adopting that procedure the impugned penalty order has been passed which is not sustainable in the eyes of law.
- F. That the appellant has been condemned unheard and has not been treated according to law and rules.
- G. That niehter charge sheet, statement of allegation, show cause notice was served upon the appellant nor inquiry was conducted against the appellant, which was necessary and mandatory in law before imposing major punishment which is violation of law, rules and norms of justice.
- H. That the appellant has not been treated under proper law despite he was a civil servant of the province, therefore, the impugned order is liable to be set aside on this score alone
- I. That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for

Respectfully Sheweth :-

The Respondents submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action/locus standi.
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal.
- 4 That the instant Service Appeal is based on mala fide intentions.
- 5 That the Appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the Appellant is not entitled for the relief he has sought from this Honorable Tribunal.
- 7 That the instant Service Appeal is against the prevailing law & rules.
- 8 That the instant Appeal is based on mala fide intentions just to put extra pressure on the Respondents.
- 9 That the Appellant has been treated as per law rules & Procedure, prior to the issuance of impugned Notifications dated 17/11/2017 & 03/4/2018.
- 10 That the Appeal is not maintainable in its present form.
- 11 That the Appeal is bad for mis-joinder & non joinder of the necessary parties.
- 12 That the instant Service Appeal is barred by law
- 13 That the Appellant is not competent to file the instant appeal against the Respondents.
- 14 That the Appellant is estopped by his own conduct to file the instant Appeal.
- 15 That the impugned Notifications dated 17/11/2017 & 03/4/2018 are legally competent.

- 16 That the appellant has failed to join his duty against the SST(Sc:) post in BPS-16 within the statutory period of time without any legal justification at GHS Hadhora Bandi District Abbot Abad till 05/10/2017.
- 17 That the appointment order dated 25/9/2017, has correctly been withdrawn vide office order dated 17/11/2017 by the Respondent Department.
- 18 That the appellant has not resumed his official duty within the prescribed period of time. Hence, the matter of his willfully absence has been reported by the Headmaster GHS Hadhora Bandi District Abbot Abad vide his office letter dated 15/5/2017 to the DEO(M) Abbot Abad who further reported the absence from duty case to the Director E&SE Department for necessary action being competent authority.
- 19 That all codal formalities have been observed by the Respondent Department prior to the withdrawal of the appointment Notification dated 25/4/2017 vide the office order dated 17/11/2017.

ON FACTS.

1 That Para-1 is correct to the extent of his appointment against the SST(Science) post in BPS-16 vide notification dated 25/4/2017 falling at S/No: 60 of the said notification & was posted at GHS Hadhora Bandi District Abbot Abad where against, the appellant did not resume his official duty nor submitted any kind of arrival report for duty to the Head Master concerned. Hence, the matter regarding his non-resumption of duty at the said school was reported by the Headmaster GHS Hadhora Bandi District Abbot Abad vide his office letter No: 242-2 dated 15/5/2017 to the District Education Officer (M) Abbot Abad which was forwarded to the Director E&SE Khyber Pakhtunkhwa vide letter No: 8326 dated 28/7/2017 by the DEO(M) Abbot Abad & in response to the said letter dated 28/7/2017, the District Education Officer (M) Abbot Abad was directed vide letter dated 29/8/2017 for serving an absence notice to the appellant on his postal address which was served upon the appellant vide absent notice No: 9805-06 dated 11/9/2017 by the District Education Officer (M) Abbot Abad & an intimation the said effect was also forwarded to the Director E&SE Department Khyber Pakhtunkhwa vide letter No: 1077-78 dated 11/11/2017 by the District Education Officer (M) Abbot Abad.

The appellant, in reply to the said absence notice dated 11/9/2017 by the appellant to the District Education Officer (M) Abbot Abad wherein, he has admitted his guilt regarding his willful absence & non resumption of duty against the SST(Science) post in BPS-16 on dated 20/9/2017 without any cogent reason & justification which resulted in the impugned notification dated 17/11/2017 against the appellant . **(Copies of the appointment notification dated 25/4/2017, absence from duty report by the Head Master dated 15/5/2017, letter of the DEO(M) Abbot Abad dated 28/7/2017, letter dated 29/8/2017, absence notice dated 11/9/2017 & impugned notification dated 17/11/2017 are annexed as annexures-A, B, C, D, E & F).**

2 That Para-2 is also incorrect & not admitted. The plea of the appellant is without cogent proof & legal justification & is looking for illegal & un-authorized adjustment against the SST(Science) post in BPS-16 in the Respondent Department on mala-fide intentions.

3 That Para-3 is correct to the extent of serving an absence notice upon the home address of the appellant duly received & replied by the appellant in an unsatisfactory manner which resulted in the withdrawal of his appointment notification dated 25/4/2017 vide office order No: 3474-77 dated 17/11/2017 issued by the Deputy Director (Etab:/M) E&SE Department Khyber Pakhtunkhwa, upon the approval of the Director E&SE Department Khyber Pakhtunkhwa, & where against the appellant has filed an application dated 06/2/2018, for his re-instatement against the SST (Science) post as against the factual position that he has not resumed his official duty intentionally which resulted in the withdrawal of his appointment order dated 25/4/2017 vide the said office order dated 17/ 11/ 2017, under the mandatory provisions of Section-21 of General clauses Act: 1897 which is not only legal but is also liable to be maintained in favour of the Respondents in the interest of justice.

However, aggrieved from the office order dated 17/11/2017, the appellant has filed a Departmental Appeal which was rejected vide order dated 03/4/2018 on merits of the case by the Respondent Department.

4 That Para-4 is legal. However, the Respondent Department further submit on the following grounds inter alia:-


GROUND.


- A. Incorrect & not admitted. The impugned Notifications dated 17/11/2017 & 03/4/2018 are legally competent as the Respondent Department has observed all the codal formalities prior to the issuance of the said Notifications. Therefore, the plea of the appellant is liable to be dismissed.
- B. Incorrect & denied. The order dated 03/4/2018 is within legal sphere & liable to be maintained in the interest of justice as the appellant has failed to resume his official duty against the SST (Sc:) post at GHS Hadhora Bandi District Abbot Abad intentionally & without any legal justification. Which resulted in the withdrawal of his appointment order dated 25/4/2017 by the competent authority.
- C. Incorrect & denied. The act of the Respondent Department is within legal parameter & has by observing all the codal formalities by the Respondent Department. Hence, the claim of the appellant is liable to be dismissed.
- D. Incorrect & denied. The statement of the appellant is baseless & without any cogent reason & justification as the both the impugned orders have been passed by the competent authority.
- E. Incorrect & denied. The plea of the appellant is mainly based on mala-fide intentions as the act of the Respondent Department with regard to the impugned notification dated 17/11/2017 & 03/4/2018 are within legal sphere & are liable to be maintained.
- F. Incorrect & denied. Formal absence notice has been served upon the appellant for resumption of his duty against the SST (Sc:) post at the said School which was not responded by the appellant intentionally & is now taking shelter of medical grounds on mala-fide for his ex-post in the Respondent Department which cannot be entertained at such a belated stage as he has already forgiven his right of appointment against the said post willfully. Hence, the stand of the appellant is without any reason & legal justification.

- G Incorrect & denied on the grounds that the appellant did not bother to resumed & report for duty at the said school therefore, serving of charge sheet, statement of allegation don't make any sense except absence notice which was dully served upon the appellant on his postal address in accordance with the relevant provisions of law & rules by the Respondent Department.
- H Incorrect & denied. The stand of the appellant is without any legal justification as he did not resume his duty against the said post within the time limitation. Hence, he does not fall within the ambit of Section-2(b) of Civil Servants Act 1973 & his claim is liable to be rejected.
- I Legal, however the Respondents also seek leave of this Honorable Tribunal to submit additional grounds, record & case law at the time arguments on main appeal.

In view of the above made submissions, it is most humbly prayed that this Honorable Tribunal may very graciously be pleased to dismiss the instant Service Appeal in favor of the Respondent Department.


