

SERVICE APPEAL UNDER SECTION 4 OF SERVICE TRIBUNAL ACT 1974 READ WITH CLAUSE XIV OF POSTING & TRANSFER POLICY AGAINST IMPUGNED NOTIFICATION BEARING NO. 5129-45/ADMN DATED PESH 18.05.2023 WHEREBY APPELLANT WAS DEPRIVED FROM PROMOTION AND RESPONDNET NO. 04 FROM DISTRICT BATTAGRAM WAS GRANTED PROMOTION AGAINST THE FACT AND LAW WHILE PROMOTING THE RESPONDNETS NO. 04 BY THE RESPONDNET No. 01.

Prayer:

On acceptance of the instant service appeal, impugned Notification bearing No. 5129-45/Admn dated Pesh 18.05.2023 issued by the respondent No. 01 may please be set aside and respondent No. 01 may please be directed to consider/promote the appellant against the post of Superintendent on regular basis and issue notification in this regard forthwith or any other order or relief as this Honorable court deems fit and appropriate in the circumstances of the case, may also be issued/passed.

Respectfully sheweth,

1. That, the appellant is bonafide resident of Muhallah Dab No. 02, Behind GCCM, Silk Rout, Tehsil & District Mansehra. (Copy of CNIC of appellant is annexed as Annexure A.)

2. That, appellant has been appointed as Assistant/Reader BPS-14 in District Judiciary Mansehra in the year 2011 and was upgraded in the year 2015 to the BPS-16 by the provincial Govt on regular basis. **(Copy of Seniority List for the year 2022/23 is annexed as Annexure B.)**
3. That the appellant is qualified having Degree in Law, Master in social sciences and performing official duties and obligations in District Judiciary Mansehra since 2011. **(Copy of educational documents is annexed as Annexure C.)**
4. That the appellant is performing official duties with full zeal and zest and had never remained negligent during his whole service up till now.
5. That the appellant had served 12 years' service in the district judiciary Mansehra as Assistant/Reader and senior most reader in his cadres post. **(Copy of Seniority list as Annexure B already annexed in Para No. 02)**
6. That the appellant was fit for promotion however respondent No. 01 had promoted the respondent No. 04 by not considering the appellant which is illegal, against the law, policy, against the facts. **(Copy of Notification bearing No. 5129-45 dated Pesh 18.05.2023 is annexed as Annexure D.)**
7. That the notification issued by the Respondent No. 01 is against the law, arbitrarily, void ab initio, against the fact and is liable to be set aside. **(Copies of Rules, policy are annexed as Annexure E.)**
8. That in the year 2022 appellant moved an application for vacation of the seat of the Superintendent and filling up of the said seat from the incumbents of District Mansehra, however the said application was not entertained/Considered by the Honorable/Respondent No. 01. **(Copy of application duly forwarded by the Respondent No. 02 dated 16.08.2022 is annexed as Annexure F).**
9. That, in the instant year 2023, appellant forwarded another application to the respondent No. 01 for adjustment/transfer of the seat of Superintendent for District Mansehra but appellants request was not considered for promotion/adjustment. **(Copy of application duly forwarded to the Respondent No. 02, dated 14.04.2023 is annexed as Annexure G).**
10. That, during pendency of the applications of the appellant, impugned Notification Bearing No. 5129-45/Admn Dated Pesh 18.05.2023 was issued by the Respondent No. 01 by not considering the applications of appellant for promotion. **(Copy of Notification**

bearing No. 5129-45 dated Pesh 18.05.2023 is annexed already as Annexure D in Para No. 06.)

- 11. That appellant being aggrieved from the impugned notification file departmental appeal before respondent No. 01 but the same is still unattended to. (Copy of Departmental Appeal dated 14.06.2023 are annexed as Annexure H.)
- 12. That, till now appellant has not so far been called by the Honorable/Respondent No. 01 and appellant time and again visited the office of the respondent No. 01 for consideration of his promotion but in vain hence the appellant being aggrieved from the impugned notification seeks the graciously indulgence of this Honorable Tribunal by way of instant service appeal, inter alia on the following grounds,

GROUNDS

- A. That the impugned notification passed by the respondent No. 01 whereby respondent. 04 was promoted is wrong, illegal, against the law and facts, arbitrary, fanciful, perverse, against the relevant law and rules, regulations, based on malafide, against the fundamental rights of the appellant hence being not maintainable, liable to be set aside.
- B. That the relevant law, rules and regulations have blatantly bypassed/violated by the respondents and the relevant law, rules and regulations have never been taken into considerations by the respondents and thus the notification passed by the respondent No. No. 01 has no legal sanctity in the eyes of law.
- C. That no solid, valid, concrete or inspiring reasons/justification has been given by the competent authority while depriving the appellant from legal and legitimate right of promotion.
- D. That the appellant has 12 years unblemished service career without any stigma and the appellant is not considered for promotion being senior most in the cadre of District judiciary Mansehra.
- E. That respondent No. 01 has not advanced any strong, cogent and confidence inspiring reasons while refusing the promotion to the appellant.
- F. That the appellant has not ever been called by the respondents No. 01 nor afforded any opportunity of being heard hence all the proceeding being carried out at the back of appellant is against the


settled principles of natural justice, "that no person should be condemned unheard."

- G. That the appellant being senior most has been refused for promotion whereas junior than appellant have been promoted hence clear crystal discrimination has been done with the appellant by respondent No. 01 in a sheer malafide manner.
- H. That the competent authority has been failed to exercise its powers in accordance with law, rules and regulations rather travelled beyond the powers so vested in it under the law.
- I. That the appellant has unblemished service career as the appellant is performing his duties with Zeal and zest and never remained negligent in performance of his assigned duties. Similarly neither any departmental or any public complaint is available against the appellant or any negative remarks available in the service record of the appellant.
- J. That, it is an alienable right of the appellant to enjoy the protection of law and to treated in accordance with law, rules and regulations but such right of appellant has been infringed in a sheer malafide manner.
- K. That powers of jurisdiction are vested in authority to exercise it justly, fairly honestly, judiciously and in accordance with law, rules and regulations but the respondents No. 01 to 07 have transgressed upon their powers while dealing with the matter in hand.

.....PRAYER.....

It is therefore most humbly prayed that, on acceptance of instant service appeal, impugned notification bearing No. 5129-45 dated 18.05.2023 issued by the respondent No. 01 may graciously be set aside and respondent No. 01 may please be directed to promote the appellant on the post of superintendent BPS-17 on regular basis and to issue notification in this regard forthwith or any other order or relief as this honorable tribunal deems fit and appropriate in circumstances of the case, may also be issued/passed.

TRANSFER AND POSTING POLICY NOTIFICATION

Dated Peshawar, the 13th March, 2017

No. 69-J The Competent Authority has been pleased to amend the transfer and posting policy as under: -

ZONES:

For the purpose of transfer and posting, the province of the Khyber Pakhtunkhwa is divided into the following five Zones:

Zone-I	Charsadda, Mardan, Nowshera, Peshawar and Swabi
Zone-II (Hard area)	Battagram, Buner, Chitral, Dir Upper, Kohistan, Shangla, Tank, Hangu and Tor Ghar
Zone-III	Bannu, DI Khan, Lakki Marwat, Kohat & Karak
Zone-IV	Abbottabad, Haripur and Mansehra
Zone-V	Dir Lower, Malakand at Batkheal and Swat

TENURE:

- I. Tenure of stay in Zones I, III, IV and V shall be three years
- II. Tenure of stay in Zone-II (hard area) shall be two years.
- III. Tenure for an ex-cadre judicial post shall be two three years.
- IV. Tenure of an ex-cadre non-judicial posts shall be two years.

ROTATION:

- I. After having served in Zone-I, or at ex-cadre post, or upon return from study leave, (including abroad for a period of more than six months), the judicial officer(s) shall be posted to Zone-II (hard area) for a tenure as fixed above.
- II. After having served in Zone-II (hard area), the judicial officer (s) shall be posted in Zone-III thereafter in zone IV, further thereafter,

to zone-V, and further followed by a posting to Zone-I. The rotation shall thus continue.

TRANSFER & POSTING TIME:

Routine transfers and postings shall be made in the months of March and September only. However, the Chief Justice in consultation with the Administration Committee may order transfer and posting where it is deemed appropriate owing to some unforeseen reason(s).

SPOUSES:

Transfer and posting of spouses to one station shall be considered in the public interest.

RETIREMENT:

Transfer and posting of judicial officer(s) due to retire within one year, on his/her own options, be posted to a District near to the home District, till retirement.

HEALTH ISSUE(S):

Transfer and posting of judicial officer(s) having serious health issues(s) to himself/herself and/or to family members(s) requiring specific medical treatment, will be considered with due regard to such health issues. For this purpose, such a judicial officer has to inform the Registrar in writing with sufficient documentary proof. The Registrar shall verify the information. The Administration Committee shall on a case-to-case basis decide the gravity of the health issue that may be assessed as serious enough to be considered for the purpose of transfer and posting.

EX-CADRE POSTING:

Transfer and posting to an ex-cadre position shall be on one time basis. Posting to an ex-cadre post shall be on the basis of Performance Evaluation Report.

REPRESENTATION:

A transfer and posting order passed by the Administration shall be initially a proposal, against which a judicial officer may file representation within three days. After the decision on representation, the Administration Committee shall pass a final order.

It is to state with great homage and with reference to the subject noted above, I would like to lay down the following submissions;

1. That, the undersigned was appointed as Assistant/Reader in the year 2011 in District Judiciary Mansehra.
2. That, prior to induction in District Judiciary Mansehra, the undersigned served in another Govt Department for 6/7 years.
3. That, in the year 2017, Mr. Ashraf, Superintendent to Honorable D&SJ Mansehra got retirement from the service on superannuation and the seat of superintendent became vacant and no one amongst the cadre post of assistants was promoted through DPC from District Judiciary Mansehra.
4. That, said post was filled by transferring Syed Asif Hussain Shah, Superintendent from District Batgram who was initially appointed at District Kohistan and valuable rights of the officials were shattered due to such transfer.
5. That, due to said transfer, the senior most officials amongst the cadre post of assistants could not avail the chance of promotion and got retired without availing due promotion to the post of Superintendent.
6. That, in said period 02 DPCs were held for the promotion of assistant at Batgram, i.e one of the assistants promoted as a Superintendent currently posted at Batgram whereas second assistant was also promoted and posted as Superintendent to District Torghar at Oghi.


- 7. That, since 2017, none of the assistant has been promoted to the post of Superintendent from District Mansehra due to which carrier progression to the incumbents against the post of assistants is become stuck-up/stagnant and if present Superintendent posted at Mansehra continues services then there would no chance of promotion of existing assistants since 2030.
- 8. That, last DPC for promotion of assistant against the post of Superintendent was held in the year 2008 whereby Muhammad Ashraf the then Superintendent was promoted and since then no one amongst the post of assistant has been promoted, meaning thereby from last 14 years the assistant from District Judiciary Mansehra are waiting for their promotion.

Request:-

- > In the light above aforementioned submissions, it is humbly prayed that, my request on humanitarian grounds may kindly be considered for filling up the vacancy of Superintendent on account of falling vacant in imminent future.
- > It is further requested that, if your good honor may deems appropriate, the present Superintendent may please be transferred to his parent District and the post of Superintendent so become vacant may be filled from District Mansehra and obliged.
- > Any other relief may please be granted if deems appropriate.







With due respect, it is submitted as under;

1. That, the undersigned has been appointed as Assistant/Reader in year 2011 in District Judiciary Mansehra and is working as reader since the same year. Similarly undersigned is senior in his cadre. "Copy of seniority list for the year 2022/23 is annexed A."
2. That, the undersigned submitted an application to the Honorable Registrar Peshawar High Court Peshawar wherein it was prayed that, upon the vacation of the post of Superintendent, DPC may be conducted for the staff of District Judiciary Mansehra from the holder of the post of Assistants but in vain. "Copy of the application dated 30.07.2022 is annexed B."
3. That, the undersigned submitted an another application to the Honorable Registrar Peshawar High Court Peshawar upon vacation of seat of Superintendent at Battagram District and requested for filling the same by holding DPC for District judiciary staff of Mansehra but in vain. "Copy of the application dated 14.04.2023 is annexed C."
4. That, the above requests were not considered and Battagram District has been awarded promotion and Mr. Nasrullah Jan Assistant granted promotion to the post of Superintendent vide Notification No. 5129-45/Admn dated Pesh 18.05.2023. "Copy of the Notification No. 5129-45/Admn dated 18.05.2023 issued by the Honorable Registrar PHC Peshawar is annexed D."
5. That, last DPC for the filling the post of Superintendent at District Mansehra was conducted in the year 2008 and since then the incumbent for the post of assistant awaiting the fruits of promotion however in the year 2017 upon the retirement of the then superintendent at Mansehra, transfer posting of Superintendent from Battagram District was made vide Notification No.4449-19 Dated 21.04.2016 as well as Notification No. 8788-95/Admn Dated Pesh the 30.05.2017 and the vacancy was filled through transfer which culminated all the hopes and fruits. "Copies of the Notification dated No.4449-19 Dated Pesh the 21.04.2016 as well as Notification No. 8788-95/Admn Dated Pesh the 30.05.2017 issued by the Honorable Registrar PHC Peshawar is annexed E and F."
6. That, the present Superintendent, Mr. Asif Hussain Shah is holding the post of Superintendent since 2004 and if he will continue his service at Mansehra, whose retirement as per the date of birth (20.03.1970) is in the year 2030 on superannuation (19.03.2030), then the holders for the post of assistant surely cannot avail the chance of promotion to an indefinite period. "Copy of Seniority list for the year 2022/23 already annexed for ready reference as A."

7. That, due to the said transfer of Mr. Asif Hussain Shah, the present Superintendent, the promotion chances of the clerical cadre of Assistants, senior clerks, junior clerks, naib qasid etc suffered in all respect.
8. That, after the transfer of Mr. Asif Hussain Shah the present Superintendent, 02 DPCs have been conducted in District Battagram whereas no DPC has been scheduled for District Mansehra, meaning thereby one district avails 02 promotions and the other one has not avail even a single chance of promotion and due to this, carrier progression in District judiciary Mansehra is stuck for indefinite period.
9. That, both the applications of undersigned dated 30.07.2022 and 14.04.2023 have not been considered.
10. That, impugned Notification No. 5129-45/Admn dated Pesh 18.05.2023 issued by the Honorable Registrar Peshawar High Court Peshawar is arbitrarily, biased, illegal, against the law and fact, and is liable to be set-aside.
11. That, undersigned feeling aggrieved from the impugned Notification 5129-45/Admn dated Pesh 18.05.2023 regarding promotion of Mr. Nasrullah Jan Assistant to the post of Superintendent at District Battagram, the instant Departmental Appeal is submitted.

Prayer:-

It is therefore, humbly requested that, the Notification 5129-45/Admn Dated Pesh 18.05.2023 regarding promotion of Mr. Nasrullah Jan Superintendent may kindly be set aside and undersigned may be considered for promotion to the post of Superintendent.

Any other relief may please be granted if deems appropriate and obliged.


