

**APPEAL U/S 4 OF THE SERVICE TRIBUNAL ACT, 1974  
AGAINST OFFICE ORDER NO. 6492 / 256 ADVANCE  
INCREMENTS DATED 02-10-2020 OF R. NO. 01  
WHEREBY REQUEST FOR GRANT OF ADVANCE  
INCREMENT OF APPELLANT WAS REJECTED:**

**Respectfully Sheweth:**

1. That appellant has in his credit the educational qualifications from SSC to Double MA. (Copies as annex "A")
2. That apart from the aforesaid qualifications, appellant has professional qualifications of PTC, CT, B. Ed and M. Ed passed with distinction. (Copies as annex "B")
3. That on 08-10-1988, appellant was appointed as PTC teacher by figuring his name at S. No. 2911 with other candidates. (Copy as annexed "C")

4. That the KP, Public Service Commission advertised numerous post of Senior Certified Teacher (SET B-16) and after going the Commission through prescribed procedure, appellant was appointed as such on 15-01-1998, and his name was placed at S. No. 13 of the said Notification. (Copy as Annex "D")
5. That numerous posts of subject specialist B-17 were advertised by the Commission, and by fulfilling the required procedure for the purpose, appellant was recommended by the Commission for appointment as such and then the authority issued notification on 03-07-1999 by appointing appellant as subject specialist B-17 and he was figured at S. No. 34 of the said notification. (Copy as Annex "E")
6. That on 06-10-1999, appellant was transferred from GHSS Pirpai (NSR) to GHSS Gule-e-Amam (Tank), followed by subsequent transfer letter vide Notification dated 24-07-2006. (Copies as Annex "F")
7. That prior to the year 2001, incumbents were allowed Advance Increments on acquiring of higher and professional educational qualifications from the prescribed qualifications taintd for the post for appointment.
8. That numerous incumbents not only in hundred but in thousands, were benefited by allowing them advance increments on acquiring of high professional qualifications. As appellant had higher professional qualifications, so he was / is legally entitled for grant of advance increments on prescribed professional qualifications.
9. That appellant agitated the matter regarding advance increments before the department time and again, but no heed was paid to the same for the purpose.
10. That the aforesaid matter was agitated in numerous cases before the honorable Tribunal, High Court and apex Supreme Courts of Pakistan where in department was directed to grant advance increments for acquiring additional qualification w.e.f 16-04-2008 vide judgment dated 06-03-2011 of the apex Court. (Copies as Annexed "G")

11. That on 25-04-2014, appellant was promoted to the post of Senior Subject Specialist B-18 on regular basis along with others and his name was placed at S. No. 93. (Copies as Annexed "H")
12. That on 27-04-2017, the Provincial Selection Board recommended appellant with others for promotion to B-19 on regular basis and his name was placed at S. No. 82 of the said notifications. (Copies as Annex "I")
13. That from the aforesaid circumstances and facts of the case, it is crystal clear that appellant has spotless service in his credit without any complaint to the superior or to the general public and was legally entitled for the grant of three advertisement increments on high professional qualifications M.A, B.ED, and M.ED.

Such benefit was extended by the department to similarly and equally placed servants.

14. That on 15-08-2020, appellant submitted subsequent representation before the authority for grant of Advance Increments followed by reminders dated 16-09-2020 and 28-09-2020 but his request was rejected on 02-10-2020 for no legal reason. (Copies as Annex "J" & "K")

Hence this appeal, inter alia, on the following grounds:-


**GROUND S:**

- a. That beside relevant qualifications for the required post, appellant has professional qualification of PTC, CT, B. Ed and M. Ed.
- b. That after introduction of policy regarding grant of advance increment on acquiring of higher professional educational qualification, numerous incumbents in thousands were allowed advance increments on the basis of higher educational qualification.
- c. That the case of appellant is at par with the cases of other incumbents of the department who were allowed advance increments.


- d. That though in the year 2001, the Govt. curtailed advance increments but the case of appellant falls prior to the said curtailment, so is entitled for the same.
- e. That on one hand, the Govt. allowed advance increments on the basis of acquiring higher professional qualification but on the other hand, the same were not allowed to appellant.
- f. That equally and similarly placed persons be treated equally and similarly to avoid discrimination inter-se the incumbents.
- g. That the subject matter came up for hearing on 16-03-2011 wherein the hon'ble apex court was pleased to allow advance increments for acquiring of additional qualification.


It is, therefore, most humbly prayed that on acceptance of the appeal order dated 02-10-2020 of the respondents be set aside and appellant be allowed advance increments from the date of acquiring of the qualifications.

JUDGMENT

NASIR-UL-MULK, 1. This appeal by leave of the court is directed against the judgment of the KPK Service tribunal, dismissing the appellant's appeal for the grant of increments upon acquiring higher qualification in accordance with the policies of the Government.

2. The appellant was appointed as subject specialist in Physics in a Government school having the qualification of M. Sc and B.Ed. He acquired additional qualification of M.Ed on 16.04.2002 and thus applied for additional increments admissible to the employees under the Government polices upon acquiring additional qualification.

The learned counsel for the appellant has pointed out that

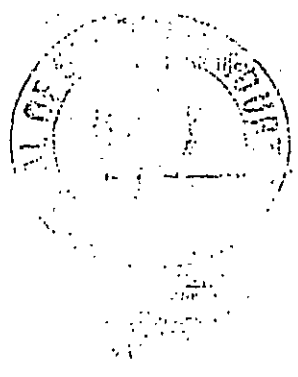

by the Headmaster of the School to appear as private candidate in M.Ed Examination. That the appellant wanted to acquire additional qualification in view of policies of the Government for advance increment for such qualification. He argued that since the basic qualification held by the appellant was M.Sc B.Ed on the basis of which he was appointed, the acquisition of M.Ed was an additional qualification.

4. The learned Additional Advocate General submitted that the scheme under which advance increments were granted had been discontinued in 2001. The learned counsel for the appellant submitted, in response that the appellant had acquired the additional qualification through long distance course from Allama Iqbal Open University and the appellant had completed all the semesters by spring of 2001 but the result was notified on 16.04.2002.

5. The record shows that the prescribed qualification for the appointment of subject specialist at the relevant time was M.A/B.Ed. and the acquisition of M.Ed. was therefore a higher qualification Reference may be made to the judgment of this court in HAMEEDUL HAQ v ACCOUNTANT GENERAL N.W.F.P PASHAWAR AND OTHERS; Civil Petitions no. 1854 to 1879 of 1999 dated 21.04.2000 copy of which has been filed with this appeal. As regards the discontinuation of the scheme, it may be pointed out that the appellant had admittedly completed the entire course through semesters by spring 2001. whereas the scheme was discontinued at the end of 2001. Issuance of certificate of passing of M.Ed. depended solely upon the completion of semester since the appellant was taking a long distance course. The appellant cannot be blamed for the delay in certification of his passing M.Ed. examination. Thus by the time the appellant had qualified the scheme for advance increments was still in force. Having said that we are mindful of the fact that the appellant knocked the doors of the tribunal in 2008 against a cause of action that arose in 2002. However, since it is a matter of incurring pecuniary benefits, the appellant has a continual cause of action at the same time we cannot overlook the lethargic conduct of the appellant for approaching the court with due diligence.

in view of the foregoing, we allow this appeal in terms that the appellant shall be granted advance increments for acquiring additional qualification with effect from 16.04.2008. the date on which he filed service appeal before the service tribunal.

**Preliminary Objections**

1. That the present appeal is bad by law and not maintainable.
2. That the appellant is not an aggrieved person nor has any cause of action.
3. That the appellant has no locus standi to file the present appeal.
4. That the appellant has not come to Tribunal with clean hands.
5. That according to section-02 of "KP cessation of payment of Arrears on advance increments on Higher Education Qualification Act, 2012" this Service Appeal is liable to be dismissed with cost. The relevant section is reproduced as under.

S (2). Cessation of payment of Arrears on advance increment on Higher Education Qualifications

1. Notwithstanding anything contained in any decision, judgement and of any Tribunal or court including High Court or Supreme Court of Pakistan, for the purpose of any claim for payment of arrears on account of advance increments on Higher Education Qualification sanctioned in pursuance of any order, letter, office memoranda, notification, instructions and other instruments issued before 01-12-2001, such orders, letters, office memoranda, notification instructions and other instruments shall be deemed to be non-existent, ceased or revoked and no further claim whatever on the basis of these instruments shall be entertained and all cases in respect of such claims pending in any court or Tribunal including High Court and Supreme Court of Pakistan shall stand abated.

6. That the present appeal is totally against the prevailing law and rules. Hence liable to be dismissed.
