

**MINUTES OF THE DEPARTMENT COMMITTEE MEETING HELD ON**  
**19.10.2017**

In order to discuss/consider promotion of Junior Clerk, Patwari and Naib Qasids to the post of Senior Clerk, Kanungo and Junior Clerks respectively a meeting of the Departmental Promotion Committee was held on 19.10.2017 at 1:00 PM presided by the undersigned in the office.

The meeting started with recitation from the Holy Quran. The Chair apprised the forum that various posts in the district are laying vacant which are to be filled in by promotion. Working papers alongwith relevant record/rules were provided to all members. The committee discussed the cases one by one as follows:

**1. PROMOTION FROM THE POST OF JUNIOR CLERK (BPS-11) TO SENIOR CLERK (BPS-14)**

According to sanctioned strength of this office only one post of Senior Clerk (BPS-14) is available and laying vacant due to promotion of Mr. Ghulam Mustafa as Assistant (BPS-16). According to rules the post of Senior Clerk (BPS-14) is to be filled in by promotion on the basis of seniority cum fitness from amongst the Junior Clerks of the District concerned with at least 02 years service as such. Joint Seniority list of Junior Clerks for the period ending 31<sup>st</sup> December, 2016 perused Muhammad Rafiq being top most senior has forgone his seniority and is not interested in promotion, his written statement is placed on file. Hence, the second top most senior Mr. Sartaj Ali Junior Clerk applied for promotion. Documents, ACRs, synopsis, certificates of Mr. Sartaj Ali Junior Clerk perused and found correct/authentic, fulfilling the criteria. Hence, Mr. Sartaj Ali was unanimously approved/ recommended to be promoted from the post of Junior Clerk (BPS-11) to the post of Senior Clerk (BPS-14).

**2. PROMOTION FROM THE POST OF PATWARI (BPS-09) TO KANUNGO (BPS-11)**

01 post of Kanungo (BPS-11) is laying vacant due to retirement of Faiz Ur Rehman Kanungo on 21.01.2017. According to rules the post of Kanungo (BPS-11) is to be filled in by promotion on the basis of Joint Seniority cum fitness on district level from amongst the Patwaris/ who have passed the departmental examination of Kanungo. Joint Seniority list of Patwaris for the period ending 31<sup>st</sup> December, 2016 perused Abdul Ghafar being top most senior has forgone his seniority and is not interested in promotion, his written statement is placed on file. Further he has not passed departmental examination of Kanungo. Hence, the second top most senior Mr. Abdur Rehman Patwari (BPS-09) applied for promotion. Documents, ACRs, synopsis, certificates of Mr. Abdur Rehman Patwari perused and found correct/authentic, fulfilling the criteria. Hence, Mr. Abdur Rehman was unanimously approved to be promoted from the post of Patwari (BPS-09) to the post of Kanungo (BPS-11).

**3. PROMOTION FROM THE POST OF NAIB QASID (BPS-03) TO JUNIOR CLERK (BPS-11)**





Mr. Sartaj Ali as Senior Clerk vide para at S# 1 above. Thus total 05 posts are laying vacant. According to rules the posts of Junior Clerks (BPS-11) are to be filled in with ratio of 33% by promotion on the basis of seniority cum fitness, from amongst the Qasids and Naib Qasids including holders of other equalent posts in the District concerned with 02 year service as such, who have passed Secondary School Certificate Examination and 67% by initial recruitment from the candidates of the District concerned. The availed quota of promotion and direct recruitment was discussed. 07 Naib Qasids have already been promoted to the post of Junior Clerks (BPS-09) and the reserved quota of 33% has been exhausted. 




