



- 1. That this Honorable Service tribunal has got no jurisdiction to entertain the present appeal.
- 2. That the appellant has got no cause of action/locus standi to file the present appeal.
- 3. That the appeal is not maintainable in its present form.
- 4. That the appellant has not come to the Tribunal with cleans hands.
- 5. That the appellant is estopped by his own conduct to being the instant appeal.
- 6. That the transfer of the appellant was in interest of public Service and is further bound by section 10 of Khyber PakhtunKhwa Civil servant act 1973 to obey the orders.
- 7. That the appeal is groundless based on malafide.
- 8. That the appeal is based on false and malafide hence deserves dismissed.
- 9. That the appeal is barred by law and limitation.



#### RESPECTFULLY SHEWTH.

- 1. Para No.1 is correct up to the extant that the appellant is serving in Education Department.
- 2. Para No.2 is correct up to the extent that the appellant was conditionally transferred from GGPS Harian Panjool to GGPS Ganda (Mansehra) against the post of Mst: Kalsoom Jan PST, who was likely to be promoted against the post of SST.
- 3. Para No.3 is related to the service record of the appellant. The Government Servant is bound to perform her service at any station asked by the Department.
- 4. Para No.4 needs no comments.
- 5. Para No.5 is incorrect. The appellant was transferred from GGPS Ganda to GGPS Harian Panjool on the basis of internal adjustment of the teachers to fill the gap of vacant posts in the best interest of Public Service.
- 6. Para No.6 is correct up to the extent that the appellant filed an appeal, but the competent authority has not given any kind of approval, being non-maintainable.

#### **GROUNDS:**

- A:- Para is incorrect. The transfer order dated 08-11-2014 is legal, constitutional and is accordance with rules.
- B:- Incorrect. The appellant has served more than 33 years in the Department Without any complaint on the part of the Department.
- C:- Incorrect as stated above in para-5, the transfer order was made, due to the internal arrangement / adjustment of teachers by the Department and not on political grounds.

- D:- Incorrect, the appellant was conditionally transferred from GGPS Harian Panjool to GGPS Ganda and not on the basis of favoritism to either side of the appellant or provide respondent.
- E:- Incorrect. At the time of transfer of the appellant, the post was occupied by Mst: Kalsoom Jan PST.

It is therefore humbly prayed that the instant appeal may kindly be dismissed.
