

Sir,

That the appellant respectfully submits the following :-

- 1) That the appellant was enlisted as Forester in the Forest Department, Govt: of Khyber Pukhtunkhwa in the year of 1982, for which the appointment office order is attached herewith.
- 2) That during this long tenure of my service no complaint has been received against the appellant and during this 29-30 years unblemished record the superior officers of the department concerned has got no complaint against him nor from public at large, where the appellant was posted for performing his official duties. He always worked hard and entire satisfaction to the superiors of the department and in the best interests of the public at large in accordance with his official duties.
- 3) That it is pertinent to note here that the official concerned is still on adhoc basis and not confirmed as regular official as required by the law and could not promoted to the next higher rank of his job in the department concerned.
- 4) That since 7/8 months ago the Borest Department has announced vacant posts of Deputy Rangers in the daily news papers through an advertisement and in this regards the departmental promotion committee meetings were held/convenened but no result has so far been dig out in this behalf for the reasons not known.

- 8) That the Malakand & Swat Division Foresters have already been promoted in this regards vide order dated 14-05-2012 and their services have also regularized and confirmed, howevef they both are juniors to the present appellant.
