Sir,

With due respect it is stated that I was serving as computer operator in the Finance and Planning section DC Office Kohat. But I was transferred to Kacheri Offices. In compliance I submitted arrival report on 03/03/2014, however on the next day I felt some trouble in skin & backbone therefore, I visited private doctor and after examining, doctor advised me to take rest for some days.

Meanwhile Assistant Commissioner, Kohat telephonically directed me to see him on 12/3/2014. In compliance I attended the Office of Assistant Commissioner, Kohat, on 12/3/2014 and discussed my case with AC and also submitted application for leave on Medical/Personnel ground without pay for 03 months.

Later on I was shocked to see absentee notice in local newspaper on 15/05/2014. As I visited office on 21/5/2014 after bed rest and also submitted application (attached vide Flag A) along with relevant medical record. I also attended office from 21/05/2014 to 26/05/2014. On 26 May 2014 my back pain got worse and I had to visit orthopedic surgeon at DHQ, hospital Kohat & doctor advised me to take bed rest for two weeks. I submitted another application (attached vide flag B) on 26/05/2014 for two week medical leave on medical ground as advised by the doctor.

But surprisingly on 04/06/2014 removal from service order(attached vide flag C) was issued without considering my applications and also fired, rule 9 and rule 4(b) iii of E & D 2011 as mentioned in the removal from service order.

As my case was genuine and in case my superiors were not agreed with my application then they had to conduct an inquiry into the matter which is essential under the rules but neither notice was issued after 26/05/2014 nor conduct any inquiry and direct issue removal from service order, which is against under E & D rules Para 9 which is mentioned in the removal from order is reproduced below:

"Notwithstanding anything to the contrary contained in these rules, in case of willful absence from duty by a Government Servant, a notice shall be issued by the authorized officer through "registered acknowledgement" due cover on his home address directing him to resume duty forthwith. If the same is received back as undelivered or no response is received from the absentee within the stipulated time, a notice shall be published in at least two leading newspapers directing him to resume duty within fifteen days of the publication of that notice, failing which an ex-parte decision will be taken against him. On expiry of the stipulated period given in the notice, the authorized officer shall recommend his case to the authority for imposition of major penalty of removal from service."

In this case I submitted reply on 21 may 2014 in response to 15 May newspaper notice which was not entertained.

Further More I also submitted application for medical leave as advised by the doctor on 26 May 2014. According to KPK government servant rules Para 7 which is reproduced here:

"Leave on M.C. cannot be refused. The sanctioning authority can, however, secure second medical opinion of civil surgeon/Medical Board."

This rule has also been ignored.

And in case if the enquiry was dispensed then under E & D rules, Para 7 sub Para a, b, d: personal hearing & opportunity of showing cause against the proposed action, which is must has also been ignored.

Other than these above Paras, E & D rules, rule 14 Para 2 & Para 4 sub Para a,b,c: has also been ignored and issued removal from service order which is against the E & D rules as well as social justice.

In view of above I request that my removal from service order issued by the DC. Kohat may be set aside and exonerate me from the charges which are baseless and oblige.


