



#### **Preliminary Objections**

- The appellant has no locus standi to file the Appeal in hands.
- II. That the appellant has concealed material facts from this Hon'able Court hence the Appeal in hands is not maintainable.
- The appointment order of the appellant was not in accordance with the prescribed III. manner as provided in the Appointment and Promotion rules.
- IV. That the appeal is badly time barred.
- That the appellant has been estopped by his own conduct to file the instant appeal. V.
- VI. That the appellant has no cause of action.
- VII. That the Hon'able Tribunal has no jurisdiction to entertain the appeal.
- VIII. That the appellant has no come to the court with clean hands.

#### **Facts**

- 1. Incorrect. The appointment order dated 03/11/2012 was not according to the strict codal formalities as it was made in undue haste. A lecturer in (BPS-17) has issued the appointments orders which fall beyond his jurisdiction. Above that this committee has interviewed all these 11 candidates and issued their orders on the same day to the extent that they have taken their charge of offices. Furthermore, a thick cloud of malafide is visible as evident from the inquiry report dated 26/11/2012(Annexure-A) wherein three main objections have been raised by the Inquiry Officers:-
  - There is a variation between the date of requisition of the College Administration for the candidates i.e. 08/10/2012 and provision of the candidates by employment exchange Bannu i.e. 02/10/2012. Another disputed point is that the Manager Employment Exchange, Bannu only sent the same names of those 11 candidates who were later on appointed. However in the eyes of law and procedural experiences he should have sent more than 11 candidates.
  - ii. No call letters to candidates were issued, which is pre-requisite for such like appointments.
  - iii. The DDO being a lecturer in BPS-17 and not an officer of category-II is not competent to issue these appointments orders.
- 2. Incorrect. The DDO concerned was informed to held in abeyance the appointment orders vide Endst No.SO (COLLEGES-II)28-1/2012 dated 05/11/2012 Annexure-D of the appeal.
- 3. Incorrect. The pay was stopped due to the gross irregularities reported to the Provincial Government in the appointments of the appellants.
- 4. Incorrect. His Departmental appeal has been considered and filed being meritless.

#### <u>Grounds</u>

- A. Not admitted. The action of the Respondents is legal, lawful and in the best interest of public.
- B. Not admitted. The appellant is trying to misguide the Court by claiming that he is still performing his duties but, in Para-2 of the Departmental appeal he himself admits that the DDO has stopped his salary and cancelled his appointment order. According to the inquiry report (Annexure-A) supra the appointments orders are made purely on temporary basis and are liable to termination at any time with out any notice or assigning any reason.
- C. Incorrect. Per terms and conditions the appointment of the appellant was liable to termination without serving upon him any notice.
- **D.** Incorrect. The action of the Respondents is according to the law and rules as stated above.
- E. Incorrect. Section -17 of the civil servant act,1973 deals with the seniority of the civil servant and not with the payment of salary, hence denied.
- F. The Respondents also seek permission to advance additional arguments at the time of the hearing of the case.

#### Prayer

The above arguments prove that the appellant has very weak legs to stand upon, hence the appeal in hand may graciously be dismissed.



#### **Preliminary Objections**

The appellant has no locus standi to file the Appeal in hands.

That the appellant has concealed material facts from this Hon'able Court hence the Appeal in hands is not maintainable.

The appointment order of the appellant was not in accordance with the prescribed III. manner as provided in the Appointment and Promotion rules.

That the appeal is badly time barred. IV.

That the appellant has been estopped by his own conduct to file the instant appeal. V.

That the appellant has no cause of action. VI.

That the Hon'able Tribunal has no jurisdiction to entertain the appeal. VII.

That the appellant has no come to the court with clean hands. VIII.

#### Facts ·

iii.

1. Incorrect. The appointment order dated 03/11/2012 was not according to the strict codal formalities as it was made in undue haste. A lecturer in (BPS-17) has issued the appointments orders which fall beyond his jurisdiction. Above that this committee has interviewed all these 11 candidates and issued their orders on the same day to the extent that they have taken their charge of offices. Furthermore, a thick cloud of malafide is visible as evident from the inquiry report dated 26/11/2012(Annexure-A) wherein three main objections have been raised by the Inquiry Officers:-

There is a variation between the date of requisition of the College Administration for the candidates i.e. 08/10/2012 and provision of the candidates by employment exchange Bannu i.e. 02/10/2012. Another disputed point is that the Manager Employment Exchange, Bannu only sent the same names of those 11 candidates who were later on appointed. However in the eyes of law and procedural experiences he should have sent

more than 11 candidates.

No call letters to candidates were issued, which is pre-requisite for such like ii. appointments.

The DDO being a lecturer in BPS-17 and not an officer of category-II is not

competent to issue these appointments orders.

2. Incorrect. The DDO concerned was informed to held in abeyance the appointment orders vide Endst No.SO (COLLEGES-II)28-1/2012 dated 05/11/2012 Annexure-D of the appeal.

3. Incorrect. The pay was stopped due to the gross irregularities reported to the

Provincial Government in the appointments of the appellants.

4. Incorrect. His Departmental appeal has been considered and filed being meritless

#### <u>Grounds</u>

- A. Not admitted. The action of the Respondents is legal, lawful and in the best interest of public.
  - B. Not admitted. The appellant is trying to misguide the Court by claiming that he is still performing his duties but, in Para-2 of the Departmental appeal he himself admits that the DDO has stopped his salary and cancelled his appointment order! According to the inquiry report (Annexure-A) supra the appointments orders are made purely on temporary basis and are liable to termination at any time with out any notice or assigning any reason.
  - C. Incorrect. Per terms and conditions the appointment of the appellant was liable to termination without serving upon him any notice.
  - D. Incorrect. The action of the Respondents is according to the law and rules as stated; above.
  - E. Incorrect. Section -17 of the civil servant act, 1973 deals with the seniority of the civil servant and not with the payment of salary, hence denied.
  - F. The Respondents also seek permission to advance additional arguments at the time of the hearing of the case.
