PRAYER IN APPEAL:

On acceptance of this appeal the condition of FA/FSc from the above noted notification for the promotion of the PST Teacher may please be removed and the promotion may please be granted on seniority-cum-fitness basis.

Respectfully Sheweth:



- 1. That the appellant is belonging to the Education

 Department, all serving on the posts as mentioned

 against his name in the heading of the appeal.
- 2. That the appellant has got at his credit on the above said post a long tenure of service extending over 20 to 40 years.
- 3. That previously the basic qualification for the appointment at the post of PST was fixed as Matric Certificate along with the PST Certificate from a recognized Institution and the appellant appointed on the above said post having the said qualification as was the requirement at the time of the appointment of the appellant.
- 4. That the basic qualification for the post of PST was duly enhanced with basic qualification from Matric to F.A/
 F.Sc in the year 2011 and many other colleagues of the appellants were then appointed on the same posts of PST having their qualification as F.A/ F.Sc alongwith the PST Certificate.

3

- 5. That in the year 2007 a policy of upgradation was promulgated by the than Provincial Government, whereby the PTC, Teachers were upgraded from BPS-07 to BPS-12 on the basis of the length of the service. (Copy of the Notification issued by the Government is attached herewith as annexure "A").
- 6. That again a similar summary was formulated at the initial stage by the Education Department that the PST Teachers will be upgraded to BPS-15 having 22 years service, whereas the teachers having 15 years service will be upgraded to BPS-14.
- 7. That the above said policy was just as according to the justice and demand of the teachers community, however later on the said policy was converted from time scale to the education scale, whereby the promotion policy for the PST Teachers was formulated as under:

"Primary School Head Teacher (PSHT) (BPS-15)

By promotion, on the basis of seniority-cum-fitness from amongst senior primary school teachers with at least 10 years service and having qualification prescribed for initial recruitment of primary school teacher.

Primary School Teacher BPS-14

By promotion on the basis of seniority-cum-fitness from amongst school teachers with at least 05 years service as such and having qualification prescribed for initial recruitment of primary school teachers.

- 8. That thereby all the fresh appointed F.A/ PST have been given the BPS-12, whereas the holders of F.A. Certificate with 10 years length of service may be upgraded/ promoted to BPS-15 and the PSTs with the F.A. qualification having 05 years service may be upgraded to BPS-14. (Copies of appointment letter and Notification dated 13/11/2012 is attached herewith as annexure "B" & "C").
- 9. That the appellant alongwith his other hundreds of the colleagues having their services extending from 20 to 40 years have been totally ignored and have not been given any chance of upgradation/ promotion throughout their professional career inspite of having such a long spotless tenure of service.
- 10. That this attitude of the respondent department to give F.A/F.Sc benefit to the PST teachers with the qualification teachers with Matric over the the qualification has been formulated without any cogent/ legal grounds but just to give benefit to the blue eved teachers of the respondent department, whom have been appointed in their tenure.
- 11. That the appellant is also equally entitled to be upgraded on the basis of his tenure of service and be given the

5 to the

same benefit as it has been given to the other PSTs teachers having the F.A. Certificates, as the higher qualification of F.A. can not be any means made the basis for giving any sort of above said benefit to the teachers.

- 12. That in this respect the appellant has also moved their representation to the concerned authority, thereby explaining their grievance, however no response whatsoever has yet been received by the appellant till the filing of this Service Appeal. (Copy of representation is attached as annexure "D").
- 13. That the appellant got no other efficacious/ adequate now approaches this Hon'ble Tribunal on the following grounds amongst the others:

GROUNDS:

- A. That act of the respondent department, thereby depriving the appellant from the above said benefit of upgradation is illegal, unlawful, without authority/ jurisdiction, as well as being based on the malafide intentions of the respondent department is liable to be set aside.
- B. That since hundred and hundreds of the teachers have been treated in a discriminatory manner and have been

deprived of the above said benefit mere on the ground that they are not having the qualification of F.A/F.Sc is an act unjust and without any reasonable ground, as the basic qualification at the time of the appointment of the appellant was Matric with PST and the basic qualification at the time of the appointment of the benefited teachers were F.A/F.Sc with PST, hence no privilege can be granted to the persons, whom have been appointed on the prescribed qualification.

- C. That the appellant has been serving on the above said since long, whereas the minimum tenure of the service amongst the appellant is 18 years and the maximum tenure amongst the appellant is extended to 40 years and since long the appellant has been waiting for his turn to be promoted/ upgraded to some higher scale, however after having a tenure of such a long legitimate expectations the appellant has been treated unlawfully without any cogent/ solid grounds.
- D. That it is very respectfully submitted it has never happened that in the cases of upgradation/promotion the factor of seniority should be abolished/ ignored totally and the grounds of upgradation/ promotion should be made mere educational qualification, whereas the

upgradation/ promotion has always been made on the basis of seniority-cum-fitness and have never at the basis of higher qualification whatsoever it may be. Furthermore still it is not the higher qualification for the teachers whom have been going thorough get benefit for the above said notification, but with the passage of time as the basic qualification has been raised, hence they have been appointed on the basis of F.A/F.Sc Certificate, which said factor cannot be made a ground for their upgradation to BPS-14/15.

- E. That the said act of the respondent department is not merely illegal as well as unlawful, but is also against the very clear Articles of Constitution of Islamic Republic of Pakistan as engraved in the basic rights of said constitution.
- F. That the appellant has got every right to be treated equally with his other colleagues and closing all the ways of upgradation/ promotion for the appellant is against all the norms of justice as it has been done in the above mentioned notification dated 13/11/2012.
- G. That it will be pertinent to bring into the notice of this

 Hon'ble Tribunal that the above said benefit has also

 been extended to the Clerk's community, whereby the



clerk's even with the Martric Certificate have been upgraded from BPS-09 to BPS-16 and similarly according to other notification dated 24th April, 2012 the Federal Government has been pleased to upgrade the PST Teachers from BPS-09 to BPS-14 including the Matriculate Teachers.

It is, therefore, prayed that on acceptance of this Service Appeal the respondents may please be directed to set-aside the term of:

"having qualification prescribed for initial recruitment of primary school teachers"

and the appellant may please be considered equally for the above said promotion/ upgradation with the other colleagues, whom have been appointed on F.A/F.Sc basis and the above said conditions being illegal, unlawful, unconstitutional and discriminatory may please be deleted from the conditions of promotion of the PST Teachers to the BPS-14/15.

Any other remedy to which appellant is found entitled, in the peculiar circumstances of the case may also be granted.



Respectfully Sheweth:

To

- 1) That education department advertised posts of (PTC) Primary School Teachers and described the qualification as metric PTC certificate.
- 2) That appellants competed for the same and were selected and appointed as PTC/PST (Primary School Teachers) in BPS 7.
- 3) That appellants are serving as teachers (primary school teacher) for the last more than 25 years.
- 4) That appellants served in the said grade for the last more than 25 years and all are serving as Head Teachers.
- 5) That throughout the Province/ Pakistan, rules/ notification was issued for upgradation of those employees who served for 10 years in one grade.
- 6) That viae notification dated 13th November, 2012 respondent held in Column No.19 as under -

"By promotion, on the basis of seniority-cum-fitness, from amongst Senior Primary School Teachers with at least then years service and having qualification prescribed for initial recruitment for Primary School Teacher."

In column No.20 of notification held as under:

"By promotion, on the basis of seniority-cum-fitness, from amongst Senior Primary School Teachers with at least then years service and having qualification prescribed for initial recruitment for Primary School Teacher."

Column No.21 is reproduced as under:-

- "i. Intermediate or equivalent qualification, from a recognized Board with Primary School Teacher Certificate/ Diploma in Education from a recognized Institute; or
- ii. Secondary School Certificate, from a recognized Board in second Division with two years Associate Degree in Education from a recognized University."
- 7) That education department are interpreting column No.19 of said rules by depriving petitioners of Primary School Head Teacher (BPS-15) on the ground that petitioners are lacking F.A, whereas petitioners are continuously performing the duties of Head Teacher for more than 10 years.

That appellants being aggrieved approach your good-self on following grounds.

GROUNDS:

- A) Because appellants are qualified for the post of Primary School Teacher as possessing Metric with PTC which is the requisite qualification for the post in question.
- B) Because appellants are qualified for the post, that is why, appellants, are holding the posts.
- C) Because appellants are holding and occupying the post of Primary School Head Teacher for more than 10 years, therefore, vested right has accrued to appellants and appellants can't be divested of the same.
- D) Because the instant notification dated 13th November, 2012 is to be given effect immediately and it has no retrospective effect. Thus already vested qualification of metric & PTC can't be divested for appellants.

andheo

- E) Because as per principles of Interpretation of statute, retrospective effect is not to be given to a statute unless it is specifically provided in clear words.
- Because as per column No.20, Senior Primary School Teacher F) (BPS-14) is by promotion on the basis of Seniority-cum-Fitness from amongst the Primary School Teachers, and column 19 of the notification prescribes that (PSHT) BPS-15 is by promotion on the basis of seniority-cum-fitness from amongs. Senior Primary School Teacher (BPS-14) with at least 10 years service, and having qualification prescribed for initial recruitment of Primary School Teacher (BSP-12). The last condition needs harmonious interpretation of column No.21 (II) i.e. S.S.C or the initial recruitment qualification at the time of appointment of petitioners or the initial recruitment qualification of Primary School Teacher (BSP-12) needs to be deleted or declared ultra-vires as petitioners crossed Primary School Teacher (BPS-12), Senior Primary School Teacher (BPS-14) are practically working as Head of the Primary School i.e. Primary School Head Teacher (PSHT) BPS-15, thus the qualification of BPS-12 can't be trusted upon them or in other words when promotion is amongst Senior Primary School Teacher (BPS-14) then report to initial recruitment of Primary School Teacher (BPS-12) is not to be made or this reference means qualification which existed at the time of initial recruitment of petitioners i.e. 25/30 years back.
- G) Because as per General Clause Act/ Principles of interpretation of statute, these rules ought to be beneficially interpreted in favor of appellants.
- H) Because if education department succeeded in interpreting the rules with respect to initial qualification in present rules, the young/junior most F.A qualified Teachers are to be promoted as against appellants holding S.S.C + PTC qualification and senior most, equal to the age of Fathers of said F.A qualified Teachers, then appellants shall be made subordinate to his subordinate (F.A qualified) which

is against all canons of justice, service laws, S-8 (seniority), S-9 (promotion) of Civil Servant Act, 1973 and would be ultra-vires.

Because as per General Clause Act, notice is must to the effectees if rules are changed to their disadvantage (Relevant Section 23 of General Clause Act is Annexure "H" and Repeal Chapter of Interpretation of Statute is Annexure "I")

It is, therefore, humbly prayed that on acceptance of this appeal, an appropriate order may please be issued to by putting harmonious interpretation upon column NO.16,19,20 of the notification dated 13th November, 2012 read with qualification prescribed for initial recruitment at the time of entry into service and not the qualification of initial recruitment mentioned in column No.16 of notification dated 13th November, 2012 as it would amount to give retrospective effect to the notification dated 13th November, 2012 with respect to qualification of initial recruitment.

Any other relief deemed fit may also be graciously granted.
