



Meeting of the Standing Service Rules Committee (centralized) was held on 08.08.2023 at 03:00 PM under the Chairmanship of Special Secretary (Regulation), Establishment Department in his office in order to discuss framing of service rules as well as to look into the proposed amendments in the existing service rules of the following Departments:-

- A. Board of Revenue, Revenue & Estate Department.
- 2. Elementary & Secondary Education Department.
- 3. Home & Tribal Affairs Department.
- 4. Zakat, Usher and Women Empowerment Department.

The Chair welcomed participants and formally spelled out the purpose of the meeting. Thereafter, agenda items of the following departments were discussed in detail and the representatives of the departments were asked to brief the forum on their respective agenda items as under.

### Board of Revenue, Revenue & Estate Department.

The representative of Board of Revenue, Revenue & Estate Department apprised the forum that as per existing Service Rules of Tehsildar (BPS-16), fifty five percent (55%) share of promotion on the basis of seniority-cum-fitness goes to Naib Tehsildar, District Revenue Accountant, District Kanungo and Sub-Registrar with at least three (03) years' service as such. However, there is only one (01) post viz. Head Vernacular Clerk (HVC) (BPS-15), in Commissioner Office Hazara having no service structure. It is therefore, imperative that avenue of promotion may be provided to Head Vernacular Clerk (HVC) on account of having the same scale as that of Naib Tehsildar, District Revenue Accountant, District Kanungo and Sub-Registrar; thus the same may be included in the fifty five percent (55%) share for the purpose of promotion of the incumbent to the post of Tehsildar (BPS-16). In the wake of promotion of the incumbent, the post of Head Vernacular Clerk (HVC) shall be abolished as HVC is the only post in the whole Revenue & Estate Department. Sml

One of the members raised a query that in case the post of Head Vernacular Clerk (HVC) is included in the joint seniority list of Naib Tehsildar, District Revenue Accountant, District Kanungo and Sub-Registrar what would be the position of seniority of the incumbent Head Vernacular Clerk (HVC). In reply to which majority of the members opined that in that scenario the incumbent Head Vernacular Clerk (HVC) would be placed at the bottom of the joint seniority list.

### **Elementary & Secondary Education Department.**

#### Agenda No. 01.

The representative of Elementary & Secondary Education Department briefed the forum regarding proposed amendments in the existing Service Rules of the Librarian Cadre following the orders/directions of Hon'ble Peshawar High Court Peshawar in WP No. 668-A/2020, case titled Muahmmad Ayaz etc vs. Government of Khyber Pakhtunkhwa and subsequent approval accorded by Provincial Cabinet in its 6<sup>th</sup> meeting held on 08.06.2023 to the Service Structure under four Tier (4-Tier) formula, the representative of E&SED proposed amendments in the existing Service Rules of Librarian of Elementary & Secondary Education Department under the four Tier (4-Tier) formula.

After threadbare discussion, the forum unanimously agreed to the proposed amendments in the existing Service Rules as per (Appendix-II)

#### Agenda No. 02.

The representative of the Elementary & Secondary Education Department briefed the forum referring to the previous SSRC meeting dated 25.01.2023 for framing of Service Rules for the post of Assistant Programmer (BS-17) wherein E&SED was advised to approach Finance Department for changing of nomenclature of Assistant Programmer into Assistant Director (IT) and re-submit the case in the upcoming meeting of SSRC.

The representative further added that since the said post has been re-designated as Assistant Director (IT) (BPS-17) by Finance Department vide its letter No. SO(FR)/10-22/2023/17-23/E&SED dated 27.03.2023.

After threadbare discussion and deliberation, the forum unanimously agreed upon Service Rules for the re-designated post of Assistant Director (IT) (BPS-17) in Elementary & Secondary Education Department as (Appendix-III)

### e & Tribal Affairs Department.

The Representative of Home & Tribal Affairs Department explained that there are two cells operating under the Administrative Department namely Tribal Research Cell and TA Cell & Wireless Cell, Home and TAs Department. He further added though Service Rules of Tribal Research Cell do exist but too old as the same has not been updated in the wake of upgradation of many posts. Thus, the existing Service Rules need to be amended.

During discussion, it got revealed that the post of Senior Accountant/Supptt as reflected in the Working Paper does not exist in the available copy of budget book. Perusal of available record and ensuing discussion also revealed that there are basically two Cells for which administrative department has proposed combined Service Rules by merging two cells together. Merging of two Cells is not the domain of Standing Service Rules Committee (SSRC) rather the same falls within the ambit of Restructuring Committee.

After threadbare discussion, the forum unanimously agreed to advise the administrative department to move working paper for O&M study regarding restructuring/merging of the two cells and at the same time to take up the case with Finance Department for creation of the post of Senior Accountant/Supptt(BS-17).


