

Prayer in the Appeal:

By accepting the appeal the impugned deduction of pay of four days from the salary of January 2014 made by SDEO (M) Buner, respondent No. 3 may be set aside with direction for due action against the respondents for their unlawful and illegal act and making mockery of service rules/laws, and wasting precious time of the tribunal by unnecessary litigation.

Respectfully Sheweth:

- 1. That I am serving as senior primary school Teacher (SPST) in BPS-14 in Govt. Primary school, Sur Kamar Buner.
- 2. That I am performing my duty with my best zeal, dedication, punctuality and efficiency with no chance of complaint to the high ups and the general public.
- 3. That through a letter No. 82 dated 08/11/2013 the SDEO (M) was directed to keep all the staff of the GPS Sur Kamar under the supervision of the ASDO (M), Ambela Circle to check its punctuality on daily basis for a month (Copy attached at Page No. 5)
- 4. That in this letter the DEO (M) directed the SDEO (M) Buner in violation of the service rules that four (04) days deduction of pay may be made from my salary without no fault of mine and without showing any reason.
- 5. That the SDEO (M) without following the service rules blindly obeyed the order of the DEO (M) and deducted four (04) days salary from my monthly pay of January 2014 (Copy attached at Page No. # 6)



- That then on 27/11/2013 I appealed to the DEO (M) Buner against the act of 6. deduction of SDEO (M) Buner (Copy Attached at Page # 7).
- That the DEO (M) has not responded so far despite the lapse of ninety (90) 7. days statutory period of departmental appeal, hence this appeal with the following

REASONS/GROUNDS

- That I have been performing my duty at GPS Sur Kamar, Buner with punctuality, zeal and efficiency and nothing adverse has ever been proved against me.
- The deduction of pay has not provided in the service rules and it is not 2. provided in the list of penalties of E&D rules 1973 and 2011.
- That I have not been heard before deduction and nothing in this regard 3. has been communicated to me. I got a photo copy of the source 02 with great pain on my personnel efforts on which the deduction has been made.
- That the Supreme Court has declared in the famous Anita Turab Case of 2012 that civil servants are servants of the state and not of the government and they are not bound to obey the unlawful orders of their superiors.

It is therefore, prayed that on acceptance of this appeal the deduction made by respondent No. 3 may be set aside with directions for due action against the respondents for their making mockery of the rules/laws and wasting the precious time of this tribunal by unnecessary litigation.

Reference your letter No 82 dated 08/11/2013 issued under the sign of ADO (Estb) whereby the SDEO has been directed to make me deposit pay for four days for no fault of mine.

From the aforesaid letter it is evident that grave violation of service rules/authority has been committed.

- 1. The ADO (Estb) is not authorized to sign such type of letter without approval of the DEO which does not seem to have been done in the instant case.
- 2. There is no provision either of deduction of pay or deposition of pay through challan. Even there is no provision of stoppage of pay and even it is allowed during suspension in murder case of Sec 302 (CRPC).
- 3. Civil servants are servants of the state and not of the government; they are not bound to obey the unlawful orders of their superiors as narrated by the Supreme Court in the famous Anita Turab case of 2012. I will not obey the unlawful directions carried by the letter mentioned above, and will rather obey the Supreme Court judgment cited above. It is therefore requested that the letter carrying the unlawful directions may be cancelled/ with drawn with strict action against those who violated the supreme court judgment and the service rules. I intend to knock at the door of the court after expiry of the statutory period if no remedy was given to me.
