





- That the appellant was posted as SST (G) at GGHS Baghecha Dheri Mardan when she was transferred to government high school Chamrango Mardan vide 6010/G/SST dated 30/10/2014

- That thereafter a corrigendum order was issued i-e order no 6269/G dated 11/11/2014 with the effect of which appellant being senior was restored to GGHS Baghecha Dheri.

- That seniority list and district list are there according to which appellant Zeenat BiBi is senior most than respondent no 3.

- That again an order no 6464-67 dated 18/11/2014 was issued in which appellant at serial no 7 was transferred to GGHS Chamrango to adjust Zeenat Begum serial no 8 at GGHS Baghecha Dheri.

- That having aggrieved from the order of DEO (F) Mardan appellant submitted representation/Departmental appeal.

- That the representation /departmental appeal in question are still unresponded despite the fact that the statutory period is lapsed.

GROUND

That the impugned order is illegal, unjustified, based on malice, undue influence, undue favoritism and political pressure Hence the same is liable to be set aside on the following grounds.

1. That the post held by the appellant in GGHS Baghecha Dheri was malafidely vacated for Zeenat Begum Respondent no 3.
2. That the said mst Zeenat Begum respondent 3 who used undue political influence and hence the appellant was transferred for adjustment of respondent no 3 at GGHS Baghecha Dheri.
3. That on promotion and posting junior shall be transferred and senior shall retain the same school.

4. That being aware of all these facts and rules DEO (F) malafidely transferred appellant being senior most at serial no 7 while respondent no 3 at serial no 8 junior was left at the same school.
5. That appellant informed DEO (F) respondent verbally but of no avail.
6. That appellant moved departmental appeal /representation to DEO(F) but is yet to be decided .
7. That the appellant seeks leave of this honorable tribunal to claim further grounds.

It is prayed that on acceptance of this appeal the impugned order may kindly be set aside with retrospective effect.

The appellant may also be granted any other relief which this honorable tribunal deems fit in the best interest of justice. The cost of this appeal may also be awarded in favour of appellant against the respondents.
