SUBJECT: PARAWISE COMMENTS ON BEHALF OF RESPONDENTS NO. 1 to 3

Respectfully Sheweth: -

Preliminary Objections:-

- 1. That the appellant has got neither cause of action nor locus standi to file the instant Service Appeal.
- 2. That the appellant has not come to this Tribunal with clean hands.
- 3. That the appellant is estopped by his own conduct to file the instant appeal.

Facts: -

- 1) Correct to the extent that the appellant was appointed as Beshashti (BPS-03) vide appointment Order dated 26/04/2021 at Govt: Degree College, Khanpur, District Haripur and was given responsibilities in the Clerk Office (Annex-A)
- 2) Incorrect. That on 08/12/2022 the respondent no. 3 was informed by the suspicious Branch about Bank **Pakistan** Khanpur National transaction/withdrawals. On probing, the respondent no. 3 came to know that Umair Matloob withdrew an amount of 1324000/- (Thirteen Lac Twenty-Four thousand) illegally from College pupil fund by forged signature of the principal. The respondent no. 3 vide office order dated 09.12.2022 constituted inquiry committee comprising Mr. Tariq Naveed Qureshi, Associate Professor & Mr. Sami Ullah Shah, Assistant to conduct fact finding inquiry (Annex-B). The inquiry committee investigated and record statement of concerned staff members including the appellant wherein the appellant confessed that he has withdrawn the money illegally from college account and also did fake signature of the principals (Annex-C). It is pertinent to mentioned here that the family of the

appellant submitted the illegally withdrawn amount by the appellant the very next day (Annex-D). Statement of the Bank Manager was also recorded wherein he has clearly mentioned that the appellant cashed two Cheque on 08.12.2023 (Annex-E). The Inquiry committee submitted its recommendation on 07.01.2023 (Annex-F). In light of the recommendation of fact finding inquiry committee, the respondent no. 3 initiated formal inquiry against the appellant and constituted inquiry committee vide order dated 10.01.2023 (Annex-G). Statement of allegations (Annex-H) and charge sheet (Annex-I) were served upon the appellant. The appellant submitted the reply wherein he confessed all the charges/állegation (Annex-J). The inquiry committee served upon him the questioner (Annex-K) and the appellant gave confessional statement on oath before the inquiry committee (Annex-L). Show cause was served upon the appellant on 28/01/2023 (Annex-M). The appellant requested for personal hearing (Annex-M) which was provided to him on 06.02.2023 (Annex-N) and after fulfillment of all codal formalities the appellant was removed from service vide notification dated 06.02.2023 (Annex-O)

- 3) Correct, to the extent that charge sheet & statement of allegation were served upon the appellant, rest of the para is misleading, the appellant has confessed the charges/allegations before the inquiry committee as already explained in para 2 and documentary evidence is also attached.
- 4) Correct to the extent that the appellant has been removed from service vide notification dated 06.02.2023.
- 5) Correct to the extent that the appellant filed departmental appeal and respondent no. 2 assigned task to Mr. Waheed Akbar Awan Principal, Govt. Degree College, Ghandaf Haripur vide letter dated 15.06.2023 to conduct fact finding inquire (Annex-P). and the inquiry officer also recommended to regret his appeal (Annex-Q) personal hearing in the said appeal was scheduled on 06.09.2023 (Annex-R)
- 6) Incorrect. That the appellant is not aggrieved as he himself confessed all the allegations/charges.

Grounds: -

- A. Incorrect. As already explained in para 2 of facts, all the codal formalities are fulfilled.
- D. Incorrect. That show cause notice dated 28/11/2023 has been served upon the appellant as already explained in para 2.
- E. Incorrect. That the appellant was part of the disciplinary proceedings he submitted written statement, reply to questioner and personal hearing was also granted to him on 06.2.2023 as already explained in para 2 and documentary evidence is also attached.
- F. Incorrect. As already explained in para 2.
- G. Incorrect. As already explained in para 2.
- H. Incorrect. That the respondent may be allowed to raise additional grounds at the time of arguments

Prayer:-

It is, therefore, humbly prayed that the instant Service Appeal is based on misconception/misstatements hence may graciously be dismissed.

REPORT OF FACT FINDING COMMITTEE REGARDING

IRREGULARITIES IN PUPIL FUND

MEMO:

The committee constituted by principal regarding the above-mentioned subject held several meetings with all concerned staff members to find the facts about irregularities to find the

Foregrounds of Fact Finding:

On 08th December 2022 Principal told the committee that he received a call from NBP khanpur branch that two cheques amounting. Rs. 79000/- and Rs.88000/- brought by Mr. Umair Matloob. (Beheshti) of the college, and the signatures of principal on the cheques are not matching with your specimen signatures.

Principal contacted Mr. Zia ur Rehman (senior clerk who keeps the

cheque book of Pupil Fund a/c) just after receiving this information from bank and instructed him to investigate about these cheques as Principal did not signed any cheque on the same day. When Mr. Zia ur Rehman contacted the bank and inquired about cheques it was confirmed that the signatures on both the cheques are forged.

In the meanwhile Mr. Zia ur Rehman try to contact Mr. Umair Matloob but failing which he contacted to Mr. Haris Matloob (brother of Mr. Umair Matloob) and told him about the situation. He accepted to pay the amount Rs. 167,000/- and handed over to Mr. Zia Ur Rehman. The next day Mr. Zia Ur Rehman deposited the amount in Pupil Fund a/c and got bank statement which showed that different cheques amount Rs. 1,157,000/- were drawn the forged signature and stamp of the DDO / Principal in addition to the amount submitted on 09/12/2022. As the MR. Haris Matloob was along with Mr. Zia ur Rehman in the Bank so Mr. Umair Matloob family accepted and pay the remaining amount Rs. 1,157,000/- after lessening voice massage of Mr. Umair Matloob.

To find the facts and figures Principal constituted a committee comprising the following:

1- Mr. Tariq Naveed Qureshi

Associate Prof: of Physics

2. Mr. Samiullah Shah

Assistant: BPS 16

Member

Committee started his work after a short briefing by Principal about the situation. Committee moved forward in the assignment in the following way. (briefing of Principal is hereby attached in the form of statement as Annexure 1) in light of briefing

167,000/-+1,157,000/-= 1,324,000/- details of cheques having Cheque No., dated and amount is attached with statement of Mr. Zia ur Rehman with the annexure II.

In the mean while Mr. Zia ur Rehman received a Voice massage of Mr. Umair of Mr. Umair Matloob agreed to pay back all the remaining amount of Rs.1,157.000/-on 09/12/2022.

- 3- In his statement Mr. Ashfaq Ahmed told the committee that stamps remain in his draw and all the office members use these stamps according to their need, he told that the stamps on the cheques have been embossed in his absence and he has no knowledge about stamping of these cheques.
- 4- In the statement if Mr. Asif Mehmood Naib Qasid, he stated that he and Mr. Umair Matloob both are working in admin office as Naib Qasid and we both are custodian of offices keys.
- 5- According to his statement, Mr. Umair Matloob admitted of drawing these cheques having forge signatures and have been paid back by him / his family to the College.
- 6- National Bank of Pakistan Khanpur Dam Branch manager Mr. Raja Habib Ahmed stated in his statement that he informed the Principal on 08/12/2022 about last two cheques but manager did not give any details about other 14 cheques cash earlier from bank during 10/11/2022 to 07/12/2022.

Conclusion of the committee.

Committee concludes that:

- 1. An amount of Rs. 1,324,000/- have cashed through different cheques from pupil fund account.
- 2. The amount then recovered and re-deposited in the same account on 09/12/2022.
- 3. These cheques have been taken out from the cheque book along with counter files, by Umair Matloob, and drawn by him using forged signatures of DDO and stamps on various date between 10/11/2022 to 8/12/2022
- 4. The custodian of the Cheque book Mr. Zia ur Rehman did not handled the cheque book professionally.
- 5. All the staff of the College have an open access to use the stamps of the different cadre for attestation of NADRA registration forms and documents attestation etc.

In the light of the above fact finding report, it is suggested that the matter needs to be probed further.




