**JUDGMENT**

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Appellant

alongwith his counsel present. Mr. Muhammad Bilal, Deputy District Attorney

alongwith Mr. Sohail Ahmad Zeb, Assistant for the respondents present.

Arguments heard and record perused.

2. Brief facts of the case as per present service appeal are that the appellant was serving in Education Department as Senior Primary School Teacher (BPS-14). He was imposed major penalty of reduction to lower post from the post of Senior Primary School Teacher (BPS-14) to the post of Primary School Teacher (BPS-12) vide order dated 25.08.2014 on the allegation the he changed his adverse remarks of his ACR in the Log Book for the purpose of his promotion. The appellant filed departmental appeal on 19.09.2014 which was rejected on 23.03.2016 hence, the present service appeal on 20.04.2016.

3. Respondents were summoned who contested the appeal by filing of written reply/comments.

4. Learned counsel for the appellant contended that the appellant was serving in Education Department as Senior Primary School Teacher BPS-14. It was further contended that the appellant was imposed aforesaid major penalty on the allegation that the page of Log Book regarding the ACR of the appellant was found removed and tempered during Inspection of the school. It was further contended that the appellant was issued as show-cause notice on the basis of facts finding inquiry to which he replied and denied the allegation leveled against him. It was further contended that since the major penalty of reduction from the post of Senior Primary School Teacher (BPS-14) to the post of Primary School Teacher (BPS-12) was imposed upon the appellant and the appellant has denied the charge of tempering of his ACR and removing of page of Log Book regarding his ACR in the reply of show-cause notice therefore, the respondent-department was required to conduct full fledged inquiry against the appellant but the respondent department has neither framed or served charge sheet, statement of allegation nor regular inquiry was conducted and only fact finding inquiry was conducted therefore, the appellant was condemned unheard

which has rendered the whole proceeding illegal and liable to be set-aside and prayed for acceptance of appeal.

5. On the other hand, learned Deputy District Attorney for the respondents opposed the contention of learned counsel for the appellant and contended that the appellant was serving in Education Department as Senior Primary School Teacher (BPS-14). It was further contended that he was imposed major penalty of reduction from the post of Senior Primary School Teacher (BPS-14) to the post of Primary School Teacher (BPS-12) on the aforesaid allegation. It was further contended that a fact finding inquiry was conducted wherein the appellant was found guilty and a show-cause notice was also issued to the appellant but the appellant failed to satisfy the competent authority therefore, the appellant was rightly imposed the major penalty of reduction from the post of Senior Primary School Teacher (BPS-14) to the post of Primary School Teacher (BPS-12) and prayed for dismissal of appeal.


6. Perusal of the record reveals that the appellant was serving in Education Department as Senior Primary School Teacher (BPS-14). He was imposed major penalty of reduction from the post of Senior Primary School Teacher (BPS-14) to the post of Primary School Teacher (BPS-12) on the allegation that he had ~~made~~<sup>m</sup> tempered entry of his ACR and removed the page of Log Book pertaining to his ACR. It is well settled law that major penalty cannot be imposed upon a civil servant unless and until a regular inquiry has been conducted against the civil servant but in the present case only fact finding inquiry was conducted against the appellant and on the basis of fact finding inquiry, major penalty of reduction from the post of Senior Primary School Teacher (BPS-14) to the post of Primary School Teacher (BPS-12) was imposed. Although the appellant has totally denied the allegation in the reply of the show-cause notice therefore, the impugned order is illegal and liable to be

set-aside. As such, we partially accept the appeal, set-aside the impugned order and direct the respondent-department to conduct de-novo inquiry in the mode and manner prescribed by Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 including serving of charge sheet, statement of allegation, opportunity of cross examination, issuing of show-cause notice alongwith copy of inquiry report and personal hearing. Parties are left to bear their own costs. File be consigned to the record room.

**FACTS:-**

1. That the appellant was appointed in the Respondents department as PTC in BPS -7 and serving in the respondents department with due diligence since appointment. (Copy of the appointment letter is attached and marked as annexure "A").
2. That the appellant was promoted from BPS-7 to BPS-12 on 01/10/2007 and from BPS -12 to 14 on 29/02/2013.( Copy of the Office order No's are attached and marked as annexure "B"&"C" respectively).
3. That the page of the log book was found removed and tempered during the inspection of school.
4. That show cause notice No 4936/ENo27/vol-II/EB11 dated 18/06/2013 was issued to the appellant which was properly replied by the appellant.(Copy of the

show cause notice and reply is attached and marked as annexure "D"&"E" respectively)

5. That another show cause notice 4838/F.No.27/voll-II dated 14/07/2014 has been issued and the same was also replied by the appellant.( Copy of the show cause notice and reply is attached and marked as annexure "F"&"G" respectively).
6. That respondent No 4 was appointed as inquiry officer to conduct the inquiry of the appellant as well as other teachers.(Copy for the order of inquiry and inquiry report is attached and marked as annexure "H"&"I" respectively)
7. That on 25/08/2014 the respondent No 3 passed an order against the appellant by imposing major penalty by reduction to lower post to BPS-12.(Copy of the order is attached and marked as annexure "J")
8. That the appellant feeling aggrieved from the order dated 25/08/2014 filed departmental appeal on 19/04/2014 and reminders were given by the appellant to the respondent No 1 thereafter appeal of the appellant was rejected vide order dated 25/03/2016.(Copy of the appeal, reminders& order is attached and marked as annexure "K""L" &"M" respectively)

9. That feeling aggrieved from the order dated 25/03/2016 and 25/08/2014 the appellant approaches this honorable tribunal for redressal of his grievances on the following amongst other grounds.

**GROUND:**

- a. That impugned order against the law and facts hence liable to be set-aside.
- b. That the other one Mr Mohammad Saleem who was also reduced to lower rank through same impugned order dated 25/08/2014 was also restored with all back benefits by this honorable tribunal so the appellant has also the right of same treatment.
- c. That that the inquiry and charge sheet against the appellant is baseless having no footings hence impugned order is liable to be set aside.
- d. That inquiry was conducted in the absence of the appellant furthermore no opportunity was provided to cross examine the witness.
- e. That the appellant is innocent having no interest with the removal/tempering of log book and nor he was beneficiary, it is also evident that inquiry officer also declared the appellant innocent.

- f. That there no evidence against the appellant which amounts to the major penalty.
- g. That the Respondent No 2 and 3 have not advanced any reasons while issuing the impugned order.
- h. That under the law, no major penalty can be imposed upon the appellant or any other employee without adopting the proper procedure under the law.
- i. That the impugned order suffers from the principle of natural justice as the same was passed t the back of the appellant without providing any opportunity of being heard to appellant.
- j. That the appellant served in the respondents department with unblemished service record and the same was not taken into consideration while awarding major penalty.
- k. That impugned order is absolutely wrong illegal hence not maintainable and liable to be struck down.
- l. That this honorable tribunal has the jurisdiction to entertain the instant appeal
- m. That other grounds will be agitated with the permission of this Honourable Tribunal at the time of arguments.

## Enquiry Report In Respect of M. Shafique PST

<b>Reference:</b>	I Mr. Abdur Rashid V/P GHSS Nawan Shehr was appointed as an enquiry officer in case of M. Shafique PST, GPS Sher Baai Saidaan Abbottabad vide Endst No. 6102-14/FNo.124/VOL:1/Complaint cell/ Gen: (M) Peshawar dated 28-01-2014 and 10-02-2015 received on 12-02-2015 by hand.
<b>TOR's:</b>	Re-inquiry regarding cutting/tempering/alteration of remarks in Log book and getting up gradation from BPS-12 to BPS-15 through bogus and forged remarks.
<b>Short History:</b>	An enquiry has already been conducted earlier by Khalid Mehmood, Principal GHSS Bandi Dhundan. The appellant has been imposed punishment of reversion to BPS-12 from BPS-15, regarding the alteration in annual remarks of ADO in the log book. Appellant with counsel and Mr. Jamshaid Awan, Assistant alongwith Mr. Muhammad Tahir Aurangzeb, GP for respondents present.

2. The instant appeal has been filed by the appellant Muhammad Saleem PST Jhangi Khoja under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act-1974 against the order dated 25.08.2014 passed by respondent No.3 whereby appellant was reverted from the post of PSHT (BPS-15) to the lower post of PST (BPS-12) He prayed that on acceptance of the instant appeal the order dated 25.08.2014 may be set aside and appellant may be restored on his post PSHT (BPS-15) with all back benefits..

3. Brief facts of the case are that appellant was promoted from the post of PST to PSHT (BPS-15) on 25.02.2013. An enquiry for the charges of removal/alteration in the Log Book was conducted by Mr. Khalid Mahmood Principal GHSS Bhandi Dhundan against two school teachers Mr. Shakeel Ahmad SPST GPS Gojri and Mr. Mohammad Shafique Ex-PST GPS Gojri. The enquiry officer found both the above teachers as well as the appellant involved in the removal of the pages of Log Book which contained adverse remarks made by ADO during inspection of GPS Gojri.



 the impending promotion to higher pay scale/post. Based on the fact  
 finding enquiry the competent authority issued show case notice dated  
 14.07.2014 to the appellant dispensing with formal/regular enquiry. All the  
 three teachers were awarded major penalty of reduction to lower post of  
 PST (BPS-12) vide order dated 25.08.2014. The appellant filed  
 departmental appeal against the impugned order which was not acceded to  
 hence the instant appeal.

4. The learned counsel for the appellant argued that the impugned  
 order was based on malafide and personal grudge and was against the  
 relevant law, rules and justice. That the enquiry was conducted in absence  
 of the appellant. Appellant was not provided opportunity to cross examine  
 witnesses against him. That there was no evidence against the appellant  
 except the fellow teacher who was also charge sheeted and proceeded  
 against. That the appellant was not heard in person before imposition of the  
 major penalty nor was regular enquiry conducted hence opportunity of  
 defense was not provided to the appellant. He further argued that the  
 appellant had denied the allegations and in the circumstances where factual  
 controversy had arisen the holding of formal/regular enquiry could not be  
 dispensed with. He stated that fair opportunity of defense was required to  
 be provided to the appellant to meet the ends of justice. In this regard he  
 relied upon 2006 SCMR 847.

5. The learned Government Pleader resisted the appeal and argued  
 that competent authority acted in accordance with the law and rules by  
 dispensing with holding of formal enquiry as he was in possession of  
 sufficient evidence to penalize the appellant on the basis of findings of the  
 fact finding enquiry. He further argued that proper show cause was served

on the appellant and opportunity of personal hearing was given to him before passing of orders of punishment by the competent authority. He prayed that appeal being devoid of merits may be dismissed. He also denied that any departmental appeal was submitted by the appellant and turned the instant appeal in the Service Tribunal as in competent and prayed that it should be dismissed.

6. Arguments of the counsel for the parties heard and record perused with their assistance.

7. From perusal of the record it transpired that based on the findings of the fact finding enquiry show cause notice was served on the appellant by the competent authority who dispensed with the conduct of formal enquiry. Since imposition of major penalty was intended by the competent authority, it was incumbent on him in the light of verdicts of Superior Courts to conduct regular enquiry and provide full opportunity of defense to the appellant, particularly when the appellant denied the allegations and controverted the facts of the case. The Tribunal is therefore inclined to interfere in the case by remanding it back to the respondent-department for conducting de-novo enquiry strictly in accordance with law and rules and providing full opportunity of defense to the appellant before passing final orders. The enquiry shall be conducted in a period of sixty days. The impugned order is set aside. Back benefits will be subject to outcome of the de-novo enquiry. Parties are left to bear their own costs. File be consigned to the record.

FINDINGS/FACTS	In the light of evidences (material and non material, tangible and non tangible) the enquiry reached to the following findings/facts; 1. In the referred report submitted by the ASDEO regarding the tempering of remarks in log book and tearing off the pages the accused has not been found nominated anywhere as defaulter in clear terms. 2. The notification issued vide Endst: No. 6729-30/F No-27/Vol-II dated 29-7-2015 the enquiry has not been found initiated against the incumbent. It contains two names, i.e Muhammad Shakeel Ahmad and Muhammad Shafique PSTS. 3. Report of ASDEO reveals that the teacher has not been charged directly and indirectly in the matter. Present H.T has also stated that Mr. Saleem's past services & conduct remained good and reliable. 4. He was transferred from GPS Gojri on 28-7-2012 and handed over the record of school along with log book to Mr. Shakeel Ahmad.



	<ol style="list-style-type: none"><li>5. He was promoted /upgraded as PSHT in March, 2013 one year after the remarks recorded in the log book.</li><li>6. The same ASDEO<sup>has</sup> written his ACRs/PERS on the eve of his promotion, where in no adverse remark/poor performance was reflected.</li><li>7. No independent/ separate enquiry initiated/conducted against the said teacher.</li><li>8. He was made part of the enquiry on the statement of Mr. Shafique, who was the main culprit. He involved him just to save his skin by making Mr. Saleem his partner in the misdeed. Whereas he had already been transferred from the school long before the starting of the process of promotion/upgradation.</li><li>9. The enquiry officer went beyond the TORs and included the teacher unlawfully. Rather to request the competent authority for initiation/conductance of enquiry against Mr. Muhammad Saleem. He (the enquiry officer) himself gave recommendation against the teacher without solid evidence and jurisdiction.</li><li>10. The earlier enquiry has been observed misled by Mr. Shafique PST, the main culprit by creating hotch- potch, during the course of enquiry, whereas no concern of the accused has been traced with the matter.</li><li>11. No clear evidence available to the enquiry of the involvement of the Mr. Muhammad Saleem in tempering the remarks and removing the pages from the log book.</li></ol>
<b>PROPOSALS/ SUGGESTIONS</b>	As the charges against the teacher has not been proved due to lack of evidences and documentations. Therefore, it is recommended/ suggested that he may be exonerated of the charges leveled against him and he is recommended for up gradation with retrospective effect along with the back benefits.
