<u>PRELIMINARY OBJECTIONS:</u> <u>RESPECTFULLY SHEWETH:</u>

- 1. That this Hon'ble Tribunal with profound respect has got no jurisdiction to entertain and adjudicate upon the instant appeal.
- 2. That the appellant is estopped by his own words and conduct to file the instant appeal before this Hon'ble Tribunal.
- 3. That the appellant has got no locus standi to invoke the jurisdiction of this Hon'ble Tribunal.
- 4. That the appellant has concealed the entire material facts from this Hon'ble Tribunal.
- 5. That the appellant has not come to this Hon'ble Tribunal with clean hands. Therefore, he is not entitled for any relief from this Hon'ble Tribunal.
- 6. That the appellant has got no cause of action to file the instant appeal before this Hon'ble Tribunal.
- 7. That the appeal is not maintainable in its present form.
- 8. That the instant appeal is based on surmises and conjectures.
- 9. That the appellant is not aggrieved person by virtue of Section-4 of the Service Tribunal Act, 1974. Therefore, the appeal in hand may graciously be dismissed.
- 10. That the appellant has not preferred the Departmental Appeal to the Secretary Home, Khyber Pakhtunkhwa which he referred in his appeal neither the appellant has any proof of it to justify his stance nor any diary number of the Home Department is present/listed on the copy of his Departmental Appeal. Hence, the instant appeal is liable to be dismissed with cost on this count alone.

FACTS:

1. That the appellant was appointed in the Ex-FATA Development Corporation FATA Secretariat and rose up to the post of Senior Scale Stenographer. As evident, the appellant



was the employee of the Ex-FATA Development Corporation, (Irrigation Directorate) of FATA Secretariat whereby he was transferred to Law & Order Department of Ex-FATA Secretariat against the vacant post of Sr. Scale Stenographer (Copy of order dated 27-12-2017 is appended as Annex-R1).). After 25th Constitutional Amendment Act, 2018 the Ex-FATA merged into the Province of Khyber Pakhtunkhwa and the relevant Departments of the Ex-FATA Secretariat were merged in the concerned Departments of the Provincial Government. After merger, meeting of a High Level Committee was held under the Chairmanship of the Additional Chief Secretary Planning & Development Department, Khyber Pakhtunkhwa to decide the fate of the employees of the Ex-FATA Secretariat. In the meeting, it was discussed that 103 posts of Defunct FATA DC working against various posts during assistance of erstwhile FATA Secretariat, have shifted to Provincial Government and out of which 45 have already been placed at the disposal of Home & TA's Department and therefore, the terms and conditions of the Defunct FATA DC employees are different from the Provincial Government posts as these posts were created by the Federal Government and upon their retirement, they will receive gratuity instead of pension and these posts will be abolished on their retirement. Hence, no need to change the status of Defunct FATA DC employees and it was decided that the post of Defunct FATA DC (103 numbers) may be created as supernumerary posts to be abolished on retirement in light of Supreme Court decision. 2. That para-2 is totally incorrect, misconceived and denied. The appellant was given personal upgradation as Senior Scale Stenographer from BPS-16 to 17 by the Ex-FATA Secretariat on 06-03-2014 (Copy of order is appended as Annex-R3). The respondent Department not promoted the appellant to BPS-17 neither he appended any notification of the Department to justify his stance. The respondent Department posted the appellant against different posts in Home Department but due to lack of interest in the official business, his various posting orders have been withdrawn by the Department categorically. In the First instance, the appellant (Sr. Scale Stenographer BS-17) was internally posted as Section Officer (AR/NGOs), Home Department (vide Annex-R4) and relieved from the said post on the arrival of an officer from the Establishment Department on 09-04-2021 and the appellant was directed to report to Addl. Secretary (Law & Order) for his further posting (Copy of order is Annex-R5). Thereafter, the appellant was assigned the charge of the litigation cases relating to the merged areas vide order dated 16-04-2021 (as Annex-R6). Moreover, on 21-06-2022 the appellant was again internally posted as Section Officer (Levies & Khassadars), Home Department but his performance over the post was not satisfactory and as such, the Competent Authority (Home Secretary, Khyber Pakhtunkhwa) directed him to report to the Office of the Section Officer (General), Home Department vide order dated 14-04-2023 (vide orders appended as Annex-R7 & Annex-R8). The General Branch of the respondent department posted the appellant in Provincial Crisis

- & Management Cell (PCMC), Home Department vide order dated 16-05-2023(Copy of order is appended as Annex-R9).
- 3. Detail reply alongwith complete record offered in Para-01 & Para 02 above.

- 10. That Para-10 needs clarification to the extent that the appellant was assigned the look after charge of the post of Section Officer (Plan/Scheme), Home Department in lieu of maternity leave granted in respect of an officer w.e.f 10-05-2023 to 08-08-2023 vide order 18 May, 2023. (Copy of order is appended as Annex-R10).
- 11. That Para-11 is incorrect and denied as the appellant has not preferred the Departmental Appeal to the Secretary Home, Khyber Pakhtunkhwa which he has referred in his instant appeal neither he has any proof of it to justify his stance nor any diary number of the respondent department is present/listed on the copy of his Departmental Appeal. Hence, the instant appeal is liable to be dismissed with special cost on this count alone.

GROUNDS:

- A. That para-A is incorrect and denied as the respondent department has treated the appellant in accordance with the provisions of Article 04 read with Article 25 of the Constitution of Islamic Republic of Pakistan, 1973 and he has never been treated differently. Detail reply offered in Para 01-Para-2 of the facts.
- B. Same reply as given in Para-A.
- C. That para-C is incorrect, misconceived and denied as the appellant has not been posted by the Establishment Department nor he is the employee of the Establishment Department. His all posting was made internally by the respondent department. Detail reply furnished in Para-01 & Para -02 of the facts.
- **D.** That Para-D is also incorrect and misconceived. Detail service record of the appellant is already discussed in Para-1 & Para 2 of the facts.
- E. That Para-E needs clarification to the extent that other staff members alongwith the appellant filed a joint writ petition bearing No.3261-P/2021 titled "Amir Nawaz & others VS Govt. of KP through Chief Secretary & others" for seeking promotion under FATA Cooperation Regulation Act, 1970. The Hon'ble PHC disposed of the petition and directed the Government to constitute a High Level Committee to look into the grievances of Petitioners. In compliance of the aforesaid judgment, the Provincial Government of Khyber Pakhtunkhwa notified the Committee respectively. (Copy of judgment of the Peshawar High Court, Peshawar and notification are appended as Annex-R11 & R12). It is also pertinent to mention herein that the appellant has already been granted





personal upgradation on 06-03-2014 vide Annex-R3 already appended vide Para-2 of the facts.

- F. Reply to the contempt petition bearing No.236-P/2023 in writ petition No.3261-P/2021 has been submitted before the Hon'ble Peshawar High Court, Peshawar and the matter is pending adjudication before the Hon'ble Court. (Copy of reply to the contempt petition is appended as Annex-R13).
- G. Same reply as given in Para-A above.
- H. Same reply as narrated in Para-A
- I. Same reply as offered in Para-01 & 02 of the facts.
- J. That para-J is incorrect. The up-highs of the respondent department were not satisfied with the performance of the appellant and hence, treated him accordance with law and rules.
- K. Detail reply alongwith complete record offered in Para-01 & Para-02 of the facts.
- L. Same reply as given in Para 01-Para 02 of the facts. In addition, on the arrival of the officer from the Establishment Department, Khyber Pakhtunkhwa the respondent No.4 is relieved from the look-after charge of the post of Section Officer (Levies & Khasadar) vide order annexed as R14.
- M. That after seeking permission of this Hon'ble Court, the respondent will also add some additional grounds during the course of arguments.

PRAYER:

In view of the above narrated facts and grounds, it is, therefore, most humbly prayed that on acceptance of the instant parawise comments, the appeal in hand may very graciously be dismissed with special cost for the concealment of material facts by the appellant in the interest of justice.



to change the status of defunct FATA-DC employees. The chair further informed the participants that there is no issue of these posts.

- The adjustment of FATA Tribunal staff was also discussed in detail. It was informed that the staff of FATA Tribunal neither has been placed at the disposal of Establishment Department nor at the disposal of Home & T.As Department. It was also informed that most of the employees of FATA Tribunal are in the BS-01 to 16 and their further adjustment may be made in accordance to their respective domicile Districts.
- After detailed discussion, the following decisions were made:
 - The posts of defunct-FATA DC 103 numbers may be treated as supernumerary post to be abolished on retirement. The incumbents will receive gratuity in light of the Supreme Court decision.
 - The employees of FATA Tribunal may be adjusted/ placed at the disposal of their respective districts of their domicile.
 - iii. Regular staff or the Provincial Government in ex-FATA Secretariat, FDA and FATA Tribunal will report to their respective Administrative Departments.
