PRELIMINARY OBJECTIONS:

- 1. That the appellant has got no cause of action against the answering respondents.
- 2. That the appellant has concealed material facts from this august tribunal.
- 3. That the appellant is estopped by his own conduct.
- 4. That the instant appeal is badly time barred.
- 5. That the instant appeal is not maintainable in its present form.
- 6. That the instant appeal is barred by law.
- 7. That the appellant has not come to this tribunal with cleans hands.

FACTS:-

1. Para No. 01 is correct to the extent that the Petitioner was inducted in the District Judiciary, Dir Lower as Naib Qasid on. 31.03.2005 (Annex-A) while rest of the para is incorrect. The said official was dismissed from service due to inefficiency, misconduct and habitual absence from duty without prior approval of the competent authority vide Order No. 10 dated 14-03-2023. (Annex-B) 2. Para No. 02 is incorrect. The official remained absent from duty for two days i.e. 18.01.2023 and 19.01.2023 without any prior permission of the competent authority. Moreover, the said official was in the habit of arriving late and leaving the Court/duty before closing hours without permission of the concerned presiding officer and was several times orally warned to mend his ways but the said official always neglected the directions. Moreso, his behaviour towards his officer is below the mark.

Para No. 03 is incorrect. The concerned Presiding Officer 3. called an explanation from the said official on 20-01-2023 (Annex-C) to which the said official replied on 21-01-2023 along with medical prescription stating that he was not feeling well (Annex-D & E), however, the said official failed to explain his position with respect to the prior leave application as well as arriving late and leaving the Court early without prior permission from the concerned Presiding Officer. The reply was found unsatisfactory and the complaint was forwarded to the respondent No. 02 which was entrusted to respondent No. 03 for necessary action in accordance with law on 23-01-2023 (Annex-F). On 31.01.2023, the Respondent No. 03 has suspended the delinquent official from service for ninety days under section 6 of Khyber Pakhtunkhwa, Government Servants (Efficiency and Discipline) Rules, 2011 vide Office Order No. 236-40 dated 31-01-2023 (Annex-G). Thereafter, departmental inquiry was initiated, a Charge Sheet was framed and the statement of allegations was served upon the accused/official on 02-02-2023 (Annex-H & I).

4. Para No. 04 is correct. The delinquent official submitted his reply to the Charge Sheet and statement of allegations on 06-02-2023. Thereafter, the concerned Presiding Officer i.e Civil Judge, Lal Qilla was summoned, and he appeared and recorded his statement on 10.02.2023 as IW-I. The delinquent official was given the opportunity to cross examine the complainant, but he opted not to cross examine him. On 14.03.2023, the delinquent official was personally heard, and in this regard, his statement was recorded. He was also given an

opportunity to produce evidence in defense but he chose not to do so. (The statement of the Judicial Officer is **Annexure-K** while statement of the delinquent official is **Annexure-L**).

Para No. 05 is incorrect. As mentioned earlier, the statement of 5 the learned Civil Judge, Lal Qilla and that of the delinquent official was recorded on 10-02-2023 and 14.03.2023 respectively. The inquiry report was submitted by the Inquiry Officer/Respondent No. 03 on 07.03.2023 (Annex-M) and Final Show Cause notice bearing No. 433/SCJ (Admin) was also issued to the delinquent official on same date (Annex-N). The said official submitted his reply to the Show Cause notice within seven days on 11-03-2023 (Annex-O) which was found insufficient and unsatisfactory. After observing formal legal formalities, the said official was awarded major penalty of dismissal from service under rule 4(1)(b)(IV) of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 (Annex-P) vide Order dated 14-03-2023. It is important to note that the delinquent official was provided with ample opportunities to defend and explain his position throughout all the proceedings.

- 6. Para No. 06 is correct.
- 7. Para No. 07 needs no reply.

GROUNDS:-

 \mathcal{I}_{2}

- **A.** Para No. 'A' is incorrect. The delinquent official was dismissed from service after fulfilment of all mandatory and essential codal formalities.
- **B.** Para No. 'B' is incorrect. A proper and thorough inquiry was conducted against the delinquent official. The said official was given every possible opportunity and a chance to record evidence and defense, but he chose not to produce any evidence in defense (Annex-Q). That Respondent No. 03 was appointed as Inquiry

Officer by the Respondent No. 02 and Respondent No. 03 impartially conducted the inquiry proceedings and submitted his report after observing codal formalities.

- **C.** Para No. 'C' is incorrect. The delinquent official was personally heard and was also given sufficient opportunities to defend himself.
- **D.** Para No. 'D' is incorrect. No illegality was committed by the Respondent No. 03 and a Show Cause notice was issued to the appellant on 07-03-2023 and consequently appellant was dismissed from service vide Order dated 14-03-2023 which is well within specified period as mentioned in the Show Cause notice.
- **E.** Para No. 'E' is incorrect. Proper and fair inquiry was conducted against the delinquent official.
- **F.** Para No. 'F' is incorrect. The dismissal order is legal and all legal formalities were fulfilled during inquiry.
- **G.** Para No. 'G' is incorrect. The attitude and conduct of the said official was not serious toward his official duties, and he submitted a fake and bogus medical prescription after the concerned Presiding Officer called for his explanation due to his unauthorized absence from duty. Moreso, such like officials should be removed from judiciary. The actions taken by the appellant caused disastrous consequences for the department. The foresight of deterrent punishment given to the appellant is not only to maintain balance with the seriousness of the wrongdoing but also to set an example for others as a preventive measure for reformation of the society's trust upon judiciary. The appellant was found guilty; hence he could not be set free or exonerated.
- H. Para No. 'H' is incorrect. The delinquent official was habitually, found absent from his duties. The available record clearly shows that the said official remained absent for two days (18-01-2023 to 19-01-2023) from duty prior to the date of explanation 20-01-2023.
- I. Para No. 'I' is incorrect. The dismissal order is legal and specific dates of absence were mentioned in the Show Cause notice dated 07-03-2023. That the appellant has been proceeded against as per law.

- J. Para No. 'J' is incorrect. Imposition of penalty of dismissal from service is correct as the delinquent official was found to be guilty of "Misconduct" due to his willful absence from duty.
- **K.** Para 'K' is incorrect. The service record of the delinquent official was not satisfactory while dozens of oral complaints have been received against him.
- L. Para 'L' is incorrect. The attested copies of the documents were delivered to him within time.

In view of above it is humbly prayed that the entire proceeding against the appellant have been conducted as per procedure and law by adopting the legal procedure and he has rightly been dismissed from service, hence the appeal in hand is liable to be dismissed.




Accused official in person present. Written reply to show cause notice already submitted. The accused official was personally heard and a summary of his personal hearing was also prepared today and placed on file.

The learned Civil Judge Lal Qilla submitted written complaint/letter No.96 on 23-01-2023 to the Hon'ble District & Sessions Judge Dir Lower. The allegations in the complaint were that the Naib Qasid namely Gul Raheem attached to the Court of Civil Judge Lal Qilla was found absent for two days without any application of leave or any permissions of concerned officer/Civil Judge/JM Lal Qilla. It was also noticed that he always arrives late and leave the Court early before closing hours without permission of the said officer. In this regard the said officer several times orally warned him, but he consistently neglected the orders/directions of said officer. Moreover, on the visit of Hon'ble D&SJ to the Lal Qilla dated 19.01.2023, lawyers' community and honorable judges reported that as routine he is late comer and often remain absent from his duties without taking leave.

The Hon'ble District & Session Judge Dir Lower marked the said letter/complaint to the undersigned for immediate action. Since the track record of the official was not good. The undersigned was communicated many times by learned Civil Judge Lal Qilla that he remains absent from duties. He was even transferred to Lal Qilla on complaints of being not dutiful and punctual. Whereupon the accused official was immediately suspended vide order No.236-40/SCJ/Admin Dir Lower dated 31.01.2023. Thereafter, on 02.02.2023 charge sheet and statement of allegations framed and copy handed over to the accused official. Therefore, the said official submitted his written reply dated 06.02.2023. Whereupon the undersigned concluded that reply of said official is not satisfactory. Hence, notice for date 10-02-2023 was issued to the learned Civil Judge Lal Qilla for recording his statement.

Statement of Ijaz-Ul-Haq learned Civil Judge Lal Qilla (complainant) was recorded as IW-1. Which fully support the complaint/allegations filed by him. After statement full fledge,




opportunity was provided to the said accused official for crossexamination. However, the accused official did not want to crossexamine the witness. To this effect his statement recorded, and his signature was obtained. Which shows that the accused official has admitted all the charges levelled against him and he has nothing to defend himself with. The undersigned/inquiry officer conducted inquiry in the matter and prepared report on 07.03.2023.

The inquiry officer/undersigned recommended that the accused official has been found guilty of inefficiency, misconduct and habitually absenting himself from duty without prior approval of leave under sections 3(a)(b)(d) of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules. 2011. Therefore, major penalty of dismissal from service be awarded to the accused official under rule 4(1)(b)(iv) of the ibid rules.

In view of inquiry report and recommendations, the accused official was issued show cause notice on 07.03.2023. The accused official submitted reply of show cause notice on 11.03.2023. He was personally heard and a summary of his personal hearing was also prepared on 14.03.2022.

After perusal of the complaint, written replies of accused official and inquiry report, undersigned is of the view that the allegations contained in the complaint of learned Civil Judge Lal Qilla and formally laid before the accused official in the form of Show Cause notice constitute the pointes for determination for this proceeding against the accused official. The undersigned is satisfied that the accused official is guilty of inefficiency, misconduct and habitually absenting himself from duty without prior approval of leave.
