- 6. Through this appeal, the appellant seeks transfer and posting of her own choice. There is no original or appellate order from which the appellant could be said to have been aggrieved. The authority is not bound to give choice posting to a civil servant. Similarly, a civil servant cannot invoke the jurisdiction of the Tribunal to seek a direction to the authorities for posting against choice post.
- This appeal being devoid of any merit, dismissed. 7. Consign.

JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: The facts gathered from the memorandum and grounds of appeal are that the appellant was appointed as PST (BPS-12) and was posted at GGPS Kalsoona Mada Khail, District Torghar vide order dated 11.03.2015. Accordingly, her services were regularized in the year 2018 w.e.f the date of her appointment. She was serving there. After serving for four years, in the said school, she requested to the authorities for her transfer to the area near the road, but her request was refused and on proposal of SDEO (Female), the appellant was transferred to Savay Narang vide order dated 13.08.2018, which was also hard area.

- 2. Feeling aggrieved, she filed departmental appeal but fiasco, hence, she filed the instant service appeal
- 3. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeals by filing written reply raising therein numerous legal and factual objections. The defence setup was a total denial of the claim of the appellant.
- 4. We have heard learned counsel for the appellant and learned Deputy District Attorney for the respondents.
