
**APPLICATION FOR EXEMPTION OF COST OF RS 2000/- VIDE ORDER DATED

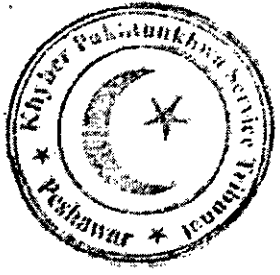
