PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action/locus standi to file instant appeal.
- 2 That the appellant is not an aggrieved person within the meaning of Section-4 Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article-212 of the constitution of Islamic Republic of Pakistan 1973.
- 3 That the appellant has concealed material facts from the ambit of this Honorable Tribunal.
- 4 That the appellant has not come to this Honorable Tribunal with clean hands.
- 5 That the appeal in hand is based on mala fide intentions for gaining illegal service benefits from the Department for her promotion against the Instructor Physical Education (IPE) in BPS-17 in violation of the Rules & policy in vogue.
- 6 That the appeal in hand is barred by law and limitation.
- 7 That the appeal in hand is bad for mis-joinder and non-joinder of the necessary parties.
- 8 That aggrieved from the Notification dated 05-04-2022, the appellant has filed a time bared Departmental appeal to the Respondent Department which was seen & filed on the grounds of limitation as well as violative of the Law & Rules.
- 9 That the appellant is not entitled for anti-dation of promotion to the post of IPE in BPS-17 w.e.f 20-10-2020 in BPS-17 under the relevant provision of APT Rules 1989 in the Respondent Department.
- 10 That the appellant has not the prescribed qualification of B.Ed mandatory for promotion to the post of IPE BPS 17 as evident from his B.Ed Degree obtained from AIOU Islamabad under Roll No. BY674369 with result declaration date of 21-01-2022, whereas, the DPC Meeting was held on 11-06-2020 which is prior to the date of passing B.Ed by the appellant.



ON FACTS.

- 1 That Para-1 pertains to the service record of the appellant against the PET in BPS-09 post vide order dated 22-10-1989 in the Respondent Department.
- 2 That Para 2 pertains to the academic record of the appellant regarding diploma of PET in 1991, JDPE in 2018 from different institutions of the country.
- 3 That Para 3 is also correct to the extent of Notification dated 28-02-2013, whereby, the appellant was promoted to the post of SPET BPS-16 attached as Annex-A.
- 4 That Para 4 is correct that vide Notification dated 24.07-2014 formal service Rules for DPE in BPS-17 were notified vide S.No. I/A, by the Respondent Department to the extent of:
 - a) By promotion from SPET BPS-16 to DPE BPS-17 on regular under the ratio of 50% by promotion on the basis of seniority cum-fitness amongst the SPETs with at least 05 years' service as SPET in BPS-16.
 - b) 50% by initial recruitment, however, the nomenclature DPE was changed to the IPE in the revised service Rules dated 26-04-2018 with further amendments of 70% by promotion & 30% by initial recruitment copies of both the service Rules are attached as Annex-B & C.
- 5. That Para 5 pertains to the record of the letter dated 23-07-2019, whereby, files for promotion to the post of IPE in BS-17 were forwarded to authority concerned for necessary action.
- 6. That Para-6 is correct that vide Notification dated 20-10-2020 at about 10 SPETs in BPS-16 have been promoted to the post of IPE in BPS-17 on regular basis in terms of their respective service record in the custody of the Respondent Department, wherein, the appellant was not promoted to the IPE in BS-17 post on the grounds of lack of the required qualification of B.Ed which is mandatory for promotion to the post of IPE BPS 17 as evident from his B.Ed Degree obtained from the AIOU Islamabad under Roll No. BY674369 with his result declaration date of 21-01-2022, whereas, the DPC Meeting was held on 11-06-2020 for promotion to the post of IPE in BS-17 which is prior to the date of passing B.Ed by the appellant. (Copies of the Notification dated 20-10-2020 & B.Ed Degree of the appellant are Annex-D & E).
- 7. That Pra-7 is also incorrect as the appellant has not the prescribed qualification of B.Ed at the time of DPC Meeting & final Notification as referred above, whereas, the question of seniority maintained by the Department under section-8 of Civil Servant Act of 1973 read with Rule-17 of APT Rules, 1989 does not accrued any vested/legal right of promotion to the post of IPE in BS-17 to the appellant under the service Rules & policy as cited above by the Respondent Department.
- 8. That Para-8 is also incorrect as the act of the Respondent Department with regard to the Notification dated 05-04-2022 is legal & liable to be maintained in favor of the Department in view of the above made submissions by the Respondent Department in the instant Reply.
- 9. That Para-9 pertains to the record.

10. That Para-10 is incorrect & denied in view of the fore made facts of the case submitted by the Respondents in the instant reply as that the appellant is not an aggrieved person within the meaning of Section-4 Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article-212 of the constitution of Islamic Republic of Pakistan 1973 therefore, the case in hand is liable to dismissed on the following grounds inter alia:-

ON GROUNDS.

- A. <u>Incorrect & not admitted</u>, the appellant has been treated as per law & rules by the Respondent Department vide Notification dated 05-04-2022 by not promoting them to the post of IPE BS-17 under the Rules & policy in vogue.
- B. <u>Incorrect & not admitted</u>. The stand of the appellant is against the facts & legal proposition made by the Respondents in the fore going paras of the present reply which is according to the provisions of Articles 4 & 25 of the constitution of 1973, hence, the plea of liable to be rejected.
- C. <u>Incorrect & not admitted</u> the appellant has been treated as per law & rules by the Respondent Department vide Notification dated 05-04-2022 by not promoting them to the post of IPE BS-17 under the Rules & policy in vogue.
- D. <u>Incorrect & not admitted</u>. The act of the Department is legal with no discrimination to words the appellant in the titled case & even according to the provision of sections 8 & 9 of the Civil Servant Act, 1973 & Rule-7 & 17 of Khyber Pakhtunkhwa APT Rules-1989
- E. <u>Incorrect & not admitted</u>. The Notification dated 05·04·2022 is according to the provision of Article 38(e) of the constitution of 1973 not applicable upon the case of the appellant under the rules, criteria policy in vogue.
- F. <u>Incorrect & not admitted</u>. The stand of the appellant is illegal as he is not entitled for promotion as IPE in BS-17 under the rules.
- G. Incorrect & not admitted. That the appellant is not an aggrieved person within the meaning of Section 4 Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article 212 of the constitution of Islamic Republic of Pakistan 1973, However, the Respondents also seek leave to this Learned Bench to submit additional grounds record & case law at the time on date of hearing.

Therefore, in view of the above made submissions, the appeal in hand may kindly be rejected in favor of the Department in the interest of justice.




