- 4. Learned counsel for the appellant has argued that the appellant was entitled to promotion on notional basis as he was found entitled to such promotion and was so recommended but no notification regarding his promotion was issued constraining him to prefer departmental appeal followed by the instant service appeal.
- 5. Learned Addl. Advocate General representing the respondents has argued that since the appellant stood retired from service before issuance of notification as such the same was not issued by the authority.
- 6. We have heard arguments of learned counsel for the parties and perused the record.
- 7. We deem appropriate to reproduce the relevant para from the minutes of Provincial Selection Board held on 07.01.2014:
 Note:

As the retired officer at S.No. 7 of the panel was recommended for promotion on notional basis on the ground that the vacant posts were available on the date of his retirement."

The Board recommended the officer for promotion to BS-20 on notional basis from the date of his retirement.

8. We have consulted the record placed before us and have come to the conclusion that no action whatsoever was taken on the recommendations made by the Provincial Selection Board referred to above. We therefore deem it appropriate to direct that the authority shall consider the said recommendations of the P.S.B and pass any order deemed, appropriate regarding notional promotion of the appellant within a period of 30 days from the date of receipt of this judgment. The appeal is accepted in the above terms. Parties are left to bear their own costs. File be consigned to the record room.

Respectfully Sheweth:

That brief facts and grounds giving rise to the instant Service Appeal are as under;

1. That the appellant as an Officer of the School administration at BPS-18 was regularly promoted to BPS-19 with effect from 26-12-2003 vide Notification bearing No. S.O (S) 1-2/2004/B-18 to B-19 dated 09-02-2004 issued by Respondent No.3.

(Copy of the Notification is annexed as Annexure-"A")

- 2. That since date the appellant performed his duty with excellent service record till 29 -12-2013 but due to miscellaneous reasons he remained on the same basic scale for about more than 10 years. It is pertinent to mention here that several posts of BPS-20 were lying vacant during his qualified service.
- 3. That according to applicable policy issued by Respondent No.2 vide Notification bearing No. SO (G)/S & LD /1/2003 Vol–II dated 09-04-2004 and 04-05-2009 respectively; the appellant was duly qualified for promotion to BPS-20.

- 10. That on 23-6-2014 the appellant also filed a departmental appeal to Respondent No.1 but in vain.

11. That on 18-10-2014 the appellant filed a Writ Petition bearing No.WP.No.3146-P/2014 before the Peshawar High Court Peshawar, which was disposed on 02-04-2015 and the attested copies provided on 09-02-2015, whereby the appellant has been asked to approach this honourable Tribunal.

The Respondents submit as under:-

Preliminary Objections:-

- That the appellant is not an aggrieved person within the meaning of Article
 212 of the Constitution of Islamic Republic of Pakistan 1973.
- 2. The appellant has got no cause of action/ locus standi.
- 3. The instant appeal is badly time barred.
- 4. The appellant has concealed the material facts from this Hon 'able Tribunal, hence is liable to be dismissed on this score.
- 5. The appellant has not come to this Hon 'able Tribunal with clean hands.
- 6. The appellant has filed the instant appeal on malafide intentions just to pressurize the Respondents for illegal service benefits.
- 7. The present appeal is liable to be dismissed for mis-joinder & non joinder of necessary parties.
- 8. The instant appeal is against the prevailing law and rules.
- 9. The appellant is estopped by his own conduct to file the instant appeal.
- 10. The instant appeal is not maintainable in its present form and also in the present circumstances of the issue.
- 11. That the Notification dated 17-03-2014 is legally competent and liable to be maintained in favour of the Respondents.
- 12. That the instant Service Appeal is bared by Law, Rules & Policy.
- 13. That the grant of promotion is not a vested right of the Appellant.
- 14. That the Appellant has got retired from service on 29-12-2013 prior to the issuance of the impugned Notification dated 17-03-2014.
- 15. No Departmental Appeal against the impugned Notification has been filed by the Appellant.

FACTS.

- 1. Para-1 needs no comments being related to the Service record of the appellant.
- 2. Para-2 is incorrect & mis-leading on the grounds that the Appellant has got retired from Service on 29-12-2013 against the Principal post in BS-19 prior to the issuance of impugned Notification dated 17-03-20914, hence his case was not considered for the grant of promotion in BS-20 in the Respondent /E&SED as per meeting of the PSB held on 07-01-2014 for the purpose of

- grant of promotion to the officers of E&SED from BS-19 to Bs-20 against the 24 vacant posts. (Copy of the PSB Minutes is Annex-A)
- 3. That Para-3 is incorrect to the extent that there were 24 vacant position BS-20 of Teaching Cadre and on the basis of the said vacant posts, the Respondent No. 1 has prepared and submitted working papers of 74 officials of the said cadre working in the Respondent Department of E&SE in BS-19 including the Appellant in which 29 candidates/officials have been declared as fit/eligible for the grant of promotion in BS-20 Teaching Cadre against the Principal Post for the purpose of Provincial Selection Board meeting held on 07-01-2014 who recommended 24 eligible candidate for the grant of promotion in BS-20 vide impugned notification dated 17-03-2014 issued by the Respondent NO. 1. However the Appellant has got retired from service on 29-12-2013 in BS-19 against the Principal post prior to issuance of the impugned Notification dated 17-03-2014 by the Respondent No. 3 in light of the recommendations of the PSB meeting in the interest of public service with immediate effect.(copy of the impugned Notification is Annex-B).
- 4. That Para-4 is correct to the extent that the working papers were prepared by the Respondent No. 3 and on the basis of the said working papers, the PSB meeting was held on 07-01-2014 wherein the cases of the above mentioned 74 officials of BS-19 were discussed and considered and consequent upon the said meeting, the Respondent No. 1 has been pleased to recommend 24 eligible officials of Teaching Cadre for the grant of promotion in BS-20 post against the Principal post in the Respondent Department of E&SED wherein, the Appellant could not be recommended on the grounds that he has got retired from the service on 29-12-2013 prior to the issuance of the impugned Notification dated 17-03-2014 issued by the Respondent No. 3 in the interest of public service and with immediate effect.
- 5. That Para-5 is incorrect and denied. Detailed reply of this para has already been given in Para-4, hence needs no further comments.
- 6. That Para-6 is incorrect and mis-leading the PSB has acted as per Law, Rules and criteria vide its meeting held on 07-01-2014. Therefore the plea of the Appellant in this para is also without any force and legal justification, hence denied.
- 7. That Para-7 is incorrect and denied, the Respondent No.1 acted as per Law, Rules & Policy hence the plea of the Appellant is also liable to be struck down of being merit less and without any legal footings on the grounds that he has got retired from service on 29-12-2013 against the Principal post in B"S-19 prior to the issuance/the impugned Notification dated 17-03-2014 issued by the Respondent No. 3 in the interest of public with immediate effect.
- 8. That Para-8 is correct to extent that the Respondent No. 3 has been please to issue the impugned Notification dated 17-03-2014 of the eligible

- candidates/officers for the grant of promotion in BS-20 in the E&SE Department in the interest of justice.
- 9. That Para-9 is correct that the Respondent No. 3 has issued the impugned Notification dated 17-03-2014 excluding the Appellant on the grounds that he has got retired form the service on 29-12-2013 against the Principal post in Bs-19 prior to the issuance of the impugned Notification dated 17-03-2014, hence he not entitled fro the grant of notional promotion along with service benefits in BS-20 in the light of relevant rules and policy hence the plea of the Appellant is liable to be dismissed in favoaur of the Respondents in the interest of Justice.
- 10. Para-10 is also incorrect and denied, No Departmental Appeal has been filed by the Appellant against the impugned Notification dated 17-03-2014, hence the plea of the appellant is meritless & is liable to be dismissed.
- 11. Para-11 is correct to the extent that the Appellant has filed a writ petition No. 3146-P/2014 before the Hon'able Peshawar High Court Peshawar which was dismissed vide judgment dated 02-04-2015 under the mandatory provision of Article 212 of the Constitution of Islamic Republic of Pakistan 1973 in favour of the Respondents .(Copy of the judgment is Annex-C).
- 12. Para-12 needs no comments. However, the Respondents further submit on the following grounds inter-alia.

GROUNDS.

- A. Incorrect and denied: The appellant has been treated as per law, rules and policy vide impugned Notification dated 17-03-2014 issued by the Respondent No. 3 in the light of the recommendations of the PSB meeting held on 07-01-2014, hence the statement of the Appellant in this ground is against the law and facts of the case.
- B. Incorrect and denied, the Appellant has got retired from service on 29-12-2013 hence, the statement of the Appellant in this para is against the Law and facts as mentioned in foregoing paras of the instant reply on behalf of the Respondents, hence liable to be dismissed.
- C. Incorrect and denied, the appellant has been treated as per law, rules and policy in the instant matter having no question of any sort of discrimination with the appellant by the respondents with regard to the impugned Notification dated 17-03-2014 issued by the Respondent No. 3 in the interest of justice, hence liable to be maintained.
- D. Incorrect and denied, the appellant has been treated as per law, rules and policy in the instant matter having no question of any sort of discrimination with the appellant by the respondents.
- E. Incorrect & denied, the referred provision of Law is not applicable upon the case of the Appellant because he has got retired from service on 29-12-2013 against the Principal post in BS-19 from the E&SED Department prior to the

- issuance of impugned Notification dated 17-03-2014 wherein he has made not entitled for the grant of promotion on notional basis in BS-20.
- F. Incorrect and denied, this Hon'able Tribunal has got no jurisdiction to entertain the instant matter, hence liable to be dismissed.
- G. Legal, the Respondent seek leave of this Hon'able Tribunal to submit Addl: grounds and record at the time of arguments before this Hon'able Bench on the date fixed.

In view of the above made submissions, it is, therefore, most humbly requested that this Honourable Tribunal may very graciously be pleased to dismiss the appeal in hand with cost in favour of the Respondents in the interest of justice.






