#### JUDGMENT

<u>AHMAD HASSAN, MEMBER:-</u> Arguments of the learned counsel for the parties heard and record perused.

### **ARGUMENTS:**

02. Learned counsel for the appellant argued that Mr. Gul Jehan was working as Chowkidar in the office of respondent no.1 since 02.03.2012. On the request of the said official, the Principal vide order dated 03.12.2013 converted the post of Chowkidar to Tubewell Operator. As this order was passed without lawful authority, therefore, the matter was brought to the notice of respondent no.2 vide letter dated 12.05.2014. On the other hand, the appellant was appointed as Tubewell Operator vide order dated 27.06.2014. After appointment of the appellant Mr. Gul Jehan filed writ petition no. 2235/2014 in Peshawar High Court, Peshawar on 10.07.2014 and vide order dated 15.07.2014, the court directed to maintain statusquo. Resultantly, vide impugned order dated 20.03.2015 services of the appellant were terminated without observance of codal formalities. Furthermore, he was asked to refund salary of nine months received by him through office order dated 11.04.2015. He filed departmental appeal on 26.03.2015, which was dismissed on 16.04.2015, hence, the present service appeal. Impugned order was passed without holding regular enquiry and opportunity of defense to the appellant. In these circumstances he was condemned unheard.

03. Learned Asst: AG argued that argued that appointment of the appellant was not made by the Principal who was the competent authority in this case. His appointment was made by the DDO, who had not been delegated powers to decide such cases. He also conceded that the Principal was not authorized to re-designated any post without prior approval of the Finance Department. As the appellant was in probation period so there was no need of holding any enquiry, therefore, respondent no.1 rightly terminated his services vide impugned order dated 20.03.2015.

### CONCLUSION:

04. The record placed before us revealed that Mr. Gul Jehan was working as Chowkidar in the office of respondent no.1 since 02.03.2012. On his written request the Principal converted the post of Chowkidar to Tubewell Operator through order dated 03.12.2013. Under the rules it was not the prerogative of the Principal to pass such an order, as it fell in the domain of the Finance Department, and rightly pointed out in letter dated 12.05.2014.

On the other hand the appellant was appointed as Tubewell Operator vide 05. order dated 27.06.2014. After his appointment Mr. Gul Jehan filed writ petition no. 2235/2014 in Peshawar High Court, Peshawar on 10.07.2014 and through order dated 15.07.2014, the court directed to maintain status-quo. It is further clarified that the appellant was not arrayed as a necessary party in the writ petition referred to above nor his appointment order was assailed by the petitioner. Moreover, Peshawar high Court, Peshawar did not suspend the order assailed by the petitioner thus it was crystal clear that the order of status-quo had no adverse implications on the fate of the appellant. Now coming to the impugned order dated 20.03.2015, the same was passed on the strength of order dated 15.07.2014 handed down by the Peshawar High Court in writ petition referred to above. This order was based on wrong interpretation and spirit of the order of Peshawar High Court referred to above. To cut it short it was an illegal and unlawful order. To set the record straight, it was further added that Mr. Gul Jehan withdrew writ petition vide order of Peshawar High Court dated 24.01.2017. After withdrawal of the said order, the implications of order of status quo earlier granted by the Peshawar High Court disappeared from the scene.

06. It is alleged that the appointment of the appellant was notified in pursuance of approval granted by the DDO whereas appointing authority in the case in hand was respondent no.2. Furthermore, services of the appellant were terminated without affording opportunity of defense/showing cause. After appointment he remained in service for nine months and many vested rights accrued to him. Attention is invited to Clause-5 of the appointment order that in case of disciplinary matters he should be dealt with under E&D Rules 2011. Admittedly, the respondents failed to act according to the prescribed procedure for reasons best know to them. Even services of a probationer cannot be dispensed with without proper opportunity of defense as held by the superior courts in its various judgments. In the present case adverse order was passed against the appellant without following the due process of law thus it was void-abitio, illegal and unlawful. In order to digout the facts leading to his appointment proper enquiry under E&D Rules 2011 is required to be conducted and thereafter appropriate orders could be passed by the respondents.

07. As a sequel to the above, the present appeal is accepted, the impugned order dated 20.03.2015 and 16.04.2015 are set aside and the appellant is reinstated into service. The respondents are directed to conduct proper enquiry under E&D Rules 2011 within a period of ninety days from the date of receipt of this judgment and thereafter pass order as deemed appropriate. The issue of back benefits shall be subject to the outcome of the de-novo enquiry. Parties are left to bear their own costs. File be consigned to the record room.





That prior to the appointment of the appellant the post of tube-well operator was vacant in the college, therefore to meet the day to day requirement of water supply to the college <u>GulJehan (chowkidar)</u> upon his request was transferred from the post of chowkidar/watchman and posted as tube-well operator by the respondent No.1 (principal) vide order dated:03-12-2013. (Copy of order is annexed as B)
- That after clarification by the finance department respondent No.1 (principal), vide letter <u>No.2159 dated:12.05.2014</u>, cancel his earlier order and Mr. Gul Jehan was reverted to his original post as chowkidar/watchman. (Copy of order is annexed as C)
- 4. That after appointment of the appellant Mr. Gul Jehan filed a writ petition No.2235/2014, on <u>10-07-2014</u> for setting aside the order dated:12.05.2014, who neither disclosed the facts that appellant has been appointed on the post of tube-well operator, nor made the appellant as respondent in the said writ petition.
- 5. That above titled writ petition was heard on <u>15-07-2014</u> by the Hon,able Peshawar High Court Peshawar, and was pleased to order for maintaining status-quo till the next date of hearing i.e 5-08-2014 as interim relief. (Copy of Writ Petition and order is annexed as C/& D)
- 6. That on the basis of the aforesaid order of this Hon,able Peshawar High Court Peshawar respondent No.1 (principal) after consultation with directorate terminated the appellant from service and was order to refund the salaries drawn by him from the government treasury within 07 days, vide office order No.101-106 dated:20.03.2015.

(Copy of letter of directorate and termination order is annexed as E & F)

- That aggrieved from the impugned order <u>No.101-106 dated:20.03.2015</u>, the appellant filed a departmental appeal/representation to the respondent No.2 which was not considered and turn down vide impugned order dated:16.04.2015, received by the appellant on 20.04.2015.
   (Copy of appeal and order is annexed as G & H)
- 2) That the appellant now approaches this Hon,able court / tribunal for setting aside impugned orders and re-instatement in service on the following grounds amongst others.

# <u>GROUNDS.</u>

- A. That the both the orders of the respondent No.1 & 2 are against the law, facts and violation of the procedure as provided under the law, hence the same is liable to be struck down.
- B. That the both respondents No.1 & 2 has totally misunderstand and misinterpret the order of Hon,able Peshawar High Court Peshawar court while terminating the service of appellant, furthermore the no final order passed in the said writ petition and the same is still pending adjudication, hence the impugned orders are based on miss application of mind and is not sustainable.
- C. That the appellant has been condemned totally unheard and as such the basic principle of natural justice is violated in the case of the appellant.
- D. That even the order passed by the respondent No.1 (principal)while posting the Mr. Gul Jehan as tube-well operator was void abi-initio and against the rules regulations and as such was rightly cancelled subsequently by the respondent No.1 (principal).
- E. That no show cause notice was served to the appellant nor any inquiry was conducted in accordance with law, rules and procedure, thus the order passed without show cause notice and proper inquiry in the matter is having no sanctity in the eye of law.
- F. That being a regular employee the appellant has served the department honestly and whole heartedly for sufficient time, and perform his duties candidly and unequivocally thus the the appellant cannot be terminated from his service with a stroke of pen as done by the respondent No.1 & 2.

- That the conduct of the respondent No.1 & 2 clearly suggests that
   appellant has highly been discriminated which is not permissible under the constitution of Islamic Republic of Pakistan 1973.
- H. That as per facts and circumstances of the case the principle of locus poenitentiae is also attracted in the case of the appellant.
- A. The contents of the departmental appeal/representation may be considered as integral part of the instant appeal.
- B. That on the permission of this Hon, able court the appellant may urge other additional ground if any, at the time of arguments.

it is therefore most humbly prayed that On acceptance of the appeal the order dated: <u>DATED:16/04/2015</u>, received by the appellant on 20.04.2015 dismissing the departmental appeal of the appellant against the <u>ORDER NO.101-106</u> <u>dated:20.03.2015</u> may graciously be set aside, and the appellant may graciously be reinstate in service with all back benefits etc, and any other orders deem proper may also be passed in the matter.

- IV. That the Honourable Tribunal lacks jurisdiction to entertain the instant appeal.
- V. That the Appellant is estopped by his own conduct to file the instant appeal.

#### **ON FACTS:**

1. Incorrect. The appointment of appellant was not made according to rules but was made by Drawing and Disbursing Officer (DDO) who is not a competent authority. Furthermore it is pertinent to mention that appointment was also held to be invalid by inquiry officer (Annexure-A).

2. Correct to the extent that Mr. Gul Jehan Chowkidar was appointed as tube well operator upon his own request by the Principal. According to rules of business creation, abolition and conversion of post is the sole prerogative of Finance Department and the Principal is not authorized to do, so since no post can be created without the prior approval of Finance Department. Therefore, in the same analogy no post can be converted from one status to another without prior approval of the competent authority, hence this conversion by the Principal is not according to rules. When later on the Principal concerned was informed by the Directorate about this illegality, the Principal in his own writing addressed a letter to inquiry officer explained his position with the request to reverse the concern order (Annexure-B&C).

3. Correct as explained in preceeding para.

4. Para No.4 is not related to respondent department hence no comments.

5. Correct, hence no comments.

6. Correct. It is further mentioned that in compliance to order sheet No.2235/2014 dated 15/07/2014 of Peshawar High Court Peshawar the service of Asad Ullah as tube well operator(probationary) of the College was terminated ab initio as his appointment was made ultra  $v_1^{\circ}$  of the order sheet of Hon'able court and the appellant was further directed to refund all salaries (Annexure-D), refund of salaries and office order of termination(Annexure-E&E supra).

7. Correct. But the same was turned down by the respondent Department as the instant Writ Petition No.2235/2014 Gul Jahan versus Govt of KPK through Principal GDC Badabher, Peshawar being pending adjudication in the Hon'able Peshawar High Court Peshawar and question of legality of the conversion of post is still within the ambit of jurisdiction of the court and further status quo has also been granted in the subject case(Departmental reply attached as Annexure-F).

8. no comments.

#### GROUNDS

- A. Incorrect. Proper procedure was adopted under the relevant rules and laws and the respondent department has performed its function in compliance to the orders of Peshawar High Court Peshawar.
- B. In reply to Para –B it is pertinent to mention that the Hon'able Peshawar High Court has granted status quo in writ petition No.2235/2015 in respect of Mr. Gul Jehan of Govt Degree College Badabher Peshawar and there is no question of misunderstanding and misinterpretation of the court order.
- C. Incorrect. As there is no violation of natural justice on the part of respondent.
- D. Correct. As explained in Para-6.
- E. Incorrect. The Appellant (Probationary) remained absent from duty in the whole month of July, 2014 without fulfilment of legal requirements. (Annex G)
- F. Incorrect. It is further mentioned that the same was done strictly in compliance to High Court order as explained.
- G. Incorrect. No discrimination has been done to the appellant.
- H. Incorrect. As explained in Para-6.
- I. No comments.
- J. That the defendants also seek permission to urge other additional ground if any, at the time of arguments.

## PRAYER

It is therefore, humbly prayed that the appeal in hand may graciously be dismissed.

After specific interpretation of the court directives the Frincipal terminated the services of the new selectee and reinstated Gul Jehan Chowkidar to the post of TWO on the advice of the Director Higher Education—Annex-S<sub>1-2</sub>.

Inquik

Since, by the time the court issued status quo order, appointment order of the complainant had already been cancelled and new appointee had taken over charge of the post, therefore, it needs clarification from the Advocate General about the real meaning of the status quo at that point.

10 In his written statement before the enquiry officer, the complainant Gul Jehan has once again accused Prof.Jehandad of favoritism. He also stated that the appointment order of the new selectee by Prof.Jehandad was issued in back date. As proof he pointed certain discrepancy in the issue numbers allotted to his cancellation order and new appointment order—(Annexure- $Q_{2-6}$ )

As matter of fact, cancellation order of his appointment as TWO was issued vides number **2160-61** on 12/05/2014. However, appointment order of the new selectee against the vacated post was issued at a later date on 27/06/2014 vide issue number **1342-44**. It appears that instead of increasing the issue number has descended during the month. The enquiry officer personally checked the issue register and found that it was a clerical mistake and the official incharge of the issue register has mistakenly issued **1**282 after **2**181 and afterwards all the issue numbers are issued in the same sequence. This is a clerical mistake and not a fraudulent activity on the part of any one. The same fact was clarified before the complainant (Annexure-T<sub>1-2</sub>).

11 Statement of the member of Departmental Selection Committee, Mr.Irfan Ullah, Associate Professor and that of departmental representative Mr.Wajid Ali, Assistant Professor testifies that the interview was held on 19/05/2014 (Annexure— $U_{1,3}$ ). Similarly medical checkup of the new incumbent Assad Ullah was carried out on 28/06/2014 (Annexure—V). All these documents show that the appointment procedure was conducted on the dates shown on record and the appointment order was not issued in back date as claimed by the complainant.

12 During the investigation it was also revealed that the complainant, Gul Jehan is not an efficient and obedient employee. He was appointed under political pressure. After appointment he did not take interest in the official duties. He used to send his brother to perform his duties as Chowkidar. As per statement of the Ex-Principal Jehandad even his brother was found absent from his duties. When the fact was brought into the knowledge of the Ex-Principal, he changed his duty from the night shift to the day shift but the complainant did not accept the change. Resultantly, the Principal marked him absent in the attendance register. However, after some time Gul Jehan came to the Assistant office along with an outsider, snatched the attendance register from the Assistant and turned his absentees into presence. It was also revealed that for a long time he unlawfully kept his service book in his custody and did not return it to the office despite several reminders (Annexure-W<sub>1-18</sub>)

#### Conclusion

9

I. The appointment order of Gul Jehan Chowkidar against the vacant post of Tube well operator issued by Prof.Jehanzeb was not according to rules. The appointment was made on the desire and aspiration of only one candidate. The post was required to be filled in through departmental selection committee by following the proper procedure and by giving opportunity of competition to all the desirous candidates, whether in-service or otherwise.

ii The findings reveal that while appointing Assad Ullah on the post of Tube well operator most of the codal formalities have been observed by Prof.Jehandad. The appointment was made through departmental selection committee. However, not all the candidates on the list of the employment exchange were informed about the date of interview. Nor the complainant was informed about the interview. Hence, the process of selection cannot be termed as

In light of the above, both the appointment orders issued against the same post of Tube well Operator are not according to rules. Therefore, fresh appointment against the same post may be made through departmental selection committee after following the proper procedure.

ili. Gul Jehan Chowkidar, the complainant is a disobedient and inefficient employee. He may be proceeded under the Efficiency and Discipline rules for the reasons depicted under Findings-B Para-12.

iv. Since, by the time the court issued status quo order, appointment order of the complainant had already been cancelled and new appointee had taken over charge of the post, therefore, it needs clarification from the Advocate General about the real meaning of the status quo at that point.



- 4. Para 4 of the preliminary objections is incorrect and against the law and facts, as this Hon, bale court/tribunal having the jurisdiction to entertain the appeal of the appellant.

5. Para 5 of the preliminary objections is also incorrect, against facts and record, the appellant having all the rights to challenge the illegal and biased order of respondent before this Hon,able court/tribunal.

## ON FACTS.

1. Para 1 is incorrect and against the facts, the appellant was appointed by the respondent No.1 after due process and on completion of all codal formalities and recommendation of departmental selection committee was appointed as tube well-operator on the vacant post as reflected in office order No.1342-44, dated:27.06.2014. furthermore the inquiry was conducted much after the termination order of the appellant as the appellant was terminated from his service on 20.03.2015 while the inquiry officer has given his findings on 23.04.2015, hence the same is having no bearing on the case of the appellant, it is further submitted that initially an inquiry was conducted by Professor Nazir of Govt. Post Graduate College Charsadda who submitted the same to Deputy Director Higher Education on 13.02.2015, which was in favor of the appellant but the same has not been brought on record by the respondents with malafide intention, appellant request the requisitioning of the same from the respondents.

- Para 2 of written reply of the respondents is need no reply on behalf of the appellant.
- 3. Para 3 of written reply of the respondents is need not comments being admitted as correct.
- 4. Para 4 of written reply of the respondents is need no comments on behalf of the appellant.

- Para 5 written reply of the respondents is also admitted as correct hence need no comments.
- 6. Para 6 of written reply also incorrect and against the facts, as both respondents No.1 & 2 has totally misunderstand and misinterpret the High Court Peshawar court Hon.able Peshawar order of while terminating the service of appellant, dated:15.07.2014. furthermore the no final order was passed in the said writ petition and the same is still pending adjudication, hence the impugned orders are based on miss application of mind and is not sustainable, moreover the Hon, able Peshawar High Court Peshawar never ordered for termination of services of the appellant.

1. That the petitioner/appellant has filed the above tilted service appeal no.476 of 2015 before this Hon'able tribunal, wherein next date of hearing is fixed for 02.03.2016.

- That the petitioner/appellant having prima facie good case and sanguine about its success, further the balance of convenience also tilt in favor of petitioner.
- 3. That prior to the impugned order respondent No .01 vide order dated 20.03.2015 directed the petitioner to refund all the salaries within seven days and to this effect through a complaint No.7398 dated 04.09.2015 was forward to the Director Anti corruption & anti corruption without due process of law vide latter No3295 dated 03.03.2015 conducted an inquiry and there after recommended departmental action against petitioner/Appellant.

- 4. That the director anti corruption vide letter No 12154 dated 23.11.2015 which was forwarded to respondent No .2 and now they are willing to lodge in F.I.R against the petitioner/Appellant if the petitioner failed to refund the salaries wherein against the termination order dated 20.03.2015 appeal of the petitioner is pending before this Hon,able court, further when the legality of the termination order is already been challenged by the Appellant through appeal any adverse action taken by the respondent is amount to discrimination without law full authority and fall within the domain of contempt of court, Hence justice demand that respondent be restrained from any action against petitioner (copy of latter No 12154 dated 23.11.2015 is annexed)
- 5. That in case if the operation of the impugned order has not been stayed the petitioner will suffer irreparable loss.
- 6. That the facts & grounds mention in the main appeal of the petitioner/appellant may kindly be considered as an integral part of this application.
- 7. That there is no legal bar in suspension of impugned order dated 16-04-2015 along with termination order dated:20-03-2015, till the decision of application of 12(2) C.P.C, rather it would meet the end of justice.

It is therefore prayed that on acceptance of this application the operation of impugned order dated:16.04.2015 may kindly be suspended along with directions to the respondents not to take any adverse actions against the petitioner regarding recovery of salaries in pursuant to the order dated: 20/03/2015, till the final decision of the main appeal of the petitioner.
