

- 3- Annexure-A of the appeal is illegible which may be replaced by legible/better one.



PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 READ  
WITH ALL ENABLING LAWS & RULES AGAINST THE  
IMPUNGED NOTIFICATION NO. SOE/C&WD/8-12/2009  
DATED 26-01-2022 WHEREBY THE SENIORITY OF THE  
APPELLANT HAS BEEN DISTURBED DUE TO THE  
ANNULMENT OF AMENDMENT MADE IN THE C&W  
DEPARTMENT'S NOTIFICATION NO. SOE/C&WD/8-  
12/2009 DATED 25-03-2010 VIDE NOTIFICATION OF  
THE RESPONDENT DEPARTMENT**

**PRAYER**

On acceptance of this appeal, it may graciously be held that on the basis of 5% exclusive quota allocated for Work Superintendents/Work Supervisors/Surveyors possessing Diploma of Associate Engineering (DAE) in Civil Technology for promotion to the post of Sub Engineer, a separate final seniority list of the said category as issued by the Respondent No. 4 on 01-04-2021 vide his office No. 52-E/791/CE/C&WD of even date, is in place prior to Notification of the C&W Department dated 26-01-2022 bearing No. SOE/C&WD/8-12/2022 of even date. The said 5% exclusive quota for category of the appellant based on a reasonable classification has been taken away and merged in 15% quota of the category designed jointly for Works Superintendents, Work Supervisors, Surveyors and Road

Inspectors possessing DAE irrespective of distinction in technology, by the amendment in the C&W Department's Notification No. SOE/C&WD/8-12/2009 dated 25-03-2010; and that on abolition of 5% exclusive quota of appellant's category and its merger in aforementioned 15% quota, if separate seniority list of the category of appellant circulated on 01-04-2021 is abandoned and a joint seniority list of incumbents allotted 15% quota by the Notification dated 26-01-2022 is prepared with determinative factor as the date of appointment for their inter se seniority, it is all likely that the appellant will lose his original seniority position available to him in the seniority list dated 01-04-2021 to his utter prejudice resulting from aforementioned amendment made to take away the lawful exclusive quota of appellant's category, based on a reasonable classification. Therefore, the amendment introduced through the impugned notification meant to take away 5% exclusive quota for category of the appellant and its merger in the 15% quota by substitution irrespective of the kind of technology in DAE is *ultra vires*, unjust, perverse, arbitrary, perfunctory, unfair, contrary to the principles of natural justice, imbued with malice of fact and law, against the principles of reasonable classification, against the fact and law and necessitates annulment to the extent of abolition of 5% quota of appellant's category. Consequently, the 5% quota for Works Superintends, Work Supervisors and Surveyors possessing DAE in Civil technology, being must on the basis of reasonable classification, necessitates restoration and in the furtherance, seniority list dated 01-04-2021 of the incumbents of said category if abandoned due to impugned amendment also necessitates to be brought in place by its revival; and the respondents are bound to do the needful under the facts and law.

Any other relief as deemed fit in favor of the appellant may also be granted to meet with the ends of justice.

**FACTS:**

The appellant seeks to make the following submissions:-

1. That appellant's service as Work Superintendent (BPS-10) comes under control of the respondent No. 1, 4 and presently he is posted as ~~Work Superintendent~~ under the control of respondents.
2. That the terms and conditions of appellant's service emanate from the Khyber Pakhtunkhwa Civil Servants Act, 1973 and rules made thereunder including the Khyber Pakhtunkhwa Government Servants (Appointment, Promotion & Transfer) Rules, 1989. Needless to say that maintenance of seniority list

and fixation of *inter se* Seniority amongst persons holding the same post / rank is the requirement of said law and rules governing the service of appellant.

3. That according to prescribed method of recruitment for the post of Sub Engineer given in appendix of C&W Department's Notification bearing No. SOE/C&WD/8-12/2009 dated 25-03-2010, there is a quota for direct recruitment and promotion from the lower posts carrying different pay scales. The breakup of the quota as provided in the said appendix is copied below:-

- a. 75% by initial recruitment;
- b. 5% by promotion, on the basis of seniority cum fitness, from Work Superintendents/Work Supervisors/Surveyors, with five year service as such, having three years Diploma of Associate Engineering in civil technology, from a recognized board;

*Note-1: For the purpose of promotion, joint seniority list of Work Superintendents/Work Supervisors/Surveyors with reference to their regular appointment to the post shall be maintained and if the dates are similar, the official in BPS-11 shall rank senior.*

- c. 5% by promotion, on the basis of seniority cum fitness, from Road Inspectors, with seven year service as such, having three years Diploma of Associate Engineering in civil technology, from a recognized board;
- d. 5% by promotion, by promotion, on the basis of seniority cum fitness, from Work Superintendents/Work Supervisors/Road Inspector, with seven year service as such, having three years Diploma in Electrical/Mechanical technology, from a recognized board;

*Note-2: For the purpose of promotion, joint seniority list of Work Superintendents/Work Supervisors/Road Inspectors, with reference to their regular appointment to the post shall be maintained and if the dates are similar, the official in BPS-11 shall rank senior.*

- e. 2.5% by transfer from amongst the Draftsman with seven year service as such, having Diploma in Civil/Electrical/Mechanical Technology, from a recognized board;
- f. 2.5% by promotion, on the basis of seniority cum fitness, from Tracer with ten year service as such, having Diploma in Civil/Electrical/Mechanical Technology, from a recognized board; and
- g. 5% by promotion, from amongst the Work Superintendents/Road Inspectors, who have passed "B" Grade departmental examination, with seven year service as such.

*Note-3: For the purpose of promotion, joint seniority list of Work Superintendents/Road Inspectors, with reference to their regular appointment to the post shall be maintained and if the dates are similar, the official in BPS-11 shall rank senior.*

Copy of Notification dated 25.03.2010 is attached as Annexure ..... A.

4. That it is clear from the above break up that 25% for promotion has been further mete out for its allocation to various lower posts with different conditions and different ratio based on a reasonable classification. Accordingly, 5% quota was allocated for the category comprising Work Superintendents, Work Supervisors and Surveyors as a class having the qualification of DAE in Civil Technology. The latest joint final seniority list of the incumbents of said category was circulated by the Respondent No. 4 with his office No. 52-E/791/CE/C&WD dated 01-04-2021 with reference to the service laws and notification of the

department bearing No. SOE/C&WD/8-12/2009 dated 25-03-2010, in which the name of appellant is listed at Sr. 12; while the officials whose name appear at Sr. 1 to 5 and 7 to 9 (08 out of total 14) have been promoted as Sub Engineer by order of the Respondent No. 4 bearing No. 177-E/1098CEC/C&WD dated 30/04/2021.

Copy of Final Seniority List dated 01.04.2021 and promotion order are attached as Annexure ..... B & C.

5. That to the utter surprise of the appellant, the Respondent No. 1 in consultation with the respondent No. 2 and 3 have made amendments in the appendix of the notification 25-03-2010 (Annexure-A) which were notified by the respondent No. 1 vide Notification No. SOE/C&WD/8-12/2022 dated 26-01-2022 whereby the 5% quota allocated for the category of Work Superintendents/Work Supervisors/Surveyors exclusively on account of their having the DAE in Civil Technology has been taken away and merged in 15% quota allocated for a single category comprising Work Superintendents/ Work Supervisors/Surveyors/Road Inspectors irrespective of distinction in technology of DAE.

Copy of Notification dated 26.01.2022 is attached as Annexure ..... D.

6. That on the basis of final seniority list (Annex-B), the Appellant with his name at its Sr. No. 12 is in the range of promotion for the post of Sub Engineer and presently he is holding the said post on own pay and scale (WS). Though not so far circulated for objections but the appellant believe that a tentative seniority list in pursuance to the amendment has been issued surreptitiously the unauthentic copy of which came in hand of the appellant. If it is true copy of the tentative list believably issued by respondent No. 4 as a single tentative seniority list of Work Superintendents, Work Supervisors, Surveyors and Road Inspectors, the name of appellant is list at Sr. 45 of the said tentative seniority list. If future promotion to the post of Sub Engineer takes place on the basis of seniority list prepared on strength of amended notification of 2022 (Annex-D), there remains no chance of promotion of appellant in near future otherwise it was expected on the basis of seniority list dated 01-04-2021. Therefore, the Appellant is reasonably aggrieved from the amendment made in relation to the entries in respect of post of Sub Engineer vide notification dated 28-01-2022 due to its being ultra vires, and in violation of the reasonable classification based on kind of technology in DAE.

Copy of Tentative Seniority List is attached as Annexure ..... E.

7. That the appellant seeks to challenge the vires of the amendment dated 28-01-2022, in alia, on the grounds as follow hereinafter:-

GROUNDS:

- A. That C&W Department in terms of its operations mainly executes civil works in the public sector and accordingly, civil technology is the paramount need of this department. So, provision of exclusive 5% quota for Work Superintendents, Works Supervisors and Surveyors having DAE in Civil Technology vide notification dated 25-03-2010 (Annex-A) was based on reasonable classification and its merger in 15% joint quota by creating a category with addition of Road Inspectors and doing away with distinction of technologies is highly unreasonable, perverse and unjustified under the facts and law. The enormity of the prejudice that is likely to be caused to the appellant and others who are **similarly situated** can be demonstrated by the fact that there was a separate final seniority list of the Work Superintendents, Work Supervisors and Surveyors comprising 14 persons of said group; and as already highlighted in the factual part herein above, 08 out of 14 persons have been promoted on regular basis while appellant and some others out of the remaining 06 persons are also holding the post of ~~Work Superintendent~~. Certainly, elimination of exclusive 5% quota of appellant's class is going to throw them in a joint seniority list with Road Inspectors which in light of the impugned amendment is to be prepared with determinative factor as date of appointment irrespective of the posts in higher pay scale and the posts in lower pay scale. In such a case, majority of the Road Inspectors despite their holding a post of BPS-7 in lower pay scale as against the appellant and other similarly situated persons holding a post in BPS-10, 11 & 12 in a higher pay scale, will become senior to the Appellant because of their date of appointment being earlier than the Appellant and other similarly placed persons. Thus, the impugned amendment lacks the test of rationality and as such the same suffers from the violation of natural justice, prudence, equality i.e. equal are to be treated alike, fairness, and transparency.
- B. That axiomatically, similarly situated refers to one class of persons being alike in all relevant ways to another class for purposes of a particular decision or issue. The impugned amendment very glaringly defeats this principle in case of the Appellant and others equal two folds. Firstly, the impugned amendment, if survives, will result in doing away with the seniority list dated 01-04-2021 and consequently the Appellant and others awaiting promotion on the basis of said seniority list will be rendered with discriminatory treatment when 08 individual from the said list have already been promoted. Secondly, when the appellant and his equals are promoted on the basis of a joint seniority list with the Road Inspectors who presently hold a post with lower scale than the former,



inevitability of the Appellant and his equals becoming junior to Road Inspectors, even after promotion as Sub Engineer, is an open secret.

- C. That the Appellant along with other affectees of the impugned amendment dated 26-01-2022 have also made representation but the same is without success.

Copy of representation is attached as Annexure ..... F.

- D. That act of the respondents by issuing amendment notification dated 26-01-2022 that has disturbed not only the promotion quota of the appellant but also disturbed the seniority meant for which is against Article-38 (e) of the Constitution of Pakistan that states that:

*“to reduce disparity in the income and earnings of the individual including persons in various classes in the service of Pakistan”.*

- E. That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- F. That the respondent while issuing the impugned amended Rules 2022 has acted in a discriminatory in nature as in other department the rule in vogue has been modified.
- G. That act of the respondent while issuing the impugned Amended Rule of 2022 notified vide dated 26-01-2022 is also against Article-37 of the constitution of Pakistan that has defined the eradication of Social Evils in the society and by doing so the respondents has disturbed the promotion quota of the appellant as well as the seniority of the appellant.
- H. That this appeal is meant to challenge the vires of amendment notification continuously affects the rights of the Appellant to seniority against the principles of equality and reasonable classifications. Thus, the appeal is within time and this Honourable Tribunal has got jurisdiction to adjudicate upon the facts in issue and law stated herein above.
- I. That any other ground found necessary will be raised during the course of arguments with permission.

With the foregoing facts and grounds, it is requested that appellant's appeal may graciously be accepted as per prayer in the heading above.
