APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDER OF RESPONDENT NO. 1 DATED 07.03.2016 VIDE WHICH THE DEPARTMENTAL APPEAL OF THE APPELLANT IS DISMISSED ORDER OF RESPONDENT NO. 2 DATED 24.06.2015, WHEREBY. APPELLANT IS APPOINTED AS **REVENUE REVENUE** SIDE MARDAN APPOINTMENT. WHILE APPELLANT IS ENTITLED TO RE-TRANSFER FROM PATWARI HALQA IRRIGATION DEPARTMENT MARDAN TO PATWARI HALQA REVENUE SIDE MARDAN BEING **EMPLOYEE** OF **REVENUE PATWARI** TO HIS PARENT DEPARTMENT ON AVAILABILITY OF VACANT POST AS A PATWARI AND ALTERNATIVE SERVICE OF THE APPELLANT ALREADY RENDERED IN SETTLEMENT OPERATION MARDAN AND IRRIGATION DEPARTMENT MAY PLEASE BE COUNTED FOR PENSIONER BENEFITS AND PAY PROTECTION.

JUDGMENT

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Learned counsel for the appellant present. Mr. Ziaullah, Deputy District Attorney for the respondents also present. Arguments heard and record perused.

Brief facts of the case as per present service appeal are that the appellant 2. passed Patwari examination in the year 1985 and got Patwar passed certificate from Patwar Academy. The appellant was enlisted as patwar candidate in the list of Patwar candidate Mardan. The appellant was appointed as Patwari in a settlement operation Mardan vide appointment order dated 16.12.1985. That due to winding off settlement operation Mardan, the appellant was posted as Patwari Halqa Irrigation Mardan vide order dated 14.12.1996 on deputation, Therefore appellant was relieved from settlement operation Mardan vide order dated 19.01.1997. That now due to availability of post, the appellant was appointed as Revenue Patwari vide order dated 24.06.2015 but with immediate effect. That the appellant filed departmental appeal which was dismissed vide order dated 07.03.2016 copy of the same was received on 14.04.2016 hence, the present service appeal. The prayer of the appellant is that the impugned appointment order dated 24.06.2015 be modified as transfer order from Patwari Irrigation Department to Patwari Revenue Mardan or in the alternative services of the appellant already rendered in the settlement operation Mardan and Irrigation Department may be counted for the pensionary benefits and pay protection on joining the appellant as Patwari Revenue Mardan.

2. Learned counsel for the appellant contended that the appellant has passed Patwar exam in the year 1985. It was further contended that the appellant was enlisted as Patwar candidate and was appointed in a settlement operation Mardan as Patwari vide order dated 16.12.1985. It was further contended that after winding off settlement operation Mardan, the appellant was posted as Patwari Halqa Irrigation Mardan and the appellant served in the Irrigation Department with the satisfaction of his superior. It was further contended that the appellant was appointed as Patwari by the competent authority vide order dated 24.06.2015 on regular basis but with immediate effect. Although the

Department to Revenue Department through impugned order of appointment of the appellant as Patwari therefore the impugned order to extent of immediate effect is illegal and liable to be rectified. It was further contended that in the alternative the service rendered by the appellant in settlement operation and Irrigation Department be counted for pensionary benefits.

- 4. On the other hand, learned Deputy District Attorney for the respondents opposed the contention of learned counsel for the appellant and contended that settlement was project. He further contended that he left project post and joined Irrigation Department and was not serving in Revenue Side. It was further contended that there is no concept in rules to transfer Patwari from other department to Revenue side. It was further contended that the service of the appellant in settlement operation and Irrigation Department was temporary and his appointment order was not passed on recommendation of Departmental Selection Committee therefore, the appellant was rightly appointed vide order dated 24.03.2015 with immediate effect and prayed for dismissal of appeal.
- 5. Record reveals that the settlement operation was Project. The appointment of the appellant in settlement operation was not made on recommendation of Departmental Selection Committee. The appellant was relieved from settlement operation when he joined the Irrigation Department on deputation. The impugned appointment order dated 24.06.2015 passed by the competent authority on the recommendation of Departmental Selection Committee was fresh appointment. Clause-Vii of the impugned appointment order dated 24.06.2015 shows that the appellant despite being overage, was appointed as Patwari revenue on the strength of judgment of Worthy Peshawar High Court as he rendered services in settlement operation.

- 6. Perusal of the record shows that the appellant was not transferred rather freshly appointed vide impugned order on his own request as Patwari candidate, but he did not report is arrival thus not accepted impugned order.
- 7. No case was made out for treating the impugned order as transfer order, similarly no case was made out for the protection of the pay of the appellant and protection of his services rendered in settlement operation Mardan and Irrigation Department.
- 8. As a sequel to the above, the present appeal is dismissed. Parties are left to bear their own costs. File be consigned to the record room.



Appeal U/S-4 of KPK, Service Tribunal Act 1974, against the order of respondent No.1 dated 07/03/2016 vide which the departmental appeal of the appellant is dismissed and order of respondent No.2 dated 24/06/2015, whereby, appellant is appointed as a Rev: Patwari in Rev: side Mardan as afresh appointment, while appellant is entitled to re-transfer from patwari Halqa Irrigation department Mardan to patwari Halqa Rev: side Mardan being employee of Rev: patwari to his parent department on availability of vacant post as a patwari and alternative service of the appellant already rendered in settlement operation Mardan and irrigation department may please be counted for pensioner benefit and pay protection.



Respectfully sheweth;

- 1. That appellant is posted as a irrigation patwari in irrigation department Mardan.
- 2. That appellant has passed patwari examination in the year 1985 and got patwar passed certificate from patwar Academy.
- 3. That appellant was enlisted as patwar candidate in the list of patwar candidates Mardan. (Copy of the same is hereby attached as Annex: "A").
- 4. That appellant was appointed as a settlement operation Mardan on 16/12/1985 vide appointment order dated 16/12/1985. (Copy order is attached as Annex: "B").
 - 5. That due to winding off settlement operation Mardan and requisition of irrigation department, appellant was transferred from patwari Halqa Mardan to Patwari Halqa irrigation Mardan vide order dated 14/12/1996 on deputation. (Copy of order is attached as Annex: "C").
 - 6. That appellant was relieved from settlement operation Mardan after completion of all codal formalities vide order dated 19/01/1997. (Copy of order is attached as Annex: "D").
 - 7. That appellant has served in the irrigation department with entire satisfaction of his superior and there is no any complaint has been received against appellant.

- irrigation department to Rev: side Mardan but in vain and finally, appellant approached to the worthy Commissioner Mardan through departmental appeal, who accepted the appeal of appellant with the "that as and when vacancy fall vacant in Rev: side Mardan" he should be adjusted as a Rev: Patwari vide order/judgment of Commissioner Mardan. (Copy of application is attached as Annex: "E").
 - 9. That now due to the availability of post, appellant is appointed as a Rev: Patwari in Rev: side Mardan as afresh patwari, while appellant is entitled for transfer from Patwari Halqa irrigation department to patwari Halqa a Rev: side Mardan vide impugned order dated 24/06/2015, which is illegal, against law and facts. (Copy of order is attached as Anenx" F).
 - 10. That appellant filed an appeal before respondent No.1 which is dismissed vide order/judgment dated 07/03/2016 received on 14/04/2016, which is illegal, against law and facts. (Copy of the departmental appeal and order is attached as Annex: "G").
 - 11. That respondent No.1 has decided the departmental appeal of the appellant on 07/03/2016, and appellant filed application for the receiving attested copy of the said judgment in the office of respondent No.1 but respondent No.1 delivered the said attested judgment to the appellant on 14/04/2016, hence filed the instant appeal before this Hon'able Tribunal, so the appeal of the appellant is within time.

12. That order/ judgment of respondent No.1 dated 07/03/2016 received on 14/04/2016 is illegal, against law and facts and appellant is entitled for transfer from irrigation department to Revenue Department or in alternative appellant is entitled for the benefit of service of appellant already rendered in settlement operation Mardan and irrigation department w.e.f 16/12/1985 till today on the following grounds.

GROUNDS:

- A. Because appellant has passed patwari examination from patwari Academy under control of Rev: hierarchy ie SMBER & DLR KPK Peshawar and issued patwar passed certificate by SMBER & DLR KPK Peshawar and appellant was entitled as patwar candidate in indera-j-Nama Register.
 - B. Because appellant was appointed as a settlement patwari in settlement operation Mardan vide order dated 16/12/1985 and due to winding off settlement operation Mardan, appellant was transferred from settlement operation Mardan to patwari Halqa irrigation department on deputation basis vide order dated 14/12/1996, so now appellant is entitled for transfer from irrigation department to Rev: side Mardan.



- C. Because appellant has served in settlement operation

 Mardan and irrigation department Mardan more than

 29 years and he is receiving monthly salary to time of

 Rs, 27,430/- per month, while on the fresh

 appointment, appellant monthly salary is fixed Rs,

 14,000/- per month along with allowance, which is Rs,

 13,430/- per months is lesser salary from his previous

 salary, therefore appellant has got losses from his fresh

 appointment.
 - D. Because impugned fresh appointment order of appellant dated 24/06/2015 is illegal, against law and facts and liable to modified to the extent of appellant may please be considered as a transferred order of appellant.
 - E. That as per the reported judgment of Federal Service
 Tribunal, PLC 2008 CS-482, judgment of this
 Hon'able Tribunal titled as "Ali zaman Vs Secretary
 Education etc and Momen Khan Vs Secretary
 Education etc" were granted pay protection and
 pensioner benefit to the civil servants for the service
 already rendered in previous department and as per
 reported judgment of Apex Supreme Court of Pakistan,
 (SCMR 1996P-1185) appellant is also entitled for the
 same benefit too.

It is, therefore, most humbly prayed that on acceptance of this appeal, that order of respondent no.1 dated 07/03/2016 may please be set aside and impugned appointment order of appellant dated 24/06/2015 may please be modified to the extent of appellant that appellant may please be transferred from patwari Halqa irrigation department Mardan to patwari Halqa Rev: side Mardan with all back benefits. In alternative, service of the appellant already rendered and settlement operation Mardan and irrigation department may please be counted for pensioner benefit and pay protection may please be granted to the appellant of the said service. Any other relief deemed fit may also be graciously awarded.



It is to the appellant either to accept the terms and conditions of the impugned order or not, which has not been accepted by him as he has not reported his arrival within the stipulated time mentioned in the appointment order.
- D. Incorrect. The office order referred to is in accordance with law and rules and there is no concept of transfer from other department to revenue side.

As there is no concept and rules to transfer Patwaris from another department to revenue, hence the appeal remains weightless, therefore it is requested to be dismissed in limine.

Preliminary Objections:

- 1. That the appeal is hopelessly time-barred.
- 2. That the appellant has not come to this Honourable Tribunal with clean hands.
- 3. That the appellant has got no cause of action and locus standi.
- 4. That the appeal is bad for mis-joinder and non-joinder of necessary parties.
- 5. That the appellant is estopped by his own conduct.
- 6. That the appeal is not maintainable in its present form.
- 7. That the Tribunal has no jurisdiction to entertain the appeal.

Parawise Comments:

Reply on Facts:

- 1. Pertains to record hence no comments may be offered.
- 2. As above.
- 3. Correct.
- 4. Pertains to record, hence no comments may be offered.
- 5. On winding up of the settlement project, its employees are terminable. As far as transfer of the appellant is concerned, he was transferred from settlement project (temporary service) to irrigation department, not from revenue side. So the contention of the appellant is misleading.
- 6. Related to record. However, he was not on the strength of revenue side as he was in project.
- 7. Pertains to his service in irrigation department.
- 8. Incorrect, no such application or appeal has not been filed; nor has any order been passed by the Commissioner Mardan Division Mardan.

- 9. Incorrect. As per rules, Patwaris are always appointed afresh from the Register of Inderaj-E-Nam, maintained for each sub Division. There is no concept of transfer on revenue side from another department; hence, the appellant was issued appointment order as per rules.
- 10. The appeal has been dismissed on merit.
- 11. Incorrect. The appeal was dismissed on merit. The appellant cannot be transferred from irrigation department to Revenue department as per rules. He has been appointed as afresh according to law.

REPLY ON GROUNS:

- A. Pertains to record. However detailed reply has been given in Para No.9.
- B. Incorrect. The appellant has been transferred from settlement operation; not from revenue side. Settlement is just a project. He had left the project and joined the regular service in Irrigation department. Now on revenue side; he can not be transferred, as per rules this office made appointments of Patwaris on revenue side from the Register of Inderaj-E-Nam on Tehsil basis and on their turn i.e. on seniority.
- C. As per rules this office appoints Patwaris from the Patwar Register of Inderaj-E-Nam, hence the appellant, being a candidate, was also offered appointment letter, wherein his appointment was fresh. It was upto the appellant whether to accept the terms and conditions of the impugned order or otherwise, which he could not comply with as he failed in reporting his arrival within the stipulated time mentioned in the appointment order.
- D. Incorrect. The office order referred to is in accordance with law and rules and there is no concept of transfer from other department to revenue side.
- E. Incorrect. Each and every case has its own merit and the appellant is not entitled for any relief.

As there is no concept to transfer Patwaris from another department to revenue side, hence the appeal remains meritless; therefore it is requested to be dismissed with costs
