Appeal u/s 4 of the K.P.K., Service Tribunal Act, 1974 to the effect that appellant is eligible for upgradation/promotion as per rules from BPS-12 to BPS-15 with all consequential in salary benefits.

Prayer in Appeal

On acceptance this Service Appeal the respondents may graciously be directed for placing name of appellant in the relevant seniority list as per rules formulated for upgradation/promotion of the appellant from BPS-12 to BPS-15, in line with the service renders by the appellant as "PST" Teachers with effect from the date taking their charge and the period excluded by respondent No. 5 be declared is illegal against the rules void-ab-initio and the appellant may be considered for BPS-15.

Respectfully Sheweth:

1. That the appellant was appointed as PTC (BPS-7) on 06.06.1988 at GPS Taimer Dairee District Dir Lower. (Copy of Service Book is attached as Annexure-'A').
2. That the appellant is now serving at the post of PST (BPS-12) since 1.10.2007 and also it is to be mentioned

that the appellant was declared as regular after getting professional qualification i.e. PST in 22.11.1992.

3. That respondents framed rules for time scale/upgradation and promotion of the appellant, which was circulated to the concerned District Education Officers at Timergara for doing the needful as per rules. (Copy of the rules/policy dated 13th Nov; 2012 is attached as Annexure-'B').
4. That the respondent No. 5 violated the said rules, prepared and issue alleged seniority list where appellant was not given due seniority as per their entitlement under the relevant law and rules on subject and therefore appellant name was excluded and not consider for promotion to BPS-15. (Copy of alleged seniority list is attached as Annexure-'C').
5. That when appellant inquired about their seniority position he was informed by respondent No. 5 that their service as PST (untrained period) was excluded towards their seniority.
6. That the appellant feeling aggrieved filed a departmental appeal vide dated 11.12.2012 before competent authority which was rejected by the competent authority. (Copy of the departmental appeal

alongwith rejection order is attached as Annexure-
'D','E').

7. That the appellant being aggrieved of the above said factual and legal position now approaches this Honourable Tribunal on the following grounds amongst the others.

Grounds

- a) That the act of respondent department for excluding the untrained period and not counting them in the alleged seniority list is an act, illegal unlawful without authority being jurisdiction being based on the malafide intentions of the respondent liable to be set-aside.
- b) That the appellant was granted all the service benefits since their very induction as PST Teacher including Annual Increments but considering as untrained period out of count so such act is unlawful illegal and the respondents violated the rules while preparing the impugned seniority list for upgradation so the act of the respondent No. 5 is not sustainable in the eyes of law liable to be set-aside.
- c) That the appellant is senior to private respondents in all respect and therefore appellant

S

have been discriminated by the respondent while preparing and issuing impugned seniority list as well as nominating the private respondents them for awarding the Grade-15.

- d) That the appellant having render the prescribe length of service and being senior to respondents are eligible and entitled to be promoted/upgraded and the impugned seniority list and upgradation of the private respondents being junior to the appellant is illegal, unlawful discriminatory, hence the same is untenable under the law.
- e) That the respondent No. 5 is legally bound to issue a fresh seniority list as per the seniority of the appellant and the appellant is eligible on all respect for promotion/upgradation from BPS-12 to BPS-15 as per the relevant rules.
- f) That in case appellant is not promoted/upgraded then appellant would suffer mental agony torture as well as they would sustain irreparable damages as well.
- g) That under the relevant rules no such discriminatory/distinction qua the upgradation / promotion of the appellant is described, so therefore the impugned seniority list is based

erroneous, interpretation and mis-conception also lack of knowledge and poor approach towards law is liable to be corrected by the Honourable Tribunal by issuing appropriate directions to the respondents.

- h) That the service renders by the appellant as PST Teachers for the initial untrained period was subsequently regularize and confirm and therefore that period cannot be excluded for the purpose of placing them in seniority list or for promotion or for any other service benefits.
- i) That the impugned seniority list and nominating the private respondents for awarding of Grade-15 is illegal ultravires, and against the relevant law and rules on the subject discriminatory without lawful authority as well against the principle of natural justice.
- j) That now the matter has been very much clarified by the so many decision of this Honourable Tribunal and other colleagues being on the same footing have already been granted the above said post after counting their seniority from the date of their first appointment.

It is, therefore, humbly prayed that on acceptance of this Service Appeal the impugned seniority list prepared by respondent No. 5 may kindly be declared to be illegal without lawful authority and this Honourable Tribunal appropriate direction may kindly be issued to the respondent to prepare fresh seniority list of incumbents and count the length of their service from the date of appointment and nominate him for the required grade i.e. Grade-15 including all benefits.

Any other remedy to which appellant is found entitled, in the peculiar circumstance of the case may also be granted.




Respectfully Sheweth:

Subject: Departmental appeal against the seniority list of PST Teachers (Male) for BPS-15, issued by the EDO (E&SE) Dir Lower at Timargara, whereby the untrained period of the appellant has not counted in making of the above alleged seniority list resultantly the appellant deprived of his legal and not selected for BPS-15.

Prayer in Appeal:

On acceptance of this departmental appeal, the excluded period by the EDO (E&SE) be declared as illegal, against the policy, void ab-initio and the appellant may please be considered/ selected for the required grade i.e. BPS-15.

Respected Sir,

1. That the appellant is belong to District Dir and has got a long tenure of service extending over years and had never given any chance of complaint of any of his senior, nor to the student community.
2. That the appellant was/ is appointed as PST Teacher as untrained Teacher, on the year 1988.

3. That as per policy of upgradation promulgated by the provincial government whereby the PTC Teachers were upgraded from BPS-7 to BPS-12 on the basis of the length of their services.
4. That the appellant alongwith hundreds of more ... have been totally ignored and have not been given any sort of benefit of upgradation for BPS-15 due to excluding the untrained period of the appellant which is against the justice and not tenable.
5. That the EDO Dir Lower prepared a seniority list for BPS-15 beyond the alleged Notification dated 13.11.2012, so the malafide on the part of department is very much clear which is against the law of land.
6. That during the course of service of the appellant, annual increments were awarded as per notification issued by the concerned authority from time to time, which entitled the appellant to be upgraded ^{to} BPS-15.
7. That the said act of the respondents' Department is not merely illegal as well as norms of justice but is also very against the Constitution of Islamic Republic of Pakistan, 1973 as engraved on the basic rights of Constitution.

8. That the appellant has right to be treated equally with other colleagues but unfortunately the Department closed all the ways of upgradation/ promotion for the appellant is against all the norms of justice.
9. That it would be pertinent to bring into your kind notice that the said benefits/ upgradation has been extended by the higher judiciary after accounting the untrained period, so the act of respondent regarding exclusion of untrained period is not justifiable and against the law.

It is, therefore, most humbly prayed that on acceptance of this departmental appeal, your good office may please be kind enough to set aside and declare unlawful, the alleged seniority list to the extent of discriminatory attitude towards the appellant may please be treated with his other PTC Colleagues and may be upgraded of service as under the law, in the interest of justice.



- 4 Incorrect, respondent No: 5 didn't violate the prescribed policy. The appellant got professional qualification in 1997 and since then appellant was declared regularized trained teacher. The Department has given then his due rights, since the date he got the required professional qualification/training. Hence denied.
- 5 The appellant is included in the seniority list as per Government policy i.e from the date of his professional training.
- 6 Incorrect. The appellant has no reason to feel aggrieved from the seniority list as mentioned. No irregularity has been made by the respondents with respect to seniority list.
- 7 Incorrect, the appellant has no ground to approach this honorable Tribunal.

ON GROUNDS

- A Incorrect, the untrained period of the appellant could not be considered for the seniority under the prescribed rules & policy. Hence denied.
- B Correct up to extent of financial benefits to the appellant but this untrained period toward the seniority is not justified. Hence denied. (Rules & Policy attached).
- C Incorrect. The respondent Department has followed all the codal formalities and no discrimination towards any one was observed.
- D Incorrect. The appellant's untrained period toward the seniority could not be considered, as per rules & policy.
- E Incorrect. The appellant is placed in the right position of the seniority list according to his professional qualification, hence denied.
- F Para-E may be considered as reply to this Para.
- G Incorrect. No discrimination in the up gradation of PST is made and all the eligible trained PST's are upgraded and they are delivering services to the department.
- H Correct up to the extent of the regularization for financial benefits but not for seniority, hence placed in the seniority list according to the due merit position i.e from the date of professional qualification.
- I Para G may be considered as reply to this Para.
