



**APPEAL UNDER SECTION 4 OF THE GOVT. OF KHYBER PAKHTUNKHWA, SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDERS DATED 26.07.2023 and 27.07.2023.**

Respectfully Sheweth;

1. That initially the appellant was appointed as PST (BPS-12) at GGPS Khadang, District Toorghar, where the appellant took charged of her post on 29.01.2013.
2. That later on, on 26.08.2016 the appellant was transferred from GGPS Khadang Toorghar to GGPS Gumbat Shangla and as such the appellant continue her services as PST at Shangla till her promotion to the post of SST. (Copy of the transfer order dated 26.08.2016 is attached as annexure "A").
3. That according to KP Employees of the Elementary and Secondary Education Department (appointment and regularization of services) Act, 2017, on 10.03.2018 services of respondent No.3 were regularized as PST and the date of appointment of respondent No.3 is 19.03.2015. (Copies of regularization Act and regularization order dated 10.03.2018 as annexure "B")
4. That in the year 2019 joint seniority lists of the PSTs (F) were prepared where the appellant was placed at serial No. 65 and the respondent No.3

was placed at serial No. 81 of the seniority list.  
(Copy of seniority list as annexure "C").

5. That in the year 2021 as 4 numbers of posts of SST were laying vacant in district Shangla, so being qualified for the said post on the recommendation of departmental promotion committee the appellant was promoted to the post of SST through order dated 04.01.2021 and as such through order dated 08.02.2021 the appellant was posted/adjusted against the vacant post of SST (Bio/Chem) at GGHS Sanila Shangla. (Copics of recommendation of DPC order dated 04.01.2021 and order dated 08.02.2021 are attached as annexure "D").
6. That feeling aggrieved from the promotion notification dated 04.01.2021 of the appellant the respondent No.3 filed an departmental appeal, where the respondent No.3 challenged the promotion order of the appellant and intersee seniority where without giving proper opportunity of hearing to appellant through impugned order dated 26.07.2023, the respondent No.2 withdraw the promotion order dated 04.01.2021 of the appellant and as such

the respondent No.3 was promoted to the post of SST (Bio/Chem) BPS-16 and through impugned order No. 2679-8/87 dated 27.07.2023 the respondent No.3 was posted at GGHS Sanila, Puran, District Shangla and further through impugned order No. 2668-78 dated 27.07.2023 the appellant was reverted/demoted to her previous post i.e. PST (BPS-12). (Copies of orders dated 26.07.2023, order No. d2679-8/87 dated 27.07.2023 and order No. 2668-78 dated 27.07.2023 are attached as annexure "E")

7. That against the above-mentioned impugned orders the appellant preferred the departmental appeal before the competent authority on 31.07.2023 but the same has not been decided within the statutory period. (Copy of departmental appeal along with application are attached as annexure "F").
8. That the appellant being aggrieved from the actions of respondents having left no other remedy except to file the instant petition inter alia on the following grounds.



**GROUND**

- A. That the actions and inactions of the respondents are ultra vires, illegal, against the rules on the subject because the impugned orders dated 26.07.2023 and 27.07.2023 were passed against the law.
  
- B. That the respondents are not treating the Appellant in accordance with law and rules.
  
- C. That the promotion of the Appellant was made on the recommendation of the departmental selection committee as prescribed by law but without any legal justification the promotion order of the appellant to the post of SST (Bio/Chem) BPS-16 was withdrawn.
  
- D. That the action and inaction of the respondents are clearly in disregard of the fundamental rights of the appellant.
  
- E. That the appellant was promoted to the post of SST (Bio/Chem) BPs-16 according to her qualification and seniority cum fitness but without giving proper opportunity of hearing her promotion order was withdrawn against the law and rules on the subject, hence the

impugned orders of reversion/demotion of the appellant is not tenable in the eye of law.

F. That according to the regularization Act, 2018 the respondent No.3 should have been placed at the bottom of intersee seniority of the cadre of the PSTs, hence further the respondent No.3 was also not qualified/eligible for the post of SST (BPS-16) as she has lack of 5 years length of services which is pre-requisite for the promotion of post of SST (BPS-16) because the appellant was regularized through regularization order dated 10.03.2018, where the proceedings of departmental promotion committee were taken place on 14.09.2020, hence respondent No.3 has lack the 5 years length of service for the post of SST (BPS-16).

G. That, other grounds will be agitated during the course of argument with prior permission.

It is therefore, most humbly prayed that on acceptance of this appeal,


- i. The impugned order No. 8924-25 F.No.332 dated 26.07.2023 may kindly be declared illegal against the law and rules

and as such the same may also be set aside,

- ii. Impugned order No. 2668-78 dated 27.07.2023 regarding the demotion/reversion of the appellant may also be declare illegal, and the same may also be set aside.
- iii. Impugned order No. 2679-87 dated 27.07.2023 may also be declare illegal, and the same may kindly be set aside.
- iv. Directions may kindly be issue to respondent No.2 to restore the promotion order dated 04.01.2021 of the appellant and the appellant may kindly be allow to continue her services against the post of SST(Bio/Chem) BPS-16. Or

Any other order/direction deemed proper and just in the circumstances of the case may also be issued/order/issued.





**WHEREAS** it is expedient to provide for the appointment and regularization of the services of certain employees appointed on adhoc or contract basis or appointed in certain projects in the Elementary and Secondary Education Department in the Province of the Khyber Pakhtunkhwa, in the public interest;

It is hereby enacted as follows:

**1. Short title, application and commencement.**—(1) This Act may be called the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017.

(2) It shall apply to all the employees in the Elementary and Secondary Education Department, as defined in clause (c) of sub-section (1) of section 2 of this Act.

(3) It shall come into force at once and it shall be deemed to have taken effect from the date of the initial appointment of the employees as referred to in clause (c) of sub-clause (1) of section 2 of this Act.

**2. Definitions.**—(1) In this Act, unless the context otherwise requires,-

- (a) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;
- (b) "contract appointment" means appointment of a duly qualified person for a specific period made otherwise than in accordance with the prescribed method of recruitment;
- (c) "employees" mean duly qualified persons.-

(ii) they have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground, before the commencement of this Act [1]

[Provided that expiry of the project as mentioned in sub-clause (i) of clause (f) of sub-section (1) of section 2 of this Act, shall not be deemed a ground for non-appointment of an employee on regular basis under this Act, and]

(iii) the service promotion quota of all service cadres shall not be affected.

(2) The services of the employees shall be deemed to have been regularized only on the publication of their names in the official Gazette.

4. Determination of seniority.---(1) The employees whose service are regularized under this Act or in the process of attaining service at the commencement of this Act, shall rank junior to all other employees belonging to the same Cadre, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the Cadre, irrespective of their actual date of appointment.

(2) The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre:

Provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one

5. Overriding effect.--- Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules to the extent of inconsistency to this Act shall cease to have effect.



Determination of seniority.**---(1) The employees whose service are regularized under this Act or in the process of attaining service at the commencement of this Act, shall rank junior to all other employees belonging to the same Cadre, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the Cadre, irrespective of their actual date of appointment.

(2) The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre:

Provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.

**5. Overriding effect.**--- Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules to the extent of inconsistency to this Act shall cease to have effect.





**NOTIFICATION**

WHEREAS, vide Notification Endst: No. 8899-8905/A-17/DPC-2019/KPK dated 1-1-2021, the Departmental Promotion Committee (DPC) decided to promote PST, SPST, and PSIT to the post of SSTs in BPS-16 on the basis of their respective seniority-cum-fitness in its meetings held on 30-9-2020 under the reserved quota of 20 % including one Mst: Raham Bibi PST at GGPS Gumbat Makhoza District Shangla as SST B/C in B-16 after due process of law and policy. Vide order dated 04-01-2021.

1. AND WHEREAS, aggrieved from the notification of even and dated 1.1.2021 to the extent of promotion of Mst: Raham Bibi, One Mst: Neelam Bibi PST GGPS Jabar of District Shangla has filed an appeal regarding her seniority for promotion as SST B/C in BPS-16 ahead of Mst: Raham Bibi to this Directorate on dated 23.12.2022.

2. AND WHEREAS, this office initiated an inquiry vide Notification No.288-90 dated 21-03-2023 through the DEO (M) Shangla. The inquiry officer submitted the inquiry report vide his office No. 3901 dated: 01-04-2023 and recommended the appellant namely Mst: Neelam Bibi PST with the recommendation of being senior to Mst: Raham Bibi PST.

3. AND WHEREAS, in view of the said inquiry report dated: 01-04-2023, the DEO (F) Shangla has submitted the reply on dated 30.5.2023, along with final seniority list, revised working papers with the request that Mst: Raham Bibi SST (B/C) GGHS Sanila may please be demoted to her previous post of PST, according to the Seniority list and the appellant, Mst: Neelam Bibi may please be promoted to the post of SST B/C for smooth resolution of the said issue and consideration of her right in the best interest of public service.

Now therefore, in view of the above made facts and circumstances of the case alongwith perusal of the inquiry report of DEO(Male)Shangla, request of the DEO(F) Shangla and powers, conferred upon the undersigned being Competent Authority, the promotion order under Endst:No. 8899-8905 dated: 04-1-2021 occurring at Sr.No:1 in item NO:1 in respect of Mst: Raham Bibi is hereby withdrawn under the provision of section-20 of General clauses Act:1897 amended in 1956, with immediate effect & Mst: Neelam Bibi PST GGPS Jabbar is promoted to SST (B/C) in B-16 (Rs.28070-2260-95870) respectively usual allowance as admissible under the rules on regular basis under the existing policy of the provincial Government on the terms & conditions mentioned below, further the services of Mst: Neelam Bibi are hereby placed at the disposal of DEO(F) Shangla for further adjustment in the interest of public service with immediate effect with the following Terms and Conditions.

**Terms and conditions:-**

1. She would be on probation for a period of one year extendable for another one year.
2. She will be governed by such rules and regulations as may be issued from time to time by the Govt.
3. Her services can be terminated at any time, in case their performance is found unsatisfactory during probationary period. In case of misconduct, they shall be proceeded under the rules framed from time to time.
4. Charge report should be submitted to all concerned.
5. Their Inter Se- seniority on lower post will remain intact.
6. No TADA is allowed for joining his duty.
7. She will give an undertaking to be recorded in their service book to the effect that if any over payment is made to him in light of this order will be recovered and if he/she is wrongly promoted she will be reversed/demoted.
8. Before handing over charge once again their document may be checked if they have not the required relevant qualifications as per rules, she may not be handed over charge of the post.
9. Any errors/omission is accepted.

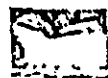


Subject: - DEPARTMENTAL APPEAL REGARDING RE-INSTATEMENT AS SST-2  
R/Sir

I have the honor to submit the following few lines for your kind and benevolent consideration with the hope that these will receive your immediate and positive response.

- 1: - That I belong to District Shangla and was appointed as PST B-12 at GGPS Khadang District Thorghar and took over charge of my post on 29/01/2013 (FN).
- 2: - That I was then transferred to my native District i.e. Shangla vide Director of Education Khyber Pakhtunkhwa E & SE Department and was posted at GGPS Gumbat Makhozae District Shangla.
- 3: - That the DEO (F) District Shangla prepared and circulated seniority list of PST B-12 ,wherein my name was appearing at S.No. 65 (copy of the seniority list attached as annexure A).
- 4: - That four (4) posts of SST-2 were lying in District Shangla and I being qualified having done MSc Bio-Chem. Was promoted to the post of SST-2 vide DEO (F) Shangla Endst. No2380-86 dated 08/02/2021 and posted at GHS Sanila District Shangla.(copy of the promotion order is attached as annexure -B).
- 5: - That I was performing my duties whole heartedly and honestly and up to the entire satisfaction of my superiors, when all of a sudden I was demoted from SST-2 posts to PST B-12 vide DEO(F) Shangla No,2668-78 dated 2q7/07/2023 read with the Director E & SE Khyber Pakhtunkhwa No.8924-25 dated 26/07/2023(copy of the order of the Director E & SE and that of the DEO(F) Shangla are attached as Annexure C& D).
- 6: - That the order both of the Director E & SE Khyber Pakhtunkhwa and that of the DEO (F) shangla are illegal, illogical and based on injustice as I had worked more than 2 years on that post.

- 7: - That the reason stated for my demotion was that I had transferred as PST B-12 from District Thorghar and as such being inter District Transfer I had to be placed at the bottom of the seniority list. In this connection it is clarified that the District seniority list had been prepared by the DEO (F) Shangla and not by me and as such I may not be scapegoated for the mistake committed by them. Moreover 04 posts were lying vacant of the same subject and as such the appellant Miss Neelam Bibi can be promoted from PST B-12 to SST-2 B-16 in some other school.

In addition to above the teacher who was promoted on my place had not completed 07 years service which is essential because as per policy of the government 07 years is must under the rules. This shows that the promotion of Miss Neelam bibi is illegal. Whereas my overall service was 07 years.
