APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED APPELLATE ORDER DATED 11.10.2023 WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT WAS PARTIALLY ALLOWED BY CONVERTING THE MAJOR PENALTY OF REMOVAL FROM SERVICE TO REDUCTION OF INITIAL PAY STAGE FOR A PERIOD CONTENT OF THREE YEARS AND TREATING INTERVENING PERIOD AS LEAVE WITHOUT PAY.

PRAYER:

 - a. Misconduct.
 - b. Inefficiency.
 - c. Corruption.
- Whereas, proper inquiry proceeding was conducted against the accused vide DFO Upper Dir Office Order No. 92 dated 22/06/2020.
- Whereas, the inquiry officer after fulfillment of the codel formalities on the subject, recommended that the charges against the accused official base on fact.
- 4. Whereas, the competent authority (DFO Upper Dir) served show cause notice upon the accused official vide DFO Upper Dir No.6687/Estt, dated 29/05/2023. Subsequently, the accused official responded to the show cause notice on 6/6/2023, which was found unsatisfactory.
