with effect from 26.02.2020 till date i.e. 30.07.2020, hence in this regard charge sheet alongwith summary of allegations were issued to the appellant and Mr. Shah jehan Khan Durrani S.P Elite Force HQrs Peshawar was appointed as Inquiry Officer. The enquiry officer recorded the statement reported that investigation was carried out by Investigation Officer is patent who found him guilty in the murder case after fulfillment of all codal formalities. The Inquiry Officer has recommended that appellant may be awarded major penalty of dismissal from service, hence dismissed from service. (Copy of FIR is Annexure A, copy of Charge Sheet is Annexure B, copy of summery of allegation is Annexure C, copy of Inquiry Report is Annexure D, while dismissal order is Annexure E).

DISCIPLINARY ACTION AGAINST CONSTABLE MANZOOR KHAN

In pursuance of your kind directions, the undersigned completed enquiry in the above cited case. Its stepwise detail is given below:

ALLEGATIONS:

As per letter of Acting SP Elite Force/RRF Mardan Region Mardan vide No.107/EF dated 03.03.2020, Constable Manzoor Khan 4754 is charged in case FIR No.256 dated 14.02.2020, U/S 302/324/353/7ATA/109/34 PPC of Police Station City, district Mardan, and remained absent from lawful duty without prior permission w.e.from 26.02.2020 till date.

In this regard, the Deputy Commandant Elite Force Khyber Pakhtunkhwa Peshawar suspended him and issued Charge Sheet and Summary of Allegations and the undersigned was appointed as enquiry officer.

PROCEEDINGS:

The Charge Sheet and Summary of allegations were served upon the accused constable Manzoor Khan 4754 at the address of Central Jail Mardan through reader SP/HQrs Elite Force Peshawar, in reply to charge sheet and summary of allegations the accused constable submitted his written statement as quoted below:

STATEMENT OF MANZOOR KHAN NO.4754:

Responding to Charge Sheet and Summary of allegations the accused Constable Manzoor Khan 4754 stated in his written statement that he had been sent to the Central Jail Mardan district Mardan on 26.02.2020 in same case. Further he stated that he did not willfully absent himself from lawful duty and charged in aforesaid criminal case falsely. He revealed that actual accused namely Adnan Khan was killed on the spot by police party on 14.02.2020 and he was arrested on 26.02.2020. He requested in his statement that his absence period may be exonerated and enquiry may be kept pending till decision of honorable court. (Statement attached)



STATEMENT OF INSPECTOR HAZRAT ALI (INVESTIGATION OFFICER):

To probe into matter the statement of inspector Hazrat Ali (Investigation officer) of PS City district Mardan was recorded, stating in his statement that footage of instant incident from CCTV cameras and CDR data were collected that had reflected the cogent evidence of allegations against the accused constable Manzoor Khan No.4754. Further he stated that it has been learnt during the course of investigation the accused constable handed over his motorcycle to the actual accused Sayyar Khan and himself seated on the motorcycle behind the accused Sayyar Khan, both went to Kachehri to meet with hired killer who was already present at the Kachehri both the accused spent some time and gave instruction and then left the Kachehri and then went to police station Kalu Khan for duty. According to the statement of IO he recovered motorcycle and cell-phone with sim of accused constable which were used for committing the case. The accused constable himself confessed before police in same case and found guilty. (Statement attached)

FINDINGS/CONCLUSION/RECOMMENDATION:

Keeping in view the above facts and statements the matter was thoroughly enquired that the allegations leveled against the accused Constable Manzoor Khan 4754 that he (constable) along with co-accused namely Sayyar Khan came to Kachehri Mardan on his motorcycle, spent some time and gave some instruction to hired killer whose name is unknown and then left Kachehri. After commission of offence both the accused constable Manzoor Khan No.4754 and Sayyar Khan were charged for the murder of one Adnan Khan in case FIR No.256 dated: 14.02.2020, U/S 302/324/353/7ATA/109/34 PPC of Police Station City, district Mardan and then constable Manzoor Khan No.4754 remained unlawfully absent without the permission of high ups from the duty.

Similarly, the investigation of the subject case was carried out by inspector Hazrat Ali (Investigation officer) of PS city district Mardan who found him guilty in the murder case and took his motorcycle and mobile with sim in possession as case property, the accused constable namely Manzoor Khan No.4754 whose involvement is proved with the assistance of CCTV cameras and Call Data Record (CDR) as the day of occurrence both the accused constable Manzoor Khan No.4754 and Sayyar Khan (relative of accused constable) were found inside the Kachehri as mentioned by the I.O in his investigation as well. Hence, the accused constable Manzoor Khan No.4754 does not deserved any sympathy and mercy, therefore it is recommended that the accused constable Manzoor Khan No.4754 may be awarded major penalty of dismissal from service, if agreed so.

As per information report of Acting SP Elite Force Mardan region vide No. 107/EF, dated 03.03.2020 that he is allegedly involved in case FIR No. 256, dated 14.02.2020 U/S 302/324/353/7ATA/109/34 PPC Police Station City, District Mardan and also remained absent from lawful duty without any leave or prior permission w.e.from 26.02.2020 till to date.

In this regard Charge Sheet alongwith Summary of Allegations were issued to him by this office vide No. 3823-27/EF, dated 05.03.2020 and Mr. Shah Jehan Khan Durran SP Elite Force HQrs: Peshawar was appointed as enquiry officer. The Enquiry Officer recorde the statements and reported that investigation was carried out by Inv: Officer Inspector Hazrat Ali of Police Station City Mardan, who found him guilty in the murder case. The I/O took his motorcycle and mobile with sim in possession as case property and involement of the accused Constable is proved with the help of CCTV cameras and ca data record (CDR) shows that both the accused Constable Manzoor and his relative Sayar Khan were found inside the kachehr on the day of occurrence. Hence, the accuse Constable does not deserved any sympathy and mercy, therefore Enquiry Officer has recommended that he may be awarded major penalty of dismissal from service.

Therefore, I, Zaib Ullah Khan, Deputy Commandant, Elite Force Khyber, Pakhtunkhwa Peshawar as competent authority, keeping in view the above facts, circumstance and recommendations of the enquiry officer, mpose major penalty of dismissal from services upon the defaulter official from the date of absonce i.e 26.02.2020.

REJOINDER ON BEHALF OF APPELLANT _____ SUBJECT:-Respected Sir,

Preliminary Objection:

All Preliminary Objections are misconceived, incorrect. Denied.

On Facts:

Paras 1 to VI.

- Para No.I, is correct, which has not denied by the respondents hence stand admitted on their part.
- Para No.II of the reply is incorrect, wrong, illegal, against the law and facts of the case, hence denied. The Appellant was falsely implicated in a criminal case vide FIR No. 256 dated 14.02.2020 II. U/S 302/324/353 / 7ATA/, he was arrested in the consequence of the said case, later on, the appellant was honourably acquitted by a competent court of law, vide judgment dated 06.01.2022. the appellant was innocent he was never involved in the said case, all the departmental proceeding in respect of the appellant service were conducted in absentia, his dismissal from service is wrong, illegal.
- Para No:III, is incorrect, wrong, illegal, against the law and facts of the case, hence vehemently denied, The Appellant was falsely implicated in a criminal case vide FIR No. 256 dated 14.02.2020 III. U/S 302/ 324/ 353/ 7ATA/, after a regular trial he was honourably acquitted by a competent court of law, vide judgment dated 06.01.2022, before the conclusion of the criminal case, disciplinary proceedings in absence of the appellant were initialed,

which culminated in his dismissal from service. Unilateral inquiry proceedings were conducted in which neither statement of the appellant was recorded nor afforded an opportunity of personal hearing copy of the inquiry report was not provided, thus he was condemned unheard. Opportunity of fair trial was not provided to him.
